## Empowering a generation of innovators

Today, it is important that we think out of the box, approach issues from different angles, and apply a creative mindset when solving problems. But what can we equip ourselves with to address the ambiguities and complexities of today's business world? Enter the Design Thinking workshop – a consultative workshop that draws from the design process to encourage fresh perspectives and creative problem solving. Since embarking on the Design Thinking journey early last year, our SEA Innovation team has brought the experience to over 900 staff across all levels, functions and geographies. In these sessions, teams experience a variety of approaches which aim to focus the business problem on human-centered needs. Tools typically characteristic of Designers like Personas, Journey Maps and Affinity Diagrams, are used to refine and ultimately craft testable prototypes out of initial concepts. The team continues to help teams solve their problems, as well as clients, through a design-led lens, fostering a culture of innovation, experimentation and ideation.

What's more, Deloitte has also included two-hour sessions in Design Thinking for Audit as part of its Core Learning Programme. Through this, Audit Associates and Seniors learn of the firm's activities in innovation whilst exploring design tools which can aid their engagements as well as personal lives.



## Deloitte and you

### Q. What is your current role?

I specialise in the provision of assurance and advisory services to financial institutions.

### Q. What is your background?

I graduated with a Bachelors in Accounting from SMU. During my undergraduate studies, I took different opportunities to explore various career paths relevant to accounting students. I did an audit internship with Deloitte and a Product Control internship with Credit Suisse. Apart from my internship experiences, I spent 6 months in Europe on an overseas exchange program.

### Q. How did you get hired to work in Deloitte?

My first working experience with Deloitte was being a summer intern and I was offered a permanent position upon graduation. Personally, I believe it was my enthusiasm at work and the ability to build a strong rapport with my team which set me apart from the rest.

### Q. Why did you choose Deloitte?

I felt drawn towards the nurturing culture prevalent within Deloitte, whereby the firm places a strong emphasis on developing the skills and talents of their employees. In addition to readily available training resources and opportunities, the senior associates and managers were always more than willing to offer mentorship as well as professional and personal advice.

### Q. How do you think Deloitte is different from the other Big Four?

I think all Big Four accounting firms are largely similar. The main difference is the cultural aspects: Deloitte focusses on team work and a flat hierarchy structure. At Deloitte, we are encouraged to step up and express our constructive feedbacks and opinions freely to our peers and managers.



### Your advice to undergraduates

#### Q. What advice would you offer to undergraduates in terms of career choices?

The best start you can give yourself is to choose a firm which facilitates the most learning and provides strong development of your foundation. My advice to undergraduates who want to pursue a career in audit is to have a good working attitude and always be mindful of all the readily available opportunities within the firm and work towards them.

#### Q. What is the best part of your job?

The best part about working in Deloitte is the people I get to interact and be team members with on a daily basis. The challenges set by my team and peers are constantly adjusted, every engagement brings a new challenge for me. The responsibility given in most of my engagements enables me to propel further in my career, which provides me with an immense sense of satisfaction.

#### Q. What is the best thing about working in FSI?

We look at risks for the various financial services companies, submerge ourselves and try to understand critical elements of the business that we audit. One of our end goals is to ensure that identified areas are meeting the regulatory requirements and risk appetite of the client firm. This provides us with a bird's eye view of the various businesses our clients undertake and their business processes.

#### Q. What should one be prepared for when entering FSI?

In this function, long working hours are not unusual during the peak period and being able to plan your priorities in your daily work is essential. In order to have a balanced and positive attitude, it is crucial to set aside time to be healthy and for things that we deem important in life. Apart from the long hours, the upside is you will always be learning something new during an engagement as you will be constantly looking for solutions or more literature to further understand the situation.



### Deloitte and you

#### Q. What is your happiest moment at work?

What I like most about working in Deloitte is the friendship and camaraderie forged with my colleagues and batch mates. We support each other throughout the year, and we have been on a few overseas vacations to near destinations!

#### Q. Do you have any career milestone in Deloitte so far?

I have been the Senior-in-charge of various large engagements and have received several Audit Applause Awards from my manager and partner in recognition of my hard work and contributions. The Audit Applause Awards recognises those who take on additional responsibilities at crunch times, the commitment they display, the high quality of work they deliver, coaching team members effectively to overcome difficulties and many other instances of going above and beyond.

#### Q. What are some of the opportunities that Deloitte provides?

Deloitte provides team bonding social activities where you get to know your team better. In FSI, we have frequent mentor gatherings and department events like movie nights and go-kart sessions, amongst many others. I have also been given various traveling opportunities in Southeast Asia and been involved in on-site audit engagements, which provides another perspective professionally as it brings about a new experience.

Overseas mobility is also possible after some years as part of the Southeast Asia Mobility / Global Mobility Program, for you to gain international exposure and help you progress your career.

# TIPS

## SUCCESSFUL NETWORKING



Networking is an investment in your future. It may sometimes seem as daunting or a waste of time, however, starting early and building relationships now can help your career in the long run.

# Here are 8 tips for successful networking:



## 1. TAKE ADVANTAGE OF OPPORTUNITIES THAT ARE EXCLUSIVE TO STUDENTS

There are numerous ways in which you could network in school. Firstly, get to know your college professors and administrators – they might be able to provide you with valuable advice and contacts in future. Secondly, internships are a great way for you to understand how the industry works and immerse yourself in the working world. Lastly, being involved in a student organisation of your choice provides further networking opportunities out of the classroom.



Having such experiences provides substance in your CV to impress your hiring manager!



## 2. WHO AM I?

Before attending any sessions, be clear on what you can bring to the table – know your talents, strengths and skill sets. Develop a short pitch, ten to twenty seconds, essentially marketing yourself. Be as candid as you like, this is intended to capture the attention of your audience and to hopefully continue the conversation.



## 3. STAY CALM AND SMILE

Relax and be yourself. Take this event as a chance to make new friends. Make the first move and go up to someone and introduce yourself. Chances are, others will be feeling as jittery as you are, so a smile and an introduction would be more than welcome.



## 4. HAVE A PLAN

Ask yourself, "What would I like to get out of this networking session?" Come up with a list of things that you would like to know more about and would like to talk about. This could include the ways in which you could be an asset to the companies, either now or in the future. However, keep in mind that networking is not supposed to be aggressive – be careful not to bombard others with questions.

Having a plan is especially important for events like Career Fairs – you only have a short amount of time to get to know more about the companies you are interested in. Don't forget the long queues that might be at the popular booths! Be clear on what you expect out of attending this session. Pre-register if possible and research to find out more about the companies. Bring a few copies of your CV to give out to hiring managers of the companies you are interested in. Be ready for on-the-spot interviews should you happen to impress them.



## 5. ASK QUESTIONS

Have questions ready on hand to ask. Networking sessions provide ample opportunities to learn as much as you can, so grab it! Apart from getting job opportunities and expanding your network, you may also gain insights into the industries that you are interested in. Keep an open mind – treat networking and meetings as a platform to learn and gain knowledge.



## 6. BE A GOOD LISTENER

Be attentive: show your interest and attempt to absorb everything that is being said. Be authentic in building trust and relationships. Take the time to listen, understand and build rapport with each other – remember it is better to make a few good contacts than countless rushed ones.

You could also come away with friends of the same age. Most job openings are better known through word-of-mouth than advertising, hence such relationships may serve you well in the future.



## 7. FOLLOW UP IS KEY

Remember this important step that most people miss – follow through with your actions; make it your priority to do so promptly. Typically, there are two ways to go about doing so, either through a phone call or email. Drop a voice mail or email within 24 hours to thank them for their time. If they are potential recruiters, attach a copy of your resume in your email.



## 8. ENSURE THAT YOUR ONLINE PROFILE IS ALWAYS UP-TO-DATE

Profiles on business-oriented websites like LinkedIn serve as an online networking opportunity and should be constantly updated in order to invite future job opportunities. Also, be careful of what you post online – recruiters frequently use social media websites to find out more about potential candidates, their skills, experiences and what they are like as a person. Do not post inappropriate things onto such mediums; once information is up on the internet, it is there for life!

**Start networking before you need it. Start with your current network and look for opportunities to expand through them. By networking early, you can focus on building relationships and a reputation for being generous rather than self-serving. With this we say, happy networking!**

**Q. What can undergraduates expect when working in Audit?**

The audit profession continues to be ever so challenging. Graduates joining us can expect a challenging but rewarding job experience. 

### #1: Wheat Baumkuchen

Just a short 5-minute walk from the office at Asia Square, Wheat Baumkuchen prepares food very quickly meaning that you don't spend half your lunch time queuing for food. I really like this place as the food is tasty, filling and affordable! They even named their food after cold climate animals which I find really cute! Healthy eats like brown rice and soba noodles are their specialities. I highly recommend the polar bear rice (brown rice, sautéed pork, egg and salad etc) and salmon soba noodles. What's more, Wheat Baumkuchen just received recognition as a Healthier Dining Partner with the Health Promotion Board which reaffirms the nutritional benefits of the food that they provide. This also means they will be offered a grant to develop and promote even healthier menu options besides the current ones. More dishes will be launched in the coming months which I'm really looking forward to!

### #2: The B Salad Kitchen

Located at Amoy Street Food centre, I think the B Salad Kitchen is probably the cheapest salad-in-a-bowl that you can find in CBD. It costs \$4.80 for Salad Base + 5 Basic toppings + Dressing. I bet you can't get any salads cheaper than this in the area! Just add 50 cents more and you can get a bowl with Salad Base + 4 Basic toppings + 1 Premium topping + Dressing. You have over 30 toppings and over 10 home-made dressings to choose from. I highly recommend these salad toppings as they are deliciously prepared in-house and you can't find some of them elsewhere: Pumpkin (basic), Baby Asparagus (basic), Sautéed Mushrooms (premium), Smoked Fish Salad (premium), Salmon Mayo (premium) and Smoked Duck (premium). The portions and dressing are really generous – it's such a value-for-money healthy meal!

### #3: Grain Traders

From the team behind Kilo and Kilo at Pact, Grain Traders is a bistro located just 5 minutes away from the Deloitte office which serves up more than your usual salad. Since opening last September, this casual joint continues to draw huge crowds during lunch hour thanks to its tasteful interior and seriously yummy food. The ambience is great – floor-to-ceiling windows and high ceilings allowing natural light to easily fill the spacious eatery.

Upon entering, the spread of food is displayed prominently in front of the hungry queues. Simply point and pick one grain, two vegs, one protein, one topping and a sauce, all served in a huge bowl. On days when I feel less adventurous, I go for the more tried and tested set combinations (affectionately called ‘Hero Bowls’) carefully selected by Grain Traders themselves. My favourite is the ‘Beebop’ – brown rice, braised pork shoulder, furikake baby corn, mixed beans topped with crispy garlic shallots.

Overall, the food is balanced, satisfying and healthy. While the prices might be slightly pricier than other CBD salad places, this bistro definitely ups the overall game with its atmosphere and wholesome food done right. Highly recommended for a good Friday treat after a gruelling work week!

### #4: Teppei Japanese Restaurant

Don't Singaporeans just love anything that has a queue? The lunch sets may be a little pricey but for those who want a bowl of authentic Japanese chirashi, the price may be worth paying. The Bara Chirashi, priced at \$17.90 (along with a set of miso, tea and buffets of appetizers), is the star dish at this popular lunch-time place. Huge chunks of various raw seafood are marinated in an aromatic soy sauce that still renders the freshness of the sashimi: it's a heavy lunch yet still healthy food. The selection of seafood including salmon, mackerel, tuna and herring all provide an excellent source of protein and Omega-3s. The miso soup is rich in magnesium, calcium, folic acid, iron and various antioxidants. These healthy freshness juicy bites totally perk up my work week.

### #5: Piao Ji Fish Porridge

You can probably see the queue even before you see the stall! This stall sells fish soup and seafood soup. I would recommend the seafood soup which comes with 3-4 large sweet prawns on top of the pomfret slices. The fish slices are really fresh, but the most noteworthy part would be the soup that is very rich, full of flavour and nutritious. It does not have any fishy smell and it's not that oily, which makes it easy on the stomach. Prices range from \$7-10 so it might be slightly more expensive than your average hawker fare but it's definitely worth the wait and also the price! Do remember to take the sauce too, which contains fermented soy and grated ginger that goes very well with the fish slices.
