Introduction

Welcome to the 119th edition of the Deloitte Queensland Index, a review of Queensland listed companies on the Australian Securities Exchange (ASX) that also includes the Deloitte Energy & Resources (E&R) Index.

Key points for May 2014 include:

- The Deloitte Queensland Index, Deloitte E&R Index and the ASX All Ordinaries increased 1.1%, 6.6% and 0.1% respectively during May 2014
- Over the 12 months to 31 May 2014, the Deloitte Queensland Index increased 6.5% and the ASX All Ordinaries increased 11.4%. The Deloitte Queensland E&R Index decreased 21.9% over the same period
- There are currently 169 companies on the Deloitte Queensland Index
- In May 2014, the market capitalisation of 66 companies increased and the market capitalisation of 85 companies decreased. The rest were either new entrants or retained their position for the month.

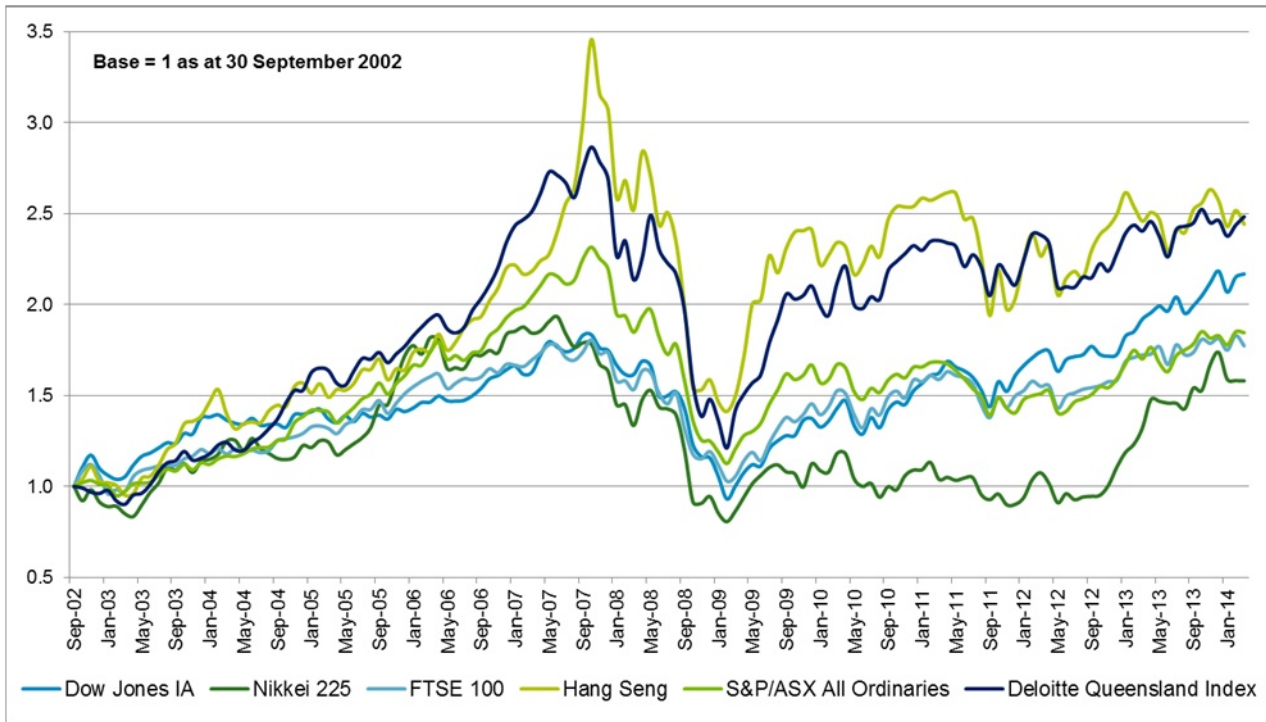

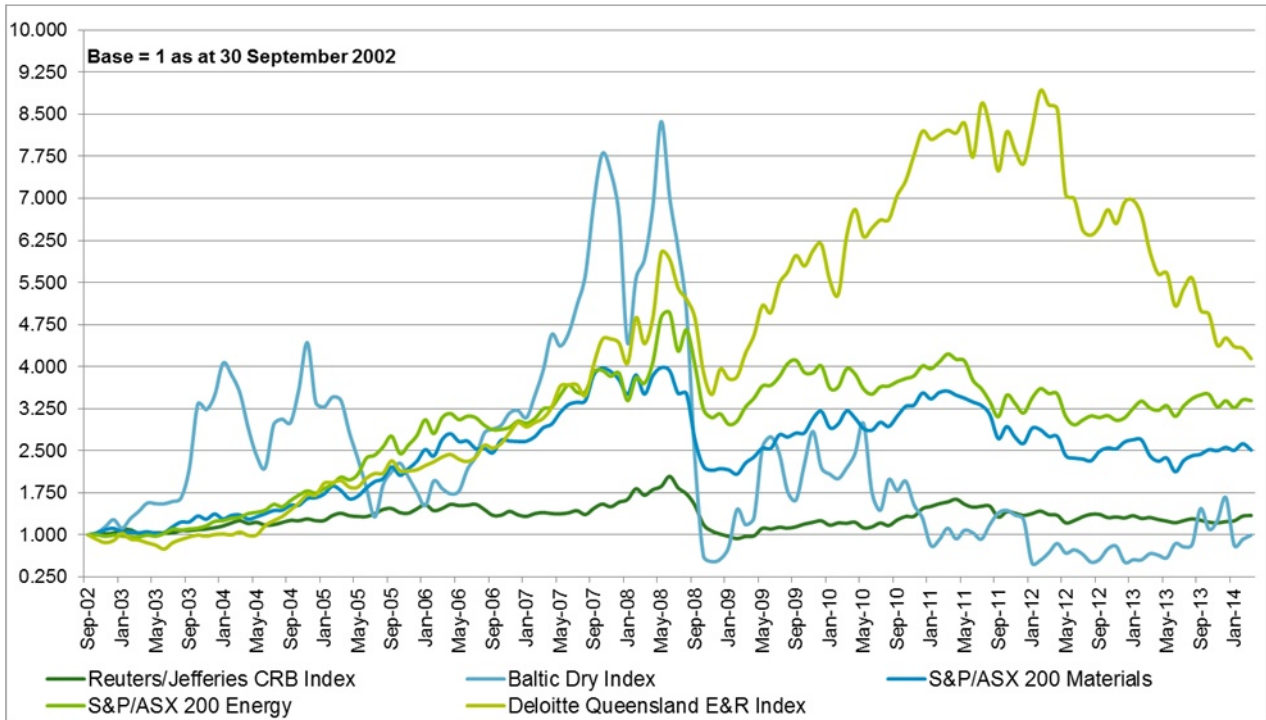

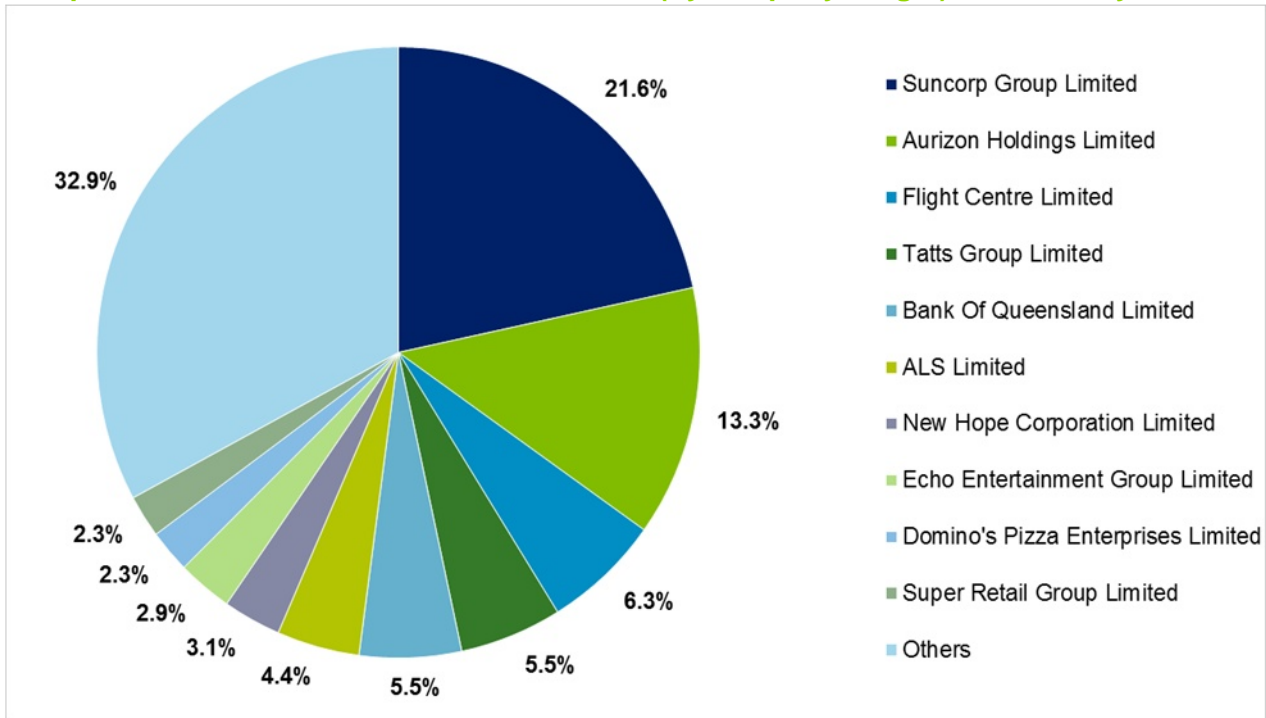
Deloitte Queensland Index versus major global indices



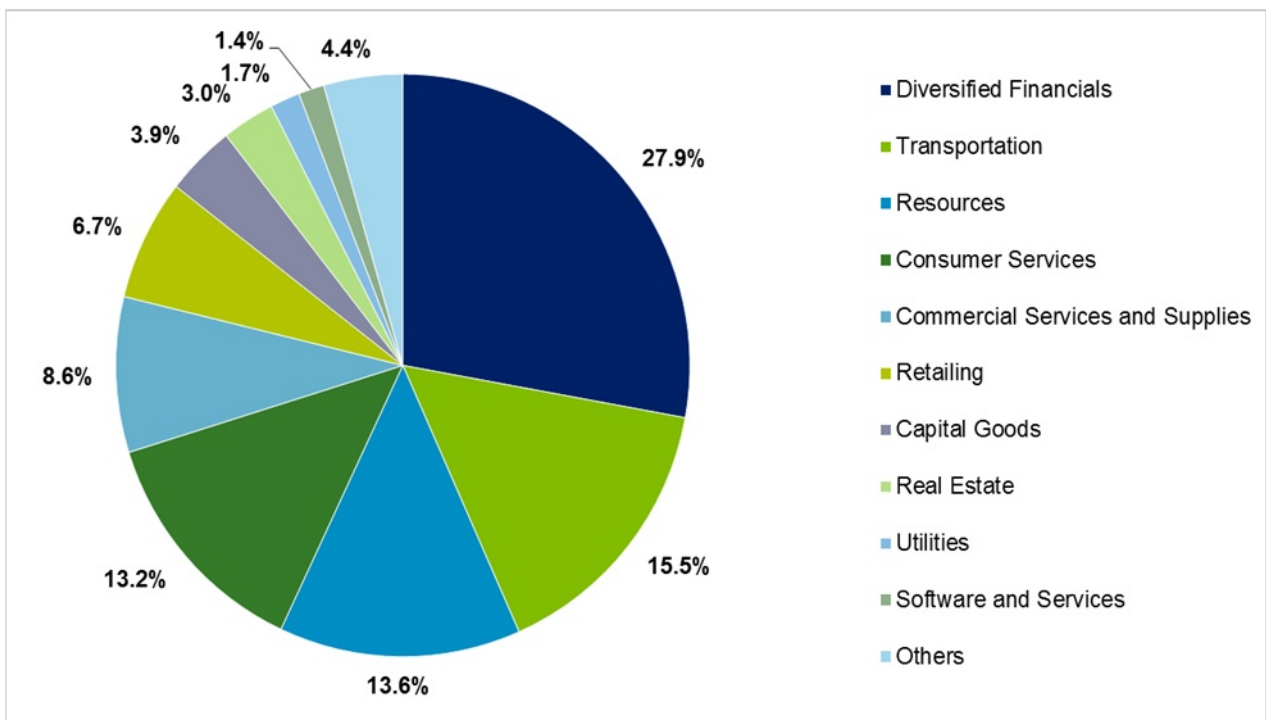
Deloitte Queensland E&R Index versus major E&R indices



Composition of the Deloitte Queensland Index (by company weight) as at 31 May 2014

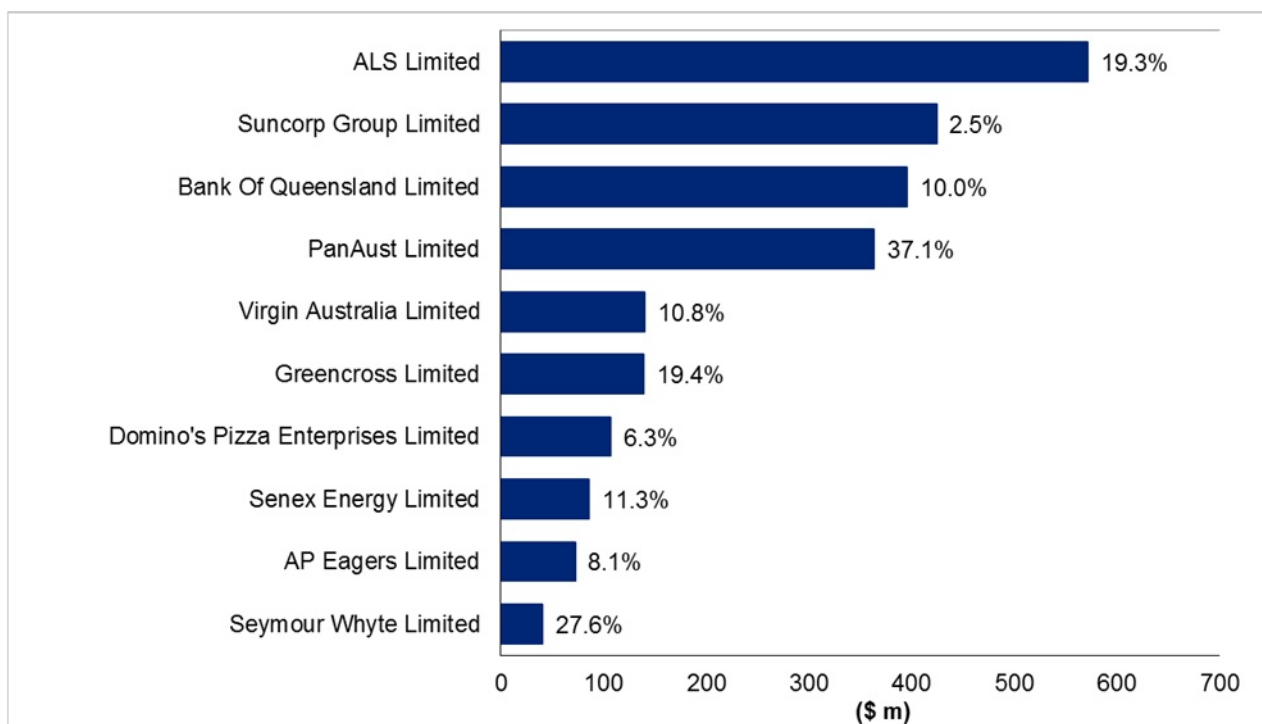


Composition of the Deloitte Queensland Index (by industry weight) as at 31 May 2014

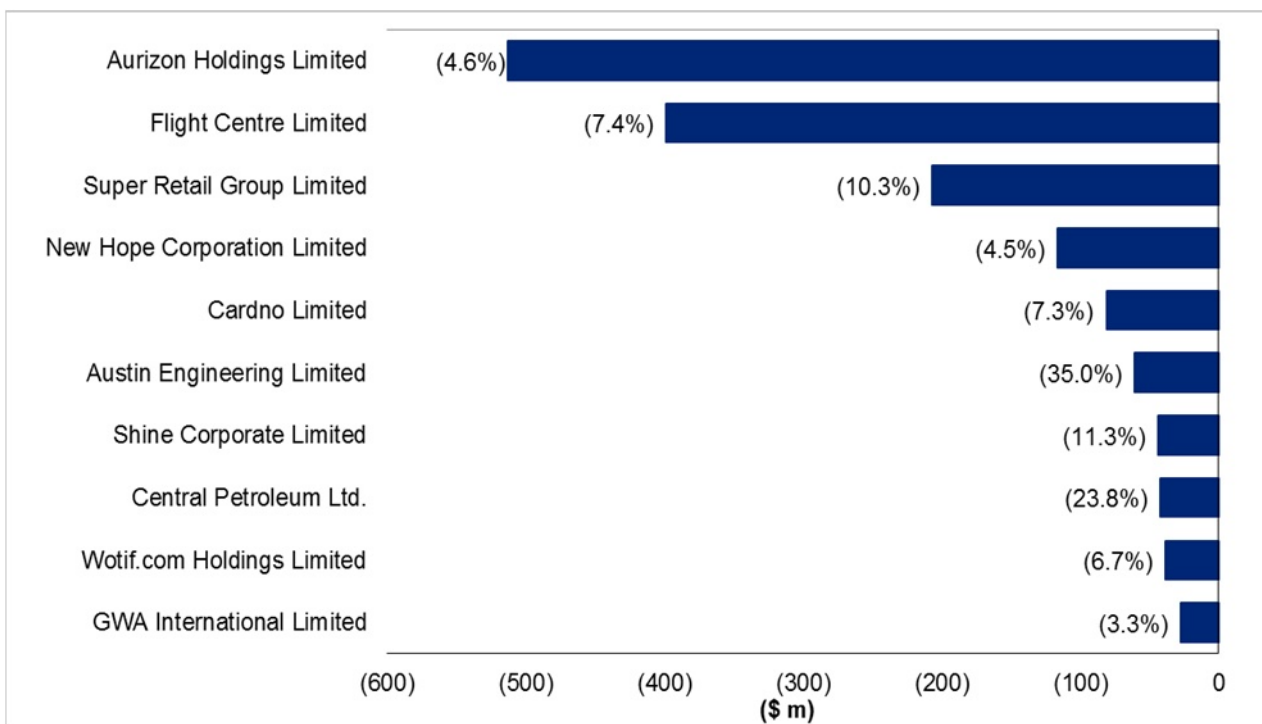


Major company movements (market capitalisation) – May 2014
