A1 Introduction

The challenging economic conditions continue the need for transparency in December 2022 financial reporting

The continuing challenging economic conditions as a result of geopolitical instability, supply chain constraints, labour shortages, inflation, increasing interest rates and energy prices, the Russia-Ukraine war, extreme rain events in Eastern Australia and a newly installed Federal government come as the global community moves toward 'living with' the COVID-19 pandemic.

Fortunately, there are few new and amended financial reporting requirements to be applied in Tier 1 financial statements in the current financial reporting period. This allows entities to fully respond to the current economic and geopolitical situation, focus on their existing financial reporting and **clearly articulate the impacts on the entity's financial performance and financial position**, and also to focus on issues such as sustainability reporting (including climate-related risks) and prepare for the likely forthcoming sustainability disclosure standards.

Some key themes for this financial reporting period include:

- Disclosure of **key judgements and estimation uncertainties** to assist users of the financial statements to understand carrying amounts and how they are calculated, including consistency with historical performance and information outside the financial statements, the use of estimates in areas such as impairment assessments, expected credit loss calculations, unlisted investment valuations, recoverability of inventories and discount rates used in recoverable amount models and the measurement of provisions
- Transparently communicate the **liquidity** of the entity and its impacts on the entity's future prospects, by providing easy to understand analyses of how risk is managed, details of key aspects of arrangements such as the impact of covenants, disclosing clearly understandable maturity analysis of financial liabilities and movement schedules of borrowings and focused disclosure of other key matters such as supplier financing or debtor securitisation, set-off and hedging
- Responding to growing investor and community support for **sustainability reporting**, including **climate-related risks**, particularly in light of the establishment of the International Sustainability Standards Board (ISSB™) and the Federal Government's commitment and funding to develop and introduce climate reporting standards for large businesses and financial institutions, in line with international reporting requirements. Given the ISSB intends to finalise its first standards as early as possible in 2023, this is an area where all entities should be prepared and disclose meaningful information to the market about risks and opportunities arising and any potential impacts on the financial statements
- Disclosure of **material business risks** affecting an entity's future prospects in financial reports (specifically in the operating financial review (OFR)). The OFR should contain information that investors would reasonably require to make an informed assessment of the entity's operations, financial position and business strategies, and prospects for future financial years, by disclosing material risks that may affect the achievement of these strategies or prospects.

A2.1 Purpose

The Deloitte IFRS model financial statements contained in the main section of this document (i.e. section *Core model financial statements*) illustrate the presentation and disclosure requirements of IFRS® Accounting Standards for the year ended 31 December 2022 by an entity that is not a first-time adopter of IFRS Accounting Standards and are also applicable for the ended 31 December 2022. They comprise consolidated financial statements which illustrate the impact of the application of IFRS Accounting Standards that are mandatorily effective for the annual period beginning on 1 January 2022.

The Deloitte model IFRS financial statements, however, do not illustrate the presentation and disclosure requirements specific to annual reports prepared in Australia. Therefore, Appendix 2 to the model financial statements has been designed by Deloitte Australia to assist users with the preparation of annual reports in Australia in accordance with:

- Provisions of the *Corporations Act 2001*
- Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board
- Other requirements and guidelines current as at the date of issue, including ASX Listing Rules, ASIC Corporations Instruments/Class Orders, Regulatory Guides and Media Releases.

The information in the core model financial statements has been presented for a financial year ending on 31 December 2022, consistent with the date of Deloitte IFRS model financial statements. However, these illustrative disclosures are designed to be used in conjunction with the Australian-specific information in Appendix 2, which has been updated and presented as relevant for the year ended 31 December 2022. Appendix 2 also includes additional considerations for Tier 1 financial reports for the year ended 31 December 2022 for Australian not-for-profit and public sector entities. Entities with differing year ends will need to ensure that they include the relevant dates when preparing their financial reports.

Not-for-profit and public sector entities

Illustrative disclosures and guidance specific to not-for-profit and public sector entities have been highlighted in this document by being shaded using teal colouring as illustrated here.

A2.2 Who should use this model annual report?

A2.2.1 Overview

These financial statements are designed for entities required to comply with 'Tier 1' financial reporting requirements, as set out in AASB 1053 *Application of Tiers of Australian Accounting Standards*.

AASB 1053 outlines the categories of entities that are required to comply with Tier 1 requirements (AASB 1053:11-12):

- For-profit private sector entities that have public accountability and are required by legislation to prepare financial statements that comply with either Australian Accounting Standards or accounting standards
- Australian Government, State, Territory and Local governments
- Subject to AASB 1049 *Whole of Government and General Government Sector Financial Reporting*, general government sector financial statements of the Australian Government and State and Territory Governments.

Other entities may be required to comply with Tier 1 reporting requirements under other legislation, regulatory or legal requirements.

Other entities can choose to comply with Tier 1 or Tier 2 reporting requirements.

A2.2.2 Tier 1 and Tier 2 reports

Tier 2 GPFS – Reduced Disclosure Requirements (RDR) have been replaced by 'Australian Accounting Standards – Simplified Disclosures' (Tier 2) with effect from annual reporting periods beginning on or after 1 July 2021.

These International GAAP Holdings Limited model financial statements include disclosures that apply to Tier 1 general purpose financial statements and do **not** illustrate the disclosures applicable to Tier 2 general purpose financial statements.

A2.3 Other considerations

A2.3.1 Amounts

The model financial statements are intended to illustrate the presentation and disclosure requirements of Australian Accounting Standards without the use of any actual numbers. They also contain additional disclosures considered to be best practice, particularly where such disclosures are included in illustrative examples provided within a specific Standard.

A2.3.2 Additional disclosures included

This model annual report includes line items that are not applicable to International GAAP Holdings Limited to illustrate items that are commonly encountered in practice. This does not mean that we have illustrated all possible disclosures, nor should it be taken to mean that entities are required to display such line items in practice.

A2.3.3 Limitations

We have developed the Deloitte model financial reports and the *Australian financial reporting guide* (available at www.deloitte.com/au/models) to assist you to meet the general financial reporting requirements applying to many entities reporting under the Corporations Act. General guidance cannot cover all possibilities, or deal with every possible permutation. We have not dealt with specific industries and types of entities, including:

- Entities that are investment entities under AASB 10 *Consolidated Financial Statements*
- Entities where the parent company or its subsidiaries are entities whose functional currency is the currency of a hyperinflationary economy
- Not-for-profit and public sector entities (other than the information provided in Appendix 2 – Australian-specific disclosures which is highlighted by being shaded using teal colouring)
- Entities subject to the regulatory requirements of Australian Charities and Not-for-profits Commission (ACNC)
- Australian financial services licences (AFSL) holders
- Entities subject to the regulatory requirements of the Australian Prudential Regulation Authority (APRA)
- Stapled entities
- Notified foreign passport funds.

Inquiries regarding specialised industries (e.g. life insurance companies, credit unions etc.) should be directed to an industry specialist in your Deloitte office.

A2.3.4 Pronouncements

Unless otherwise specified, this model annual report only includes references to Standards not yet effective (and not early adopted) in the context of illustrating the disclosures specified by AASB 108 *Accounting Policies, Changes in Accounting Estimates and Errors*.

These disclosures are critical to a reader's understanding of the financial report and are a key focus area for regulators.</p> <p>Disclosure needs to consider both positive and negative developments. The decisions, judgements and uncertainties involved in compiling the financial statements should be clearly disclosed. The overall report should outline the impacts, how risks are managed and overall impact on the entity. The above table is a high-level summary and each entity will be affected differently. Accordingly, financial report preparers should consider their own specific circumstances when preparing their financial reports and ensure they fully consider all the requirements in the sections that follow.

Important note regarding ASIC focus areas

At the time of going to finalising this publication (31 October 2022), ASIC had not released its focus areas for 31 December 2022. We expect that the focus areas will be largely consistent with prior periods, covering recoverability of assets, classification of debt as current or non-current, adequacy of provisions, solvency and going concern assessments, and disclosure of subsequent events.

ASIC's 31 December 2022 focus areas are expected to be announced on the [ASIC website in the near future](#). More information on key matters to consider can be found in our [Clarity publication](#) *Responding to ASIC areas of focus - Financial reporting in times of risk and uncertainty*. We will provide updates in future editions.

B1.2 Ongoing financial reporting considerations in times of uncertainty

B1.2.1 Effective communication in financial reporting through transparency

Although the worst of the COVID-19 pandemic is behind us, Australia and the rest of the world face challenging economic conditions as a result of geopolitical instability, supply chain constraints, labour shortages, inflation, increasing interest rates and energy prices, the Russia/Ukraine war, the floods and extreme rain events in the Eastern Australia, a newly installed Federal government and adjusting to the post-COVID-19 environment. These challenges result in similar impacts and issues for consideration to those of previous periods when preparing financial reports for 31 December 2022.

An important response to these challenges is to enhance the transparency of the financial report so that readers understand the impacts on the entity and the decisions, judgements and uncertainties involved in compiling the financial report.

One of ASIC's key focus areas for both June 2022 and December 2021 financial reporting was disclosure. Entities can expect regulatory scrutiny to continue to be rigorous. Early planning and timely preparation of position papers will enable management and directors to make informed decisions on key estimates and judgments and will support the quality of the financial information provided to the market.

Some areas where these types of uncertainties, unexpected events and developments impact financial reporting and where transparency is particularly important are outlined below.

Significant judgements and estimates

The current economic and geopolitical situation will continue the variability and uncertainty underlying the preparation of the financial reports, similar to previous experiences during the COVID-19 pandemic. The challenging economic conditions may have more uncertainty than in times prior to these events. As a result, a broader range of disclosures, in both full year and half-year reports may be needed, including consideration of AASB 101 *Presentation of Financial Statements* (paragraphs 122, 125 and 129, among others). These disclosures may include:

- Sources of estimation uncertainty
- Assumptions made
- Sensitivity and scenario analysis.

Key estimates and judgments will differ from entity to entity, but most commonly include impairment of assets (and reversals of impairments), fair values of investment property and investments, expected credit losses of loans and receivables, write-down of inventories to net realisable value, recovery of deferred tax assets, long-term provisions (such as rehabilitation provisions) and the assessment of the entity's ability to continue as a going concern.

Entities should also take care to ensure that assumptions relating to future cash flows are consistent across the different estimates and judgments (e.g. recoverable amount models and support for the recognition of deferred tax assets), and any differences are attributable to different requirements of the relevant Australian Accounting Standard.

The broader financial reporting package should also address how the business was and is expected to be impacted by these events, the impacts of the changing economic circumstances, its ongoing strategies in response and its prospects.

In the current period, the impacts arising from challenging economic conditions may not align with the entity's prior expectations, forecasts and assumptions. The business impacts may include discussion of the underlying drivers of financial performance, strategies and risks, impacts on supply and demand, covenant compliance and lending arrangements and liquidity management (either in the financial statements or the operating and financial review).

Impairment

The impacts of these events may be pervasive to an entity's impairment testing under AASB 136 *Impairment of Assets*. Users will continue looking to the financial statements to understand the impact of these events and associated developments on asset values.

A challenging area of the impairment testing process may be making reasonable and supportable estimates of cash flows. As part of this process, entities must determine how long current economic conditions are expected to last. For instance:

- Should inflation and supply constraints be considered temporary?
- Are employee costs forecast to increase?
- What does forward demand look like?
- Can cost increases be passed onto customers in the short and medium term?
- Is the business model transitioning due to climate impacts and does that need to be reflected over the first five years cashflows?

In contrast to impairment tests prior to the COVID-19 pandemic, which may have been determined using a single estimate of cash flows over the forecast period, entities may need to use a weighted probability approach to cash flows that considers a range of possible scenarios on the speed at which recovery is expected, as well as the level at which business activities will be sustained going forward. This probability weighted approach is also particularly valuable when business models are changing, e.g. as the world transitions to be less reliant on fossil fuels a probability weighted approach or sensitivity analyses can allow businesses to proactively manage and transparently communicate the change.

Terminal value cash flows and long term growth rates may also be different to those adopted prior to these events, particularly in light of rising inflation risks and interest rates and the increasing possibility of a global and local recession. The determination of discount rates used in cash flow models will also require careful analysis to reflect expected interest rates and optimal funding ratios.

Current economic conditions may necessitate the development of alternate scenarios in impairment models to those of prior periods. In some cases, this may lead to improvements in recoverable amounts determined and result in a reversal of impairments recognised in prior periods in respect of assets other than goodwill. Australian Accounting Standards do not permit a 'conservative' approach where prior period impairment are not reversed where circumstances have clearly improved and assets (other than goodwill) have been impaired in prior periods.

Finally, transparent disclosures should be made so that users of the financial report can understand how recoverable amount has been determined. Disclosure may include:

- Key assumptions
- Description of approach to each of the key assumptions, whether they reflect past experience, whether they are consistent with external sources of information, and, if not, how and why they differ from past experience, external sources, and earlier assumptions
- Key changes in underlying performance during the period and how these changes have been reflected in recoverable amount models
- Period of projected cash flows, growth rates in the terminal value and discounts rates
- Sensitivity analysis, where a reasonably possible change in a key assumption could cause impairment
- Scenario analysis, including possible ongoing recovery outcomes.

Expected credit losses

Determining the recoverability of financial assets such as trade and other receivables depends on expected credit losses (ECL). This requires forward looking information involving significant assumptions and judgements. These judgements need to consider the credit quality of the debtor, overall economic conditions and entity-specific factors. ECL models are often complex and must evolve to reflect current conditions at each reporting date. Therefore rolling forward previous assumptions is unlikely to be appropriate in volatile environments, particularly in light of rising interest rates and the possibility of recession.

Inventories

Inventories are recognised at the lower of cost and net realisable value. With supply chain disruptions and rapidly changing cost profiles, the cost of inventories may increase or involve abnormal costs. Other considerations include:

- Increased production and distribution costs may result in a higher cost of inventories and entities may need to consider whether a write down to net realisable value is required, particularly if cost increases cannot be passed onto customers
- The changing overall economic conditions may result in excess stock that may require discounting to sell
- Abnormal wastage caused by any unexpected events that are not normal to the production process should be expensed and not capitalised
- Changes to manufacturing processes to allow for delays in receiving supplies, components or the use of alternative components will need to be reflected in inventory costing calculations
- Supply chain disruption can increase the time taken to produce a finished product and therefore increase the volume of unfinished inventory at the reporting date. This can make the accuracy of systems and controls that ensure raw materials and work in progress (some of which may be physically held by third parties) are properly recognised and measured more critical to the financial report.

A careful assessment of both inventory costing and expected selling prices should be performed to ensure all estimated costs of completion and costs necessary to make the sale have been taken into account and that inventories are not overstated.

Finally, transparent disclosures should be made which may include:

- The impact of implementing an IFRIC agenda decision where it is material, which should be treated and disclosed as a change in accounting policy²
- Key assumptions and uncertainties where there is significant estimation uncertainty in determining the net realisable value of inventory
- Write downs of inventories which should be separately disclosed.

Government support

Where the entity has taken advantage of the various government support packages such as JobMaker or loan guarantees in respect of COVID-19 or flood assistance support for impacted businesses in New South Wales and Queensland it is important the nature and impacts of these schemes are clearly disclosed. Further, the discontinuation of this support could potentially lead to going concern issues or even insolvencies and therefore this information could be critical to users understanding of an entities' financial position.

Readers of the financial statements should be able to understand:

- What support the entity has received
- How the support has been accounted for
- How the support has impacted the financial position, financial performance and cash flows of the entity, including, where appropriate areas such as segment reporting, impairment and operating and financial review
- Expected duration of the support
- The impacts of any voluntary repayments of support received
- The Impacts of discontinuation of support.

Aged care COVID-19 support program

To support aged care providers that have been significantly affected by the economic impacts of COVID-19, the Australian Government has provided a range of financial support including the *COVID-19 Aged Care Support Program* which provides reimbursement for eligible expenditure incurred by approved aged care providers.

For the June 2022 reporting period, there has been delays in the approval of submitted grant claims under the *COVID-19 Aged Care Support Program* which has resulted in entities having lodged claims, but the approval has not been obtained by the end of the reporting period.

Under the *COVID-19 Aged Care Support Program*, there are certain guidelines to be followed, including the eligibility criteria for provider and expenditures as well as the application of a program funding cap (total grant program funding cap and a formula-based cap for each eligible entity). Each eligible entity can apply for a portion of the total grant funding (which is capped) over the specified grant period and in cases where there is insufficient funding, the grant will not be approved.

When accounting for such grants it is important to consider the grant eligibility criteria, the grant approval process and the impact of the capping restrictions on the timing of income recognition and other related amounts. For an entity to recognise a receivable, there should be a right to receive cash where the other party has little, if any, discretion to avoid the transfer of cash. Given that the entity only has the right to claim a portion of the combined pool where it has no visibility to the available fund pool and the grantor has the discretion to decline grant claims on the basis of insufficient funds, the criteria to recognise a receivable may not be met until the approval is obtained.

Provisions and other liabilities

Unrecorded and under-recorded liabilities have been a long term focus of regulators. It is therefore critical that the directors ensure they understand what obligations exist and how they are measured.

Changes in circumstances can create new obligations. For example, increasing cost structures may cause contracts to become onerous (particularly where contract prices cannot be increased to reflect increased costs) and therefore require a provision for 'locked-in' losses to be recognised.

Furthermore, liabilities for long term obligations such as rehabilitation, decommissioning and similar obligations can be significantly impacted by many factors, for example:

- Changes in interest rates can impact discount rates used to measure present value
- Inflation in costs (including employee costs) will impact expected cash outlays
- Impacts of climate change can affect the timing and amount of outlays.

Changes in inflation and the possibility of higher than previously expected salary costs can also impact the measurement of long service provisions and other employee entitlements. Such provisions may not have moved significantly in recent years in a low wage growth environment. Entities should monitor the appropriateness of the discount rate used to measure any pension-related liabilities, particularly since even a seemingly small change in the discount rate can affect an entity's pension liability significantly. As a higher interest rate environment is in place relative to prior periods, this may lead to decreases in pension liabilities and required employer contributions. However, such decreases may be offset by higher employee wages and reductions in plan assets.

Revenue recognition

In recent years, we have seen ASIC make a number of inquiries regarding the identification of performance obligations in licensing arrangements particularly where there may be multiple performance obligations that could impact the timing of revenue recognition.

With adverse changes in prevailing economic conditions, broader considerations in revenue recognition include:

- Previous estimates of the transaction price may need to be reassessed because variable consideration (e.g. sales returns or liquidated damages) should only be included in revenue where it is highly probable it will not result in a significant reversal
- Price inflation may result in the need for renegotiation of long-term supply contracts, which in turn may have potential accounting implications
- Modifications of customer contracts may have a significant impact on the timing and amount of revenue recognised in a period and should be assessed when the modifications are being negotiated

- For disclosure purposes, the disaggregation of revenue into categories that depict how the nature, amount, timing and uncertainty of revenue and cash flows are impacted by economic factors may need to be reassessed given the changes in the economic environment
- The operating and financial review should include discussion of how revenue will be impacted, including the ability or expectation of the entity to pass on increased costs to customers.

Non-IFRS profit measures and material business risks

Information about the impact of current economic circumstances on the entity's results is useful to investors and it is important to disclose the underlying drivers of results in the operating and financial review. However ASIC continues to focus on the disclosure of non-IFRS financial information. Volatility resulting from current economic events including supply chain disruption, labour shortages, commodity prices, rising interest rates, extreme weather events, geopolitical instability and general inflationary pressures could result in an increase in entities seeking to utilise non-IFRS measures in communicating their financial performance and position to stakeholders or to otherwise exclude the impacts of some of these events from the entities reported profit measures.

Typically, non-IFRS measures should not be disclosed in the financial statements, except in presenting segment reporting or earnings per share information. It may be possible to quantify and disclose specific items of income or expense that arose solely due to the impact of once-off 'black swan' events such as the recent flood events in the notes. However, caution should be exercised to ensure that only those items that are solely related to these events are described as such, and that items that are related to the broader current economic environment are not labelled as being attributable thereto.

In documents other than financial statements (e.g. the OFR) non-IFRS measures should not be given undue prominence and be appropriately reconciled to IFRS measures. Further non-IFRS measures should also be consistently determined from period to period and be unbiased, including both positive and negative impacts. [ASIC Regulatory Guide RG 247 Effective disclosure in an operating and financial review](#) sets out ASIC's expectations on how the OFR should be presented and the information it should contain. The disclosures should be:

- Tailored to reflect the individual circumstances of the entity and the business environment in which it operates
- Complementary and consistent with the annual financial report and other information
- Balanced and unambiguous
- Presented in a clear, concise and effective manner.

ASIC has increased its surveillance of these disclosures and is focused on transparent disclosure of material business risks in the OFR. On 15 December 2021, ASIC's [media release](#) urged greater focus on the disclosure of material business risks in the financial reports in order to balance disclosures about the entity's future prospects. The media release stated that the OFR should contain information that investors would reasonably require to make an informed assessment of the entity's operations, financial position and business strategies, and prospects for future financial years, by disclosing material risks that may affect the achievement of these strategies or prospects. ASIC has specifically called out that forward-looking information provided should have a reasonable basis. ASIC also emphasised in their [media release](#) on the focus areas for June 2022 reporting, that the most significant business risks that could affect the achievement of the disclosed financial performance or outcomes should be provided, including a discussion of environmental, social and governance risks, whilst noting that an exhaustive list of generic risks that might potentially affect a large number of entities would not be helpful³.

Where asset impairment losses were excluded from a non-IFRS profit measure in a prior period, ASIC reminds entities that any subsequent impairment reversal should also be excluded from that measure in the current period.

Specifically for COVID-19, ASIC was concerned that entities may disclose non-IFRS profit measures that purport to show the result had COVID-19 not occurred and has therefore published an [FAQ](#) to provide additional guidance. Similarly this applies to disclosure of non-IFRS profit measures relating to the current challenging economic conditions. For example, similar issues may arise where inflation, increasing interest rates, higher energy prices, increased supply chain costs, impacts of the Russia/Ukraine war or the effects of extreme weather events produce unexpected changes in financial performance.

Going concern

Consistent with the [conclusion reached](#) by the IFRS Interpretations Committee in July 2014, disclosure is required when an entity concludes there is no material uncertainty regarding its ability to continue as a going concern but reaching this conclusion involved significant judgement. This requires disclosure of the significant judgments made and is important to provide users of the financial statements with enough information to understand the pressures on liquidity, viability and solvency.

Further the directors' declaration for an entity reporting under the Corporations Act requires an explicit statement that the entity can pay its debts as and when they fall due. There are also specific provisions prohibiting an entity from trading while insolvent.

The AASB and AUASB issued a [joint publication](#) on the impacts of COVID-19 on going concern and related assessments which includes a section on going concern disclosures in various scenarios. They further issued a [joint FAQ](#) which provides guidance on some of the issues financial report preparers and auditors should consider as a result of the impact of COVID-19. This FAQ includes going concern as one of the key issues to consider.

In the current economic environment, deciding whether the financial statements should be prepared on a going concern basis may continue to involve a greater degree of judgement than usual. It is important to carefully assess whether the current facts and circumstances may challenge the going concern basis of preparation. Recent going concern issues for example in the building and construction industry have highlighted that specific industries are more vulnerable to the challenges posed by current economic conditions than others. To support companies, in January 2021, the IFRS Foundation published educational material [Going concern – a focus on disclosure](#) which brings together the requirements in IFRS Accounting Standards relevant for going concern assessments. The educational material is published to support consistent application of IFRS Accounting Standards and does not change, or add to, existing requirements.

The IFRS Foundation material notes that:

- Management's assessment of going concern is required to cover at least 12 months from the reporting date but that this is a minimum period, not a cap⁴
- That assessment needs to reflect the effect of events occurring after the end of the reporting period up to the date that the financial statements are authorised for issue
- As well as the specific requirements to disclose the basis on which financial statements are prepared and any material uncertainties over going concern, disclosure of significant judgements made as part of a going concern assessment might be required under the general requirements of IAS 1 *Presentation of financial statements*.

In the meantime, as noted in the educational material, it is important to remember what currently applicable IFRS Accounting Standards require in relation to going concern assessments—disclosures about not only material uncertainties but also significant judgements⁵. In considering these requirements in an uncertain environment, entities will need to consider:

- The extent of any operational disruption
- Potential diminished demand for products and services
- Contractual obligations due or anticipated
- Potential liquidity and working capital shortfalls
- Access to existing sources of capital (e.g., available lines of credit).

Potential disclosures where there is significant judgment in determining whether a material uncertainty exists (or not) or where it is determined that a material uncertainty does exist may include:

- Commentary on the events or conditions (e.g. deterioration in the financial results, working capital or cash constraints) that indicate the uncertainties exist at or arose post the balance date and the severity of the entity's current financial position

⁴ Under Australian Auditing Standard [ASA 570 Going Concern](#), the relevant period for assessment of going concern is the period of approximately 12 months from the date of the auditor's current audit report to the expected date of the auditor's report for the next annual reporting date (in the case of an annual financial report), or the corresponding reporting period for the following year (in the case of an interim financial report) (ASA 570.Aus 13.2). ASA 570 also notes that if management's assessment of the entity's ability to continue as a going concern covers less than the relevant period, the auditor is required to request management to extend its assessment period to correspond to the relevant period used by the auditor (ASA 570.Aus 13.1).

- Commentary on management's plans and options (e.g. capital raising, refinancing, or cost reductions etc) to mitigate the financial position and whether they are within management's control or subject to third party actions, the status of the plans and options and their interdependency
- Commentary on the feasibility of the plans or events that need to occur for the outcomes to be positive and why the outcomes are probable
- Based on the above:
 - A summary of the existence of material uncertainty and therefore that the entity may be unable to realise its assets and discharge its liabilities in the normal course of business, or
 - Significant judgements in management's evaluation that no material uncertainty exists e.g. evidence that plans are effective, additional financing, waiver of covenants, loan guarantees, government grants
- Other relevant information (e.g. interface with contingent liabilities such as legal claims).

Subsequent events

A [joint FAQ](#) issued by the AASB and AUASB provides guidance on some of the issues financial report preparers and auditors should consider as a result of the impact of COVID-19. This FAQ includes events after the reporting period as one of the key issues to consider. This guidance continues to be relevant in the current rapidly changing and challenging economic environment, as unexpected events may occur after the reporting date, or events after reporting date may confirm possible scenarios.

Each subsequent event should be assessed in accordance with AASB 110 *Events After the Reporting Period* to determine whether it provides evidence of conditions that existed at the end of the reporting period (and therefore should be adjusted for in the financial statements) or whether it reflects a change in conditions after the reporting date (and therefore disclosure is required).

For example, if a debtor is placed into voluntary administration soon after the reporting date, should this be taken into account in determining the expected credit losses at reporting date? We expect this assessment may involve significant judgement for the 31 December 2022 reporting period, and therefore management should allow sufficient time in its reporting calendar to consider such events.

If non-adjusting events are material, an entity is required to disclose the nature of the event and an estimate of its financial effect. The estimate does not need to be precise. It is preferable to provide a range of estimated effects as an indication of the impact rather than to not provide any quantitative information at all. However, where the quantitative effect cannot be reasonably estimated, a qualitative description should be provided, along with a statement that it is not possible to estimate the effect.

Fair value measurements

The impacts of the current economic environment may require changes in valuation techniques (e.g. market transactions may not be available, particularly in prior periods) and changes in categorisation of fair value measurements in the 'fair value hierarchy' (often to or from 'Level 3'). This may be particularly relevant for direct and indirect investments in properties and infrastructure and other unlisted investments. Third party property valuations for example draw upon historical pricing benchmarks and in the current environment consideration needs to be had to whether those pricing benchmarks are still relevant or require adjustment. In other cases, more recent transactions may now be available, which may be a different position to previous reporting periods.

Considerations which may result in potential changes in valuation include:

- Valuations typically performed on a rolling or cyclical basis may need to be reassessed to ensure fair values are relevant and consider (at least) the factors that ASIC has specifically referred to such as rising interest rates, expected changes in office space requirements of tenants, on-line shopping trends, future economic or industry impacts of tenants, financial condition of tenants and restructured lease agreements
- ASIC has identified companies in the commercial property sector are likely to be specifically impacted by current economic conditions
- Valuations in the commercial property sector draw upon historical pricing benchmarks and in the current environment consideration needs to be had to whether those pricing benchmarks are still relevant or require adjustments. In the absence of such considerations, changes in, or emphasis on alternative valuation techniques may be required
- In arriving at valuations for entities with interests in countries directly impacted by the Russia-Ukraine conflict, consideration should be given to whether the relevant markets can be accessed.

AASB 13 *Fair Value Measurements* requires disclosures about both recurring and non-recurring fair value measurements, particularly those categorised as 'Level 3' in the fair value hierarchy, and may include the following disclosures:

- Valuation techniques used, changes in those techniques and reason for change
- Quantitative information about the significant unobservable inputs used in the fair value measurements
- Narrative description of sensitivity to changes in unobservable inputs
- Sensitivity analysis of unobservable inputs that change fair values significantly.

Liquidity risk management

Liquidity disclosures, including how the entity manages its liquidity risk, are particularly important where uncertainty exists. Entities should consider how the use of working capital enhancement or management techniques is reflected in the entity's disclosure of its liquidity risk management as required by AASB 7 *Financial Instruments: Disclosures*.

In addition, if outflows of cash (or another financial asset) could occur significantly earlier than indicated in its summary quantitative data about its exposure to liquidity risk, entities should state this fact and provide additional disclosure. For example, this may arise where there is uncertainty about continued compliance with covenants under financing arrangements.

Entities should also consider:

- The specific disclosure requirements for transfers of financial assets as required by AASB 7 when financial assets are sold to fund working capital needs
- The accounting policies and judgements applied in determining the balance sheet and cash flow statement presentation of amounts due and paid when supplier finance and reverse factoring arrangements are used.

This could include separate presentation of amounts payable, key terms of arrangements, accounting judgements applied in determining whether to present such amounts as payables or borrowings and how risks and exposures are managed.

Payment of dividends

It is important entities considering paying a dividend ensure all appropriate accounting, legal and tax aspects are considered before declaring a distribution.

For entities incorporated under the *Corporations Act 2001*, the declaration of dividends is subject to the 'net assets test' in s.245T. In order to pay a dividend, an entity must have sufficient net assets to pay the dividend, the declaration of a dividend must be fair and reasonable to the company's shareholders, and the payment of a dividend must not materially prejudice the company's ability to pay its creditors.

The net assets test was introduced a number of years ago and followed the previous 'profits test' that only permitted the payment of dividends from profits. There is a significant amount of case law around the operation of the profits test, but the net assets test has not been scrutinised by the Courts to a comparable degree.

Under Australian tax law, a dividend can only be franked if it is paid out of profits. Accordingly, the profits test remains relevant for these purposes, and some argue the profits test remains relevant in relation to the declaration of dividends under the *Corporations Act*.

In the current economic environment and also the impacts of COVID-19 over the past few years, many entities may have experienced new conditions, and profitability patterns may have altered. Some companies may have incurred their first accounting loss for some time, or may need to fund dividends from different sources within the group than in the past.

Because of the uncertainty around the interpretation of the legal and tax requirements for dividends, particular care is needed where an entity:

- Has negative net assets and/or negative retained earnings (even if the group as a whole does not)
- Wishes to pay a dividend exceeding the available profits and retained earnings of the entity itself (even if the dividend is less than the consolidated position)
- Needs to rely on the payment of dividends from subsidiaries, particularly where a chain of entities exists (as there may be 'dividend traps' whereby an entity in the chain is prohibited from paying a dividend due to its own circumstances)

- Seeks to frank a dividend for taxation purposes when profits are not available, or the dividend is being paid in a different period to when the profits were originally earned.

The payment of a dividend when not permitted can expose the directors to consequences under the *Corporations Act 2001*, and the incorrect franking of a dividend for tax purposes can have significant tax repercussions.

Whilst the accounting is fairly straightforward, it is nevertheless important for directors to carefully consider the legal and tax implications of dividends before they are declared. Entities should obtain appropriate advice where there is uncertainty.

There may also be indirect accounting implications that need to be considered, e.g. if a dividend is being funded by paying dividends up from subsidiaries, this may result in current or deferred income tax impacts that must be recognised.

B1.2.2 Resources available

Outlined below are various resources that may assist entities in understanding and responding to the financial reporting considerations arising from COVID-19 and the current economic environment. A number of the below resources relate specifically to considerations arising from COVID-19. Although the worst of the COVID-19 pandemic is behind us, the considerations are relevant in the current economic environment which has similar financial reporting themes and issues for consideration.

B1.3 Key global developments

B1.3.1 Climate-related and other emerging risks financial disclosures

New International Sustainability Standards Board (ISSB)

In early November 2021, the IFRS Foundation Trustees announced three significant developments to provide global financial markets with high-quality disclosures on climate-related and other sustainability issues:

- The creation of a new International Sustainability Standards Board (ISSB) to develop a comprehensive global baseline of high-quality sustainability disclosure standards to meet investors' information needs. The appointment of Emmanuel Faber as Chair of the ISSB was announced in December 2021 and the appointment of Sue Lloyd as Vice-Chair and Janine Guillot as Special Advisor to the ISSB Chair were announced in late January 2022
- A commitment by leading investor-focused sustainability disclosure organisations to merge into the new board. The IFRSF completed the acquisition of the Climate Disclosure Standards Board (CDSB, an initiative of CDP) in January 2021 and the merger of the Value Reporting Foundation (VRF, which houses the Integrated Reporting Framework and the SASB Standards). The consolidation of the VRF into the IFRS Foundation was completed on 1 August 2022.
- The publication of prototype climate and general disclosure requirements developed by the Technical Readiness Working Group (TRWG), which the IFRS Foundation Trustees formed to undertake preparatory work for the ISSB. This led to the publication of ISSB exposure drafts in March 2022 discussed below.

Together, these developments create the necessary institutional arrangements and lay the technical groundwork for a global sustainability reporting standard-setter for the financial markets. The IFRS Foundation has also made the constitutional changes that have become necessary to bring in the ISSB.

In March 2022 the Chair and Vice-Chair of the ISSB published two exposure drafts based on the work (and prototype documents) of the TRWG:

- **Exposure Draft IFRS S1 General Requirements for Disclosure of Sustainability-related Financial Information** - This [exposure draft](#) proposes requiring the disclosure of information about significant sustainability-related risks and opportunities (including, but not limited to, climate change). The exposure draft includes proposals for definitions and requirements that are consistent with the IASB *Conceptual Framework for Financial Reporting*, IAS 1 *Presentation of Financial Statements* and IAS 8 *Accounting Policies, Changes in Accounting Estimates and Errors* pronouncements for financial reporting. Sustainability-related financial disclosures would be required to be published at the same time as the financial statements
- **Exposure Draft IFRS S2 Climate-related Disclosures** - This [exposure draft](#) addresses climate change in more detail and incorporates the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD) and includes metrics tailored to industry classifications derived from the industry-based Sustainability Accounting Standards Board (SASB).

Comments on the ISSB proposals closed on 29 July 2022.

The objective of the ISSB is to publish the two IFRS Sustainability Disclosure Standards as early as possible in 2023.

Jurisdictional authorities would decide whether to require the application of IFRS Sustainability Disclosure Standards, just as they have decided whether to require the application of IFRS Accounting Standards. The ISSB does not have the right to mandate the application of its Standards. However, companies could choose to apply them.

The AASB issued an equivalent Exposure Draft, [ED 321 Request for Comment on ISSB \[Draft\] IFRS S1 General Requirements for Disclosure of Sustainability-related Financial Information and \[Draft\] IFRS S2 Climate-related Disclosures](#), seeking feedback in the Australian context. ED 321 outlines the AASB's preliminary decision to position Australian sustainability-related reporting requirements as a separate suite of standards, which leaves the decision to mandate sustainability-related financial reporting with the relevant Australian legislators. Comments on the AASB's proposals closed on 15 July 2022.

The International Organization of Securities Commissions (IOSCO) [welcomed](#) the announcement of the formation of the ISSB and the publication of the Climate-related Disclosures Prototype and subsequently [welcomed](#) the strong stakeholder engagement with the ISSB's exposure drafts subsequently issued. IOSCO will review the finalised IFRS Sustainability Disclosure Standards and consider IOSCO endorsement which "will be a crucial step towards increased comparability in sustainability reporting under either voluntary or mandatory reporting regimes".

In December 2021 ASIC [welcomed](#) the establishment of the International Sustainability Standards Board and is supportive of its objectives. ASIC further indicated in the media release that it “encourages listed companies to use the TCFD recommendations as the primary framework for voluntary climate change-related disclosures. Listed companies reporting climate-related information under TCFD are expected to be well placed to transition to any future standard. Listed companies should consider all guidance published by the TCFD including the recent Guidance on Metrics, Targets, and Transition Plans.”. Listed companies are still required to prepare an operating and financial review (OFR) and ASIC [Regulatory Guide 247](#) *Effective disclosure in an operating and financial review* continues to apply.

The requirement for listed entities to prepare an OFR that accompanies and complements the financial report remains unchanged. ASIC [Regulatory Guide 247](#) *Effective disclosure in an operating and financial review* continues to apply.

Australian developments

Council of Financial Regulators

The Council of Financial Regulators (CFR) Working Group on Financial Implications of Climate Change was established in 2017. The working group brings APRA, ASIC, RBA and Treasury together to consider and coordinate actions in relation to understanding and managing climate risks. Under the working group's terms of reference, the group reports to the CFR, as needed, on international developments, emerging regulatory gaps and risks to the financial system in relation to climate change.

As part of its [2022/23 priorities](#), CFR agencies announced they will continue to strengthen the building blocks needed to facilitate high-quality and comparable climate-related disclosures, “in line with the Federal Government's commitment to introduce disclosure requirements aligned with international standards”.

The document notes that CFR agencies will work towards ensuring that standards are developed and adopted in a way that is appropriate for the Australian regulatory and economic context. Where particular ISSB metrics or disclosure requirements pose challenges for Australian entities given issues with capacity, capability and costs of accessing data and modelling expertise, CFR agencies will explore possible solutions along with government and industry.

ASIC

In September 2018, ASIC released a media release, 18-273MR *ASIC reports on climate risk disclosure by Australia's listed companies*. ASIC noted that of the 60 listed companies in its ASX 300 sample, 17% identified climate risk as a material risk to their business. ASIC also noted that while most of the reviewed ASX 100 entities had considered climate risk to the company's business to at least some extent, disclosure practices were considerably fragmented, with information provided to the market in differing forms across a wide range of means of disclosure. In some cases, the review found climate risk disclosures to be far too general, and of limited use to investors. The full text of the media release can be found at www.asic.gov.au.

ASIC also amended [ASIC Regulatory Guide RG 247](#) *Effective disclosure in an operating and financial review* to indicate that climate change is a systemic risk that could have a material impact on the future financial position, performance or prospects of entities. Example of other risks that may be material for particular entities include digital disruption, new technologies, geopolitical risks and cyber security.

In a [Corporate Finance Update](#) issued in March 2021, ASIC outlined that it had undertaken a further surveillance exercise to examine the climate-change-related disclosure and governance practices of a cohort of large listed companies. The exercise, focusing on the TCFD recommendations, resulted in the following primary observations:

- The quantity of climate-related disclosure has increased materially, but quality still varies significantly
- There is limited consistency in the adoption, application and disclosure of specific scenarios and underlying assumptions

- Board oversight of climate risk was evident across all surveillance targets
- 'Greenwashing' was prevalent in some disclosures reviewed.

For listed entities disclosing, or working toward disclosure, under the TCFD recommendations, ASIC considers that:

- Disclosing material assumptions underpinning scenario analysis of physical and transitional risks increases transparency
- Obtaining independent assurance supports the reliability of disclosures
- Updating material climate-related disclosures may be necessary and appropriate when underlying facts change.

As part of its participation in the Council of Financial Regulators Working Group on Financial Implications of Climate Change, ASIC [expects](#) "will continue to support market integrity through proactive supervision and enforcement of governance, transparency and disclosure standards in relation to sustainable finance".

In a [speech](#) given by ASIC Commissioner Sean Hughes at the Governance Institute of Australia Fellows Roundtable, Thursday 14 October 2021, the following four core messages on climate risk from the Corporate Finance Update were explained in further detail:

- **Consider climate risk** – directors and officers of listed companies must understand and continually reassess existing and emerging risks, including both physical and transitional climate risk
- **Develop and maintain strong and effective corporate governance** – boards should be comfortable with the level of oversight they maintain over climate risks and opportunities and the governance structures in place to assess, manage and disclose these risks and opportunities
- **Comply with the law** – compliance with laws relating to the operating and financial review for listed companies and other requirements for prospectuses or continuous disclosure requirements should include material climate-related disclosures and whether those disclosures have been made and updated where necessary and appropriate
- **Disclose useful information to investors** – listed companies with material exposure to climate risk should consider reporting under the TCFD framework, as this provides information that is useful for investors.

In its [focus areas](#) for financial reporting at 30 June 2022, ASIC also noted directors should consider whether to disclose information that would be relevant under the TCFD recommendations in their operating and financial review (OFR) and that climate-change-related risk disclosures in the OFR and in any voluntary disclosures (such as those recommended by the TCFD) should not be inconsistent. ASIC's focus areas for 31 December 2022 (not yet issued at the date of this publication), are expected to further emphasise these themes.

Standard setters

The AASB and AUASB together previously released a bulletin on *Climate-related and other emerging risks disclosures: assessing financial statement materiality using AASB Practice Statement 2 (APS 2)* which guides directors, preparers and auditors when preparing and auditing financial statements for their half and full year ends. In early May 2019, the AASB and AUASB released an updated version of the bulletin (dated April 2019). The full text of the AASB/AUASB bulletin can be found at www.auasb.gov.au.

In November 2021, the FRC, AASB and AUASB (the 'Boards') issued [Position Statement Extended External Reporting and Assurance](#). In the Position Statement, the Boards recognise there is a desire for authoritative guidance on extended external reporting in Australia and are taking steps to ensure Australia adopts a reporting regime that meets the needs of users of financial and non-financial reporting information and supports Australia's international competitiveness.

In December 2021 the AASB and AUASB issued a joint [staff article](#) *Globally consistent reporting for sustainability-related information - Australian perspectives* which provides an overview of the Australian perspective on recent global sustainability-related developments and the considerations for what approach the AASB and AUASB may take in response to those developments.

Operating within the existing institutional framework, the AASB intends to develop reporting requirements for non-financial information and the AUASB intends to simultaneously update relevant assurance standards, which are already capable of addressing current voluntary disclosures.

The AASB agreed at its February 2022 meeting to finalise the Position Statement which supports the voluntary application of the TCFD recommendations. The AASB also acknowledged significant support for the Board to undertake a project on sustainability reporting arising from feedback to its agenda consultation and made preliminary decisions toward the development of a project

plan (for more information see [AASB Action Alert](#)). [Position Statement](#) *Extended External Reporting Framework* was released in March 2022 and notes that the AASB “supports the voluntary adoption of the recommendations made by the Task Force on Climate-related Financial Disclosures (TCFD)”.

Following the issue of the ISSB's exposure drafts in April 2022, the AASB issued an equivalent Exposure Draft, [ED 321](#) *Request for Comment on ISSB [Draft] IFRS S1 General Requirements for Disclosure of Sustainability-related Financial Information and [Draft] IFRS S2 Climate-related Disclosures*, seeking feedback in the Australian context. ED 321 outlines the AASB's preliminary decision to position Australian sustainability-related reporting requirements as a separate suite of standards, which leaves the decision to mandate sustainability-related financial reporting with the relevant Australian legislators. Comments on the AASB's proposals closed on 15 July 2022.

In the October 2022 Federal Budget, the Federal Government announced funding for Treasury and the AASB “to develop and introduce climate reporting standards for large businesses and financial institutions, in line with international reporting requirements”. The timing of adoption in Australia is currently unclear, but entities are encouraged to start preparing now.

Treasury

Treasury will work with ASIC and industry to deliver the Government's commitment to standardise climate disclosure requirements for large, listed companies and financial institutions. This will include consultation on options and models for introducing globally aligned climate reporting requirements, as well as on the scope and timing of any mandatory obligations.

Treasury is also closely monitoring legislative and regulatory developments in key jurisdictions that are developing more prescriptive climate-related disclosure requirements, including through active engagement by Treasury posts and consultation with counterparts in other jurisdictions.

Legislation

The Federal Parliament has passed the [Climate Change Act 2022](#) which sets a 43% reduction in Australia's net greenhouse gas emissions by 2030 and a net zero target for 2050. The [Climate Change \(Consequential Amendments\) Act 2022](#) makes consequential amendments to existing federal legislation in order to support the effective implementation of the *Climate Change Bill 2022*. These legislative developments provide the framework for further initiatives to achieve the targets.

Other developments

During 2021 and 2022, the following highlighted developments have occurred (to the date of this publication), in addition to those noted above:

- The European Commission has proposed a Corporate Sustainability Reporting Directive (CSRD) which aims to improve sustainability reporting to better exploit the potential of the European single market and to contribute to the transition to a fully sustainable and inclusive economic and financial system in line with the European Green Deal and the UN Sustainable Development Goals ([Business Reporting in Focus](#), [proposals](#), [press release](#))
- In March 2022, the United States Securities Exchange Commission proposed rules that would standardise climate-related disclosures for investors, based on the TFCF recommendations and greenhouse gas protocol ([press release](#), [proposed rules](#))
- In October 2022, the TCFD released its [2022 Status Report](#) which reviewed publicly available reports of over 1,400 companies from eight industries and five regions to better understand current climate-related financial disclosure practices and their evolution. The report showed steady growth in climate-related financial disclosures on an industry and regional basis over the previous three years and that the number of TCFD recommended disclosures adopted has been steadily increasing, although being short of the total compliance with the entire 11 recommendations of the TCFD.



This model annual report highlights those disclosures that may be impacted by climate change. [Appendix 1](#) summarises the disclosures that may be impacted by climate change.

B1.3.2 Proceeds from selling output when testing property, plant and equipment

In June 2020 the AASB issued AASB 2020-3 *Amendments to Australian Accounting Standards – Annual Improvements 2018–2020 and Other Amendments* which amends AASB 116 *Property, Plant and Equipment* to prohibit an entity deducting from the cost of property, plant and equipment amounts received from selling items produced while preparing the asset for its intended use. Instead, the sales proceeds and related cost will be recognised in profit or loss.

Before this amendment there was diversity in practice in accounting for the proceeds received from selling items produced while testing an item of property, plant or equipment before it is used for its intended use. Some entities only the proceeds from selling items produced from testing were deducted from the cost of the asset. Other entities deducted all sale proceeds from the cost of the asset until the item of property, plant or equipment was available for use, even if they did not relate to testing. They did this on the basis that the asset was not yet operating in the manner intended by management. In some cases, the amount of proceeds deducted from the cost of the property, plant or equipment exceeded the costs of testing.

As a result of this amendment entities will need to identify the costs incurred from producing and selling items produced while preparing an item of property, plant or equipment for its intended use. This may require new estimation and judgments as well as present challenges in implementing the new amendment.

The disclosure requirements of AASB 15 *Revenue from Contracts with Customers* and AASB 2 *Inventories* apply if the sale of the items are an output of the entity's ordinary activities. Alternatively, unless the sales proceeds and cost are presented separately in the statement of comprehensive income, the sales proceeds and related costs recognised in profit or loss and the line items in which such sales proceeds and costs are included in the statement of comprehensive income shall be disclosed.

The amendments are effective for annual periods beginning on or after 1 January 2022 and therefore effective for the first time for reporting periods ending 31 December 2022. The amendments apply retrospectively, but only to items of property, plant and equipment that are brought to the location and condition necessary for them to be capable of operating in the manner intended by management on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments.

B1.3.3 Cost of fulfilling a contract – onerous contracts

In June 2020 the AASB issued AASB 2020-3 *Amendments to Australian Accounting Standards – Annual Improvements 2018–2020 and Other Amendments* which amends AASB 137 *Provisions, Contingent Liabilities and Contingent Assets* by providing guidance regarding costs of fulfilling a contract in respect of onerous contracts. The amendments clarify that the cost of fulfilling a contract are those costs that relate directly to the contract, consisting of both (AASB 137:68A):

- The incremental costs of fulfilling that contract (e.g. direct labour and materials)
- An allocation of other costs relating directly to fulfilling contracts (e.g. an allocation of the depreciation charge for property, plant and equipment used in fulfilling that contract among others).

The clarification was added as research undertaken by IFRIC indicated that differing views on which costs to include could lead to material differences in the financial statements of entities that enter into some types of contracts and that the need for clarification was urgent⁶.

⁶ Following the withdrawal of AASB 11 *Construction Contracts* (when the new revenue standard AASB 15 *Revenue from Contracts with Customers* was issued), entities are required to apply AASB 137 instead of AASB 111 to assess whether construction contracts are onerous. AASB 111 specified which costs to include, whereas AASB 137 did not.

Depending on an entity's existing approach for measuring the cost of fulfilling a contract the amendment may result in recognition of bigger or more onerous contract provisions.

The amendments are effective for periods beginning on or after 1 January 2022 and therefore effective for the first time for reporting periods ending 31 December 2022. The amendments apply to those contracts for which an entity has not yet fulfilled all of its obligations at the beginning of the annual reporting period in which it first applies the amendments. Comparative information should not be restated.

B1.3.4 Net realisable value of inventories

In June 2021, IFRIC finalised an [agenda decision](#) on the costs an entity includes as the 'estimated costs necessary to make the sale' when determining the net realisable value of inventories. In particular, IFRIC was responding to a request asking whether an entity includes all costs necessary to make the sale or only those that are incremental to the sale.

Paragraph 6 of AASB 102 *Inventories* defines net realisable value as "the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale". Paragraphs 28 to 33 of AASB 102 include further requirements regarding how an entity estimates the net realisable value of inventories. These paragraphs do not identify which specific costs are "**necessary to make the sale**" of inventories, in particular whether such costs are limited to incremental costs. However, AASB 102:28 describes the objective of writing inventories down to their net realisable value as being to avoid inventories being carried "in excess of amounts expected to be realised from their sale".

When determining the net realisable value of inventories, AASB 102 requires an entity to estimate the costs necessary to make the sale. The IFRIC agenda decision states that this requirement does not allow an entity to limit such costs to only those that are incremental, thereby potentially excluding costs the entity must incur to sell its inventories but which are not incremental to a particular sale. Including only incremental costs could fail to achieve the objective set out AASB 102:28.

Therefore, when determining the net realisable value of inventories, an entity estimates the costs necessary to make the sale in the ordinary course of business. An entity uses its judgement to determine which costs are necessary to make the sale considering its specific facts and circumstances, including the nature of the inventories.

Prior to the publication of the agenda decision, entities may have concluded that it is was acceptable to limit the costs necessary to make the sale to incremental costs by analogy to AASB 136 which defines 'costs of disposal' as the "incremental costs directly attributable to the disposal of an asset, excluding finance costs and income tax expense". If an entity determines that it needs to change its accounting policy as a result of the June 2021 IFRIC agenda decision, it would be entitled to take sufficient time to make that determination and implement any necessary accounting policy change. Nonetheless, it would be expected to implement the change on a timely basis and, if material, consider whether disclosure related to the change is required.



For an illustrative disclosure of the change in inventories accounting policy see Appendix 2:

- **Change in accounting policy – Net realisable value of inventories on page 268**
- **Significant accounting policies – Inventories on page 270.**

B1.3.5 Economic benefits from use of a windfarm – power purchase agreements (PPAs)

In December 2021 IFRIC finalised an [agenda decision](#) on whether applying paragraph B9(a) of IFRS 16 Leases, an electricity retailer has the right to obtain substantially all the economic benefits from use of a windfarm throughout the term of an agreement (often referred to as 'power purchase agreements' (PPAs)) with a windfarm generator (supplier).

IFRS 16 paragraph B9(a) requires that to assess whether a contract conveys the right to control the use of an identified asset for a period of time, an entity shall assess whether, throughout the period of use, the customer has the right to obtain substantially all of the economic benefits from use of the identified asset (as described in paragraphs B21–B23).

In the agenda decision, the Committee concluded that, in the fact pattern described in the request, the retailer does not have the right to obtain substantially all the economic benefits from use of the windfarm.

Consequently, the Committee therefore concluded that the agreement does not contain a lease. The Committee also noted the below two other agenda items that provide explanatory material which may be relevant to the swap agreement described in the fact pattern:

- [Meaning of delivery – IFRS 9 Financial Instruments \(August 2005\)](#)
- [Application of the highly probable requirement when a specific derivative is designated as a hedging instrument – IFRS 9 and IAS 39 \(March 2019\)](#).

Whilst the decision is in respect of a specific fact pattern entities should consider the conclusions reached by the Committee where they have similar arrangements e.g. under PPAs or virtual PPA arrangements involving corporates, a generator and an intermediary.

B1.3.6 Demand deposits with restrictions on use arising from a contract with a third party

Background

In April 2022 IFRIC finalised an [agenda decision](#) as to whether an entity includes demand deposits with restrictions on use as a component of cash and cash equivalents.

IAS 7 *Statement of Cash Flows* paragraph 6 defines 'cash' by stating that it 'comprises cash on hand and demand deposits.' IAS 7 includes no requirements on whether an item qualifies as cash beyond the definition itself.

IAS 7 and IAS 1 *Presentation of Financial Statements* indicate that amounts included in cash and cash equivalents may be subject to restrictions, namely:

- IAS 7.48 requires an entity to disclose information about 'significant cash and cash equivalent balances held by the entity that are not available for use by the group'
- IAS 1.66(d) requires an entity to classify as current an asset that is 'cash or a cash equivalent (as defined in IAS 7) unless the asset is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period'.

Consequently, the Committee therefore concluded that restrictions on the use of a demand deposit arising from a contract with a third party do not result in the deposit no longer being cash, unless those restrictions change the nature of the deposit in a way that it would no longer meet the definition of cash in IAS 7.

Presentation in the statement of financial position

Paragraph 54(i) of IAS 1 requires an entity to include a line item in its statement of financial position that presents the amount of 'cash and cash equivalents'. Paragraph 55 of IAS 1 states 'an entity shall present additional line items (including by disaggregating the line items listed in paragraph 54) ... in the statement of financial position when such presentation is relevant to an understanding of the entity's financial position'.

The Committee concluded that when relevant to an understanding of its financial position, the entity would disaggregate the 'cash and cash equivalents' line item and present the demand deposit separately in an additional line item.

An entity that presents assets as current or non-current would classify the demand deposit as current applying paragraph 66(d) of IAS 1, unless the demand deposit is 'restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period'.

Disclosures

Paragraph 45 of IAS 7 states that 'an entity shall disclose the components of cash and cash equivalents...'. Applying this requirement, in the fact pattern described in the request, the entity discloses the demand deposit as a component of cash and cash equivalents. The entity also considers whether to disclose additional information:

- In the context of the requirements in IFRS 7 *Financial Instruments: Disclosures* about liquidity risk arising from financial instruments and how an entity manages that risk
- If the information it provides in applying the disclosure requirements in IAS 7 and IFRS 7 is insufficient to enable users of financial statements to understand the impact of the restrictions on the entity's financial position (paragraph 31 of IAS 1).

The Committee concluded that the principles and requirements in IFRS Accounting Standards provide an adequate basis for an entity to determine whether to include demand deposits subject to contractual restrictions on use agreed with a third party as a component of cash and cash equivalents in its statements of cash flows and financial position. Consequently, the Committee decided not to add a standard-setting project to the work plan.

B1.3.7 Accounting policy disclosure changes

AASB 2021-2 *Amendments to Australian Accounting Standards – Disclosure of Accounting Policies and Definition of Accounting Estimates* makes amendments to various Australian Accounting Standards and AASB Practice Statement 2 *Making Materiality Judgements* to change the way in which accounting policies are disclosed in financial reports, requiring disclosure of material accounting policy information rather than significant accounting policies.

Under the revised requirements, accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. As a result, standardised information or information that only duplicates or summarises the requirements of Australian Accounting Standards may be less useful to users of financial statements. Removal of this 'boilerplate' information can substantially reduce the volume of disclosure in financial statements.

AASB 101 *Presentation of Financial Statements* notes the following areas as examples where an entity is likely to consider accounting policy information material to its financial statements if that information relates to material transactions, other events or conditions and the accounting policy (AASB 101.117B):

AASB Practice Statement 2 *Making Materiality Judgements* (as amended by AASB 2021-2) provides further detail on determining whether accounting policy information is material.

Whilst not effective until annual reporting periods beginning on or after 1 January 2023, early adoption may be attractive for entities wishing to place an emphasis on meaningful, entity-specific accounting policy information rather than repeating the requirements of Australian Accounting Standards.

B1.3.8 Complex financing arrangements

Some financing transactions such as raising capital, supplier finance arrangements and borrowing facilities may involve features that change the accounting treatment of the transaction (e.g. classification, debt vs equity).

The following are some examples of arrangements to look out for:

- **Debt or equity. Arrangements may involve features that appear to be equity but are in fact liabilities.** For example, share options that may be settled in cash in certain circumstances. Incorrect classification may result in material errors. Transactions involving share capital are not automatically classified as equity. For example, "piggyback options" attached to a rights issue can result in derivative classification, resulting in profit or loss volatility.
- **Sale and leaseback transactions.** Transactions where an asset is legally sold to another party and immediately leased back by the seller can result in unexpected accounting outcomes. In some cases, the transaction will be considered purely a financing arrangement (i.e. not a sale), whilst in others only a proportion of the overall gain will be recognised
- **Supplier finance arrangements.** In light of the [IFRIC agenda decision](#), entities need to carefully assess presentation of such arrangements in the statement of financial position and statement of cash flows, the necessary disclosures around liquidity and other risks, derecognition and other factors
- **Unusual features.** Financing facilities that contain linkages to non standard variables may result in embedded derivatives or compound financial instrument accounting, e.g. conversion features, equity linked features.

B1.4 Australian specific considerations

Some of the Australian-specific and other related factors that need to be considered in the current reporting season:

B1.4.1 Accounting implications of recent Australian government initiatives

COVID-19 and flood support

The Federal and State Governments provided various support packages in response to the COVID 19 pandemic and the floods in Eastern Australia. Such support packages include the JobKeeper scheme which effectively provided a wage subsidy to entities materially impacted by COVID-19. The JobKeeper scheme ended on 28 March 2021, however some entities have subsequently chosen to return some or all of the funds received under the scheme⁷.

Other schemes include the JobMaker Hiring Credit scheme (or payment for eligible employers creating additional jobs over the subsequent 12 month period⁸) which the Federal Budget announced in October 2020. Eligible employers must be able to demonstrate that the new employees increase overall headcount and payroll in order to claim the JobMaker Hiring Credit. Eligible employers can access the JobMaker Hiring Credit for each eligible additional employee aged between 16 and 35 they hire between 7 October 2020 and 6 October 2021. The current scheduled claim period end date of the JobMaker scheme is 31 January 2023.

Additionally, a Boosting Apprenticeship Commencements (BAC) wage subsidy was available to employers employing an eligible Australian apprentice or trainee who commenced on or after 5 October 2020. From 30 June 2022, BAC and the related Completing Apprenticeship Commencements (CAC) Program closed to new apprenticeship commencements. From 1 July 2022 to 30 June 2024, the [Australian Apprenticeships Incentive System](#) will provide broad support through wage subsidies for eligible employers in priority occupations. This scheme provides a 10% subsidy of wages for first and second year apprentices and a 5% subsidy of wages for third and fourth year apprentices on a priority list of occupations, and hiring incentive of \$3,500 and \$1,750 for full and part-time employers of Australian apprentices not included in the priority list of occupations. Employers claiming incentives for an apprentice or trainee who commenced before 1 July 2022 will continue to be supported under the Australian Apprenticeships Incentives System.

Flood support schemes include the New South Wales *storm and flood disaster recovery small business grant*⁹ and *Extraordinary Disaster Assistance Recovery Grants – South East QLD Flooding (Small Business) program*¹⁰ which provides grants of up to \$50,000 for eligible small businesses and not-for-profit organisations directly impacted by the floods in New South Wales (in February, March, June and July 2022) and Queensland (in February and March 2022).

These support packages may have a material impact on entities. There are several accounting issues such as whether the employer was acting as principal or agent, and how and when any amounts should be recognised.

These payments represent a government grant (for for-profit entities) which is recognised under AASB 120 *Accounting for Government Grants and Disclosure of Government Assistance*. This grant is recognised as a receivable when there is reasonable assurance that the entity will comply with the conditions attached to the grant and the grant will be received. The grant is recognised in profit or loss in the period in which the entity recognises the related costs as expenses.

Where associated costs are recognised as an expense, for-profit entities have an accounting policy choice of presenting the grant income as other income, or alternatively deducting the grant from the related expense. Where material, the accounting policy for these grants should be clearly disclosed together with the nature and extent of such grants. Separate disclosure is particularly important where the grant has been deducted from the related expense.

⁷ From 14 September 2021, all listed entities that received a JobKeeper payment, including through a subsidiary, are required to provide a notice to the market operator (such as the ASX, NSX, etc) with various details which include whether the entity has made one or more voluntary repayments of JobKeeper payments and if so, the sum of those payments. ASIC released an online form and [information sheet](#) to assist entities with compliance. Further, the ATO [released guidance](#) for entities seeking to voluntarily return JobKeeper funds, including guidance on when such amounts may be considered deductible for tax purposes. Entities choosing to return such payments should ensure the amounts returned are only recognised once the company has clearly committed to returning the amounts, are clearly disclosed in their financial statements and are treated consistently for accounting and tax purposes. Consideration should also be given to the entity's accounting policy for previous government grants, consistency in treatment between grants, and transparency of the amount received when making the required disclosures, both in the financial statements as well as the operating and financial review. This will include how the amounts are presented in the profit or loss and cash flow statement as well as flow on impacts on areas such as segment reporting, impairment and non-IFRS measures.

Not-for-profit entities applying AASB 1058 *Income of Not-for-Profit Entities* or AASB 15 *Revenue from Contracts with Customers* are required to recognise the grant in income and do not have the accounting policy choice to deduct the grant from the related expense.

Temporary tax loss carry backs

Changes announced in the October 2020 Federal Budget, and subsequently enacted, permit corporate tax entities with an aggregated annual turnover of less than \$5 billion to elect to carry back tax losses from the 2019-20, 2020-21 and 2021-22 income years to offset previously taxed profits in 2018-19 or later income years. The Federal Budget delivered in May 2021 announced that the (then) Government intended to extend this to tax losses from the 2022-23 income year. The extension was made law in February 2022 through the [Corporate Collective Investment Vehicle Framework and Other Measures Bill 2021](#) and commenced on 1 April 2022. The measure was not extended further in the March 2022 or October 2022 budgets.

This measure allows entities to access the benefit of tax losses earlier and receive a refund of tax previously paid. The loss offset can be, or will be able to be, claimed in the 2020-21, 2021-22 and 2022-23 income years. The amount carried back must not generate a franking deficit and is limited to the level of previously taxed profits.

Accounting considerations include:

- Recognition of a current tax asset – AASB 112 *Income Taxes* requires the benefit relating to a tax loss that can be carried back to recover current tax of a previous period to be recognised as an asset. As the carry back is optional, only entities that elect to carry back would recognise a current tax asset
- Classification – Any tax asset recognised would be classified based on its expected receipt. As the intention is that refunds of past tax would be paid on lodgement of the entity's tax return, the amount would generally be classified as a current asset
- Deferred taxes – The assessment of the recoverability of deferred tax assets may change as a result of the ability to carry back tax losses
- Uncertain tax positions – As the carry back is limited to the level of previously taxed profits, uncertain tax positions in relation to prior income years may directly or indirectly impact the amount of tax losses that can be recognised as a carry-back asset. In our view, the amount recognised for a carry back should be consistent with the recognition and measurement of current tax amounts in prior years (i.e. the amounts recognised for accounting purposes should be recognised as a carry-back asset where relevant, notwithstanding that there may be uncertainty surrounding certain tax positions taken in calculating the amounts recognised). This is consistent with the requirements of Interpretation 23 *Uncertainty over Income Tax Treatments*.

Immediate deduction for capital expenditure

Also announced in the October 2020 Federal Budget and subsequently enacted was a concession whereby businesses with aggregated annual turnover of less than \$5 billion can deduct the full cost of eligible capital assets acquired after 7:30pm AEDT on 6 October 2020 and first used or installed ready for use by 30 June 2022. The Federal Budget delivered in May 2021 announced that the (then) Government intended to extend this measure allowing for the temporary full expensing of eligible depreciating assets for a further 12 months, until 30 June 2023. The extension was made law in February 2022 through the [Treasury Laws Amendment \(Enhancing Superannuation Outcomes For Australians and Helping Australian Businesses Invest\) Act 2022](#) and commenced on 1 April 2022. The measure was not extended further in the March 2022 or October 2022 budgets.

The key concession is available for the full cost of new eligible depreciating assets and the cost of improvements made during the period to existing eligible depreciable assets. However, only businesses with aggregated annual turnover less than \$50 million can deduct the cost of second-hand eligible depreciating assets.

Accounting considerations include:

- Deferred tax considerations – An immediate deduction will give rise to a deferred tax liability for the taxable temporary difference between the carrying amount of the asset and the tax base (which will generally be zero)
- Interaction with the tax loss carry back provisions – The immediate tax deduction (similar to other deductions) may result in a tax loss, which may be eligible for carry back, resulting in a refund of past tax paid (as discussed above). Accordingly, any

amount of the tax loss able to be carried back will be recognised as a current tax asset rather than a deferred tax asset arising from a tax loss

- Other impacts – The immediate deduction may cause some entities to preference direct acquisition rather than leasing of business assets, which may change capital management approaches and disclosures.

Research and development (R&D) concession

The October 2020 Federal Budget announced that a new R&D regime would commence with effect from 1 July 2021. Under the new regime enacted in October 2020 and applying to income years commencing on or after 1 July 2021, the refundable R&D tax offset rate for entities with turnover of less than \$20m is fixed at 18.5 per cent above the prevailing corporate tax rate. For entities with turnover of \$20 million or more, the non refundable R&D tax offset is based on a two-stepped intensity threshold. The R&D expenditure threshold has also been increased from \$100 million to \$150 million.

Accounting for the new regime is expected to be largely consistent with general practice under the prior regime:

- The refundable R&D tax offset is generally accounted for as a government grant, with a credit recognised in profit before tax over the period necessary to match the benefit of the credit with the costs for which it is intended to compensate
- In contrast, the non-refundable R&D tax offset is generally accounted for as an income tax and a credit recognised within tax expense and a tax asset recorded when the entity satisfies the criteria to receive the credit. In addition, a deferred tax liability is recognised in relation to any related capitalised R&D asset.

The new R&D tax offset has different 'clawback' mechanisms for related government grants, 'feedstock adjustments' and balancing adjustments from the previous regime, and this may impact accounting policies.

Corporate collective investment vehicle (CCIV) regime

Originally announced in the 2016-17 Budget, the Government subsequently announced in the May 2021 Federal Budget that it would proceed with the introduction of a tax and regulatory framework for corporate collective investment vehicles (CCIV) with a revised commencement date of 1 July 2022.

On 22 February 2022 the related [Corporate Collective Investment Vehicle Framework and Other Measures Bill 2021](#) was made law resulting in the [Corporate Collective Investment Vehicle Framework and Other Measures Act 2022](#) which commenced on 1 July 2022 (and therefore its provisions are applicable for 31 December 2022 reporting).

CCIVs are an additional type of company under the Corporations Act used for funds management purposes with a corporate structure that provides flow through tax treatment for investors. Under the legislation, a CCIV may either be retail or wholesale, with retail CCIVs subject to a regulatory framework that encompasses protections for retail investors. The business of a CCIV is required to be conducted through one or more sub-funds (in other words, a CCIV would be required have at least one sub-fund). The CCIV, and each sub-fund of the CCIV, is required have at least one member and can issue shares and debentures that are referable to only one sub-fund, including redeemable ordinary shares. Retail sub-funds have mandatory financial reporting requirements under the Corporations Act.

Temporary levy on offshore petroleum production

In the 2021-22 Federal Budget the Government announced a temporary levy on offshore petroleum production to recover the Commonwealth's costs of decommissioning the Laminaria and Corallina oil fields and associated infrastructure from 1 July 2021. This was [passed by Parliament](#) on 30 March 2022 and its final provisions should also be taken into account in accounting.

Unlegislated announcements

A number of previously announced proposals included in Federal Budgets prior to the calling of the 2022 Federal election have not been enacted. At the time of calling of the election, any Bills in parliament effectively lapsed and would need to be reintroduced by the Government in order to be debated and made law. A number of these measures were announced as being either discontinued or deferred in the October 2022 Federal Budget. However, the Federal Government has not yet indicated its intentions with respect to a number of previously announced measures and it is uncertain if these proposals (which are discussed below in more detail) will be enacted. In addition, the October 2022 Federal Budget included a number of additional measures. Potentially impacted entities should monitor any developments and consider the impact on financial reporting.

Removal of aged care bed licences from 2024

Under the unlegislated proposals announced in the 2021-22 Federal Budget, aged care bed licences would be discontinued from 1 July 2024 as part of a series of reforms. The Federal Department of Health subsequently released a [discussion paper](#) in September 2021 dealing with the proposed transition to the new regime. Whilst the focus of the consultation is not on whether the bed licences will be discontinued, the paper has indicated the following:

- A large number of new bed licences remain available to be allocated at no charge in the period until 1 July 2024 and that a large number of provisional places will also be available
- Whilst further measures may be required to mitigate potential risks that may arise from the removal of the licences, currently there are no plans to provide direct compensation to providers for the removal of the licences as the licences were initially provided by the government at no cost.

In ASIC's [focus areas for 30 June 2022 financial reports](#), additional commentary on proposed changes to aged care bed licences was included, noting that aged care providers should review the treatment of aged care bed licences.

Patent box regime

The Government announced in the May 2021 Federal Budget that from 1 July 2022, a concessional tax rate of 17% would apply to income which is relevantly derived from Australian owned and developed medical and biotechnology patents (with the clean energy sector also being considered at that time). Only granted patents, which were applied for after the Budget announcement, would be eligible. Federal Treasury released a [discussion paper](#) on the proposed patent box regime in July 2021.

In the March 2022 Federal Budget the (then) Government announced the expansion of the proposed new patent box regime to not only the low emissions technology sector but also to the agricultural sector, with effect from 1 July 2023. No information about the measure was included in the October 2022 Federal Budget.

If legislated, for tax accounting purposes this would create another category of tax activity which may require separate current and deferred tax accounting. For instance:

- Current tax accounting may need to be bifurcated into amounts that would be taxed at 17% and those that may be taxed at a higher rate. This may require a similar process to that applied to the determination of amounts on revenue and capital account
- Deferred tax assets and liabilities associated with assets and liabilities would be measured using the 17% tax rate to the extent they were used in the eligible activity and counted in the determination of the taxable profits subject to the lower rate
- The determination of whether it is probable sufficient taxable profits are available against which deferred taxes can be utilised would need to consider both the design of the regime (including any ring-fencing) and the differing tax rates applicable to each income stream. In some cases, it may mean deferred tax assets expected to be probable no longer meet the test.

Self-assessing the effective life of certain intangible assets

The (then) Government announced in the May 2021 Federal Budget that it intends to amend the law to allow taxpayers to self-assess the effective life of certain intangible assets comprising patents, registered designs, copyrights, licenses, in-house software and telecommunications site access rights, instead of being required to use the effective life currently prescribed in the *Income Tax Assessment Act 1997* (section 40-95(7)).

In the October 2022, the Federal Government announced that it would not proceed with this measure. Accordingly, entities should not take this change into account in financial reporting.

Digital games tax offset

The 2021-22 Federal Budget included an unlegislated refundable Digital Games Tax Offset (DGTO) of 30% which would target the development of transferable skills and position Australia to take a greater share of the global gaming market. The new offset was intended to commence with effect from 1 July 2022 for Australian resident companies or foreign resident companies with a permanent establishment in Australia. To qualify, there will be a minimum spend requirement of \$500,000 on qualifying Australian games expenditure.

No further information was included in the October 2022 Federal Budget and accordingly, there is no certainty that this proposal will proceed.

If legislated, accounting considerations include:

- As the tax offset is refundable, it may be accounted for as a government grant under AASB 120 *Accounting for Government Grants and Disclosure of Government Assistance*
- A credit will be recognised in profit or loss over the periods necessary to match the benefit of the credit with the costs for which it is intended to compensate. Such periods will depend on whether the related costs are capitalised or expensed as incurred for accounting purposes.

Global agreement on corporate taxation

Treasury is [consulting](#) on Australian implementation of the 'two-pillar' solution developed by the OECD Inclusive Framework on Base Erosion and Profit Shifting that would help ensure that multinationals pay their fair share of tax in the jurisdictions in which they operate.

Pillar One would reallocate some of the taxing rights on the largest and most profitable multinationals to the countries where the goods and services are consumed. Pillar Two of the proposed reforms seeks to put a floor on the 'race to the bottom' on corporate tax rates by establishing a global minimum corporate tax rate of 15 per cent.

Implementation of these proposals may impact the tax accounting by affected entities.

Changes to thin capitalisation rules

In August 2022, Treasury released a [consultation paper](#) on a proposed multinational tax integrity package which includes limiting debt-related deductions by multinational enterprises.

In the October 2022 Federal Budget, the Federal Government announced its intention to proceed with this measure and outlined the following details on how the new regime would work:

- An entity's debt-related deductions would be limited to 30 per cent of EBITDA (earnings before interest, taxes, depreciation, and amortisation). This new earnings-based test would replace the existing safe harbour test (based on the entity's debt to equity ratio). Deductions denied under the entity-level EBITDA test would be able to be carried forward and claimed in a subsequent income year (for up to 15 years)
- An entity in a group would be allowed to claim debt-related deductions up to the level of the worldwide group's net interest expense as a share of earnings (which may exceed the 30 per cent EBITDA ratio). This new earnings-based group ratio would replace the existing worldwide gearing ratio
- An arm's length debt test would be retained as a substitute test but would apply only to an entity's external (third party) debt, disallowing deductions for related party debt under this test.

The new measures would apply to multinational entities operating in Australia and any 'inward' or 'outward' investor, in line with the existing thin capitalisation regime. Financial entities will continue to be subject to the existing thin capitalisation rules.

The new measures are intended to operate for income years commencing on or after 1 July 2023.

If substantively enacted, these proposals may have impacts on the recognition of deferred taxes (particularly in respect of the possible recognition of deferred tax assets for carried forward denied deductions, and possibly increasing the recognition of carried forward deferred tax losses where they will be utilised because interest deductions have been denied). More immediate impacts may occur in terms of debt refinancing, and liquidity risk and capital management disclosures, if restructuring of Australian financing arrangements is anticipated in response to the proposals.

Limiting deductions for certain payments for intangible assets

The October 2022 Federal Budget confirmed the Federal Government's intention to proceed with the introduction of an anti-avoidance rule to prevent significant global entities (entities with global revenue of at least \$1 billion) from claiming tax deductions for payments made directly or indirectly to related parties in relation to intangibles held in low- or no-tax jurisdictions. The budget papers clarify that for the purposes of this measure, a low- or no-tax jurisdiction would be a jurisdiction with a tax rate of less than 15 per cent or a tax preferential patent box regime without sufficient economic substance. The measure will apply to payments made on or after 1 July 2023.

If substantively enacted, this measure would impact the calculation of current taxes (as denied payments would effectively be 'permanent differences') and may impact the recognition of deferred taxes (particularly where carried forward losses become probable due to increased tax profits due to the denied tax deductions).

Changes to franking of dividends

There are two unlegislated measures that may limit franking of dividends in certain situations:

- In September 2022, the Federal Government released [Exposure Draft legislation](#) to implement an integrity measure originally announced in the 2016-17 Mid-Year Economic and Fiscal Outlook. The measure would prevent companies from attaching franking credits to distributions to shareholders made outside or additional to the company's normal dividend cycle, to the extent the distributions are funded directly or indirectly by capital raising activities that result in the issue of new equity interests. This measure is intended to retrospectively apply from 19 December 2016 (i.e. when it was first announced by the previous Government)
- The October 2022 Federal Budget announced the Federal Government's intention to align the tax treatment of off-market share buy-backs undertaken by listed public companies with the treatment of on-market share buy-backs. Currently, proceeds from an on-market share buy-back are broadly treated as consideration for the disposal of shares, whereas consideration received via an off-market buy-back is split between sale proceeds and a dividend amount (which may be franked). This measure is intended to be effective from budget night (7:30pm AEDT, 25 October 2022).

Whilst an entity does not recognise franking credits for financial reporting purposes, these measures may have indirect impacts, for example:

- The changes may alter intended capital management plans of an entity, which may affect the capital management disclosures made under AASB 101 *Presentation of Financial Statements*
- The retrospective nature of the change related to distributions funded by capital raisings may result in the loss of franking credits on distributions received by entities, resulting in prior period adjustments.

Public reporting of tax information

The October 2022 Federal Budget contained further details of the Federal Government's proposals for improving tax transparency by multinational entities:

- Large multinationals (defined as significant global entities) would be required to prepare for public release of certain tax information on a country by country (CbC) basis and a statement on their approach to taxation, for disclosure by the ATO. An earlier [consultation paper](#) sought feedback on whether such information should be based on EU proposals, the Global Reporting Initiative Tax Standard or a mandated [Tax Transparency Code](#)
- Australian public companies (listed and unlisted) would be required to disclose information on the number of subsidiaries and their country of tax domicile
- Tenderers for Australian Government contracts worth more than \$200,000 would be required to disclose their country of tax domicile (by supplying their ultimate head entity's country of tax residence).

The measures are intended to apply for income years commencing on or after 1 July 2023. Affected entities should ensure systems are in place to prepare the required information.

Other considerations

Recent Federal Budgets contain numerous other measures which have/could impact various entities. A vast array of government packages have been made available from all levels of government to assist entities to manage cash flow challenges. In addition, the Budgets have an impact on overall economic outcomes. The effects of the Budgets may need to be considered in such areas as:

- **Characterisation of schemes** – Characterisation of schemes such as JobMaker, between government assistance or government grants under AASB 120 or income tax under AASB 112 directly impacts the accounting. For instance, AASB 120 indicates that the provision of a guarantee is government assistance rather than a grant (so only requiring disclosure). However government support and loan packages involving other features may have government grant elements that require separate accounting
- **Substantive enactment** – The current and deferred tax implications of the Budget changes must be recognised where the entity's reporting date is after substantive enactment of the enabling legislation of each measure. Where the legislation has not been enacted at the entity's reporting date but is substantively enacted prior to signing of the financial statements, subsequent events disclosure may be required, rather than amending current and deferred tax accounting reflected in the financial statements.
- **Cash flow forecasts** – Cash flows used in recoverable amount models when testing impairment under AASB 136 *Impairment of Assets* may require the assessment of various scenarios, and budget information and announcements may impact some or all such scenarios. For example, the tax loss carry back and immediate capital expenditure tax write off may result in changes to the way in which capital expenditure and tax cash flows are included in value in use models. The effects of the temporary reduction in petroleum excise which applied until 28 September 2022 should not be rolled forward in forecasts, including those eligible for a rebate. New and extended wage subsidy schemes for apprenticeships will impact forecast cash flows and planning for eligible entities
- **Expected credit losses (ECLs)** – The development of ECLs in respect of loans and other receivables should consider the known and macro-economic impacts of the latest budgetary information
- **Employee implications** – The announced changes to government support programmes (including paid parental leave) and superannuation arrangements (including eliminating the \$450 monthly threshold to pay compulsory superannuation and the legislated superannuation guarantee levy increase to 12% over the coming years) would need to be taken into account in the measurement of employee liabilities and cash flow forecasts where relevant¹¹.

B1.4.2 ASIC focus areas for financial reporting

On 1 June 2022, ASIC released its focus areas for 30 June 2022 reporting which highlights the following key focus areas for 30 June 2022 financial reporting periods:

- **Asset values** - impairment of non-financial assets, values of property assets, expected credit losses on loans and receivables and values of other assets (including inventories in light of the [IFRIC agenda decision](#) and the probability assessment for deferred tax assets)
- **Provisions** - expanding specific concerns to include the adequacy of lease property make good and mine site restoration provisions in addition to onerous contracts, financial guarantees and restructuring previously highlighted in previous periods
- **Solvency and going concern assessments** - including updating the broader list of matters that may impact these assessments (the list of matters is also relevant to asset values, provisions, current and future performance and impacts on business strategies)
- **Events occurring after year end and before completing the financial report** - consistent with prior periods, events after year end should be reviewed to determine whether they relate to the current reporting period or new conditions requiring disclosure
- **Disclosures in the financial report and operating and financial review (OFR)** - including disclosing in the OFR on the most significant business risks at the whole-of-entity level and a discussion of environmental, social and governance risks.

Overall, the focus areas are largely consistent with prior periods, with the following additional changes:

- A de-emphasising of the impacts of COVID-19 in favour of broader concerns including the impact of rising interest rates and oil prices, geopolitical risks (including the Ukraine/Russia conflict), the discontinuation of government and other support, and changes in customer behaviour and skilled staff availability and expertise

- Greater emphasis on the disclosure of environmental, social and governance risks and ensuring consistency between disclosures in the OFR and any voluntary disclosures (such as those given under the Task Force on Climate-related Financial Disclosures)
- New focus areas including disclosure of material penalties for non-compliance with sanctions imposed in Australian or elsewhere in relation to Russia, and the recognition of assets, liabilities, income and expenses in registered scheme balance sheets and income statements where individual scheme members have pooled interests in assets and returns with some or all other members in substance.

At the date of this publication, (31 October 2022) ASIC has not yet released its focus areas for 31 December 2022 financial reports. We expect that the focus areas will be largely consistent with prior periods, covering recoverability of assets, classification of debt as current or non-current, adequacy of provisions, solvency and going concern assessments, disclosure of subsequent events and the impact of risks and uncertainties resulting from the changing economic environment.

B1.4.3 Results from prior ASIC financial report reviews

In June 2022, ASIC announced the results from its review of 31 December 2021 financial reports, calling for better disclosure of business risks and asset values. The review covered 70 listed entities and focussed on companies in the mining, property, and consumer finance industries, which represented over two-thirds of the total reviews. These industries were selected based on ASIC's key focus areas of asset values and provisions. Further, over half of the reviews were targeted due to going concern indicators.

ASIC made inquiries of 18 entities on 31 matters. The top areas where enquiries were raised from the review were:

- Operating and financial review (10 inquiries)
- Impairment and other asset values (7 inquiries)
- Provisions, revenue recognition, non-IFRS profits, going concern and leases (2 inquiries each).

B1.4.4 ASIC calls on insurers to respond to new insurance standard

In November 2020, ASIC issued a media release calling on insurers to respond to the new insurance standard, AASB 17 *Insurance Contracts*. AASB 17 is effective for reporting periods beginning on or after 1 January 2023.

In the media release, ASIC Commissioner Cathie Armour states that "[d]irectors and management of insurers need to plan for the new standard and inform investors and other financial report users of the impact on reported results".

The media release notes ASIC's expectation that financial reports of insurers at 31 December 2020 should disclose the impacts of AASB 17. We expect that ASIC will continue to encourage entities that may be impacted by AASB 17 to disclose the impacts as the effective date of the Standard draws closer.

Similar to what ASIC indicated for the adoption of other new standards (e.g. AASB 16 *Leases*), the adoption of AASB 17 could significantly affect results reported to the market, require changes to systems and processes, and affect businesses. Therefore it is important to inform investors and other financial report users of the impact on reported results.

Impacted entities should be cognisant of ASIC's concern previously raised in respect of disclosure of the impact of new standards where for example in [ASIC 18-203MR Findings from 31 December 2017 financial reports](#) ASIC Commissioner John Price said, "The number of companies that quantified the impact of coming new requirements for reporting revenue and financial instruments was

disappointing. Directors and preparers should ensure that they understand the impact of new accounting standards and have systems and processes in place to support reporting under these new standards.”

Considering that the adoption of AASB 17 is imminent (i.e. effective for annual reporting periods beginning on or after 1 January 2023) entities should ensure known impacts are disclosed and more extensive disclosure might be expected (than may have been previously provided) as the effective date draws closer.

B1.4.5 ASX developments

ASX Listing Rule amendments

Educational requirements for people communicating with the ASX

In mid-October 2019, the ASX released updates to its ASX Listing Rules and associated guidance dealing with shareholder information and meetings, initial admission and other matters (for details, see the ASX announcement, available at www.asx.com.au). Most of the updated requirements came into effect on 1 December 2019 except for the new and revised requirements around educational requirements for people communicating with the ASX were introduced. In terms of these requirements ASX contacts for entities with an ASX Listing (but not an ASX Debt Listing or Foreign Exempt Listing) appointed on or after 1 July 2022 and before 1 October 2022 must have completed the approved [ASX Listing Rules compliance course](#) and attained a satisfactory pass mark by 14 October 2022.

From 1 October 2022, new nominated ASX contacts for entities with an ASX Listing will need to pass the course prior to their appointment or prior to the entity's admission (or readmission), as applicable. If a nominated ASX contact has already passed the course on behalf of a different listed entity, they are not required to pass it again.

Updated requirements for oil and gas entities

In October 2021 the ASX published [Consultation Response Proposed changes to the oil and gas reporting requirements in the ASX Listing Rules](#), which outlined the final rule changes in respect of reporting by oil and gas entities of their reserves and resources. The ASX made a small number of minor and immaterial corrections to the rule amendments since it published the Consultation Response and released an up-to-date version of the rule amendments ([Final changes to Chapter 5 and Rule 19.12 of the ASX Listing Rules proposed to come into effect 1 July 2022](#)) in May 2022.

Chapter 5 of the ASX Listing Rules was drafted based on the 2007 edition of the Petroleum Resources Management System sponsored by the Society of Petroleum Engineers, the American Association of Petroleum Geologists, the World Petroleum Council and the Society of Petroleum Evaluation Engineers (SPE-PRMS). The SPE-PRMS was revised in July 2018, introducing a revised resources classification framework, and the final listing rule changes made by the ASX give effect to the revised framework (with some exceptions).

The revised Chapter 5 and Chapter 19 of the ASX Listing Rules came into effect on 1 July 2022.

The ASX also released a marked up [Guidance Note GN 32 Reporting of oil and gas activities](#) which takes into account the changes to the reporting of petroleum reserves which came into effect on 1 July 2022.

B1.4.6 Using technology to hold meetings and sign documents

Following on from temporary amendments made in 2021 to the Corporations Act in response to the COVID-19 pandemic, in February 2022 the Federal Parliament made the *Corporations Amendment (Meetings and Documents) Act 2022*, which makes permanent changes to the Corporations Act to allow companies and registered schemes to:

- Hold hybrid meetings (attending in person or remotely) and wholly virtual meetings if permitted by the entity's constitution
- Use technology to execute, sign and distribute company and meeting documents.

The new requirements came into effect on 1 April 2022 and replace temporary measures which expired on 31 March 2022.

B1.4.7 New financial reporting requirements for AFS licensees

In March 2020, the Australian Accounting Standards Board (AASB) issued two new pronouncements that:

- Remove the ability to prepare special purpose financial statements for some for-profit entities – through an *Amending Standard, AASB 2020-2 Amendments to Australian Accounting Standards – Removal of Special Purpose Financial Statements for Certain For-Profit Private Sector Entities*
- Introduce a new Tier 2 'Simplified Disclosure' Standard which replaces the existing 'Reduced Disclosure Requirements' (RDR) – *AASB 1060 General Purpose Financial Statements – Simplified Disclosures for For-Profit and Not-for-Profit Tier 2 Entities*.

The changes are effective to reporting periods beginning on or after 1 July 2021 and eliminate the application of the 'reporting entity' concept by impacted entities. Accordingly, entities reporting under the Corporations Act 2001 are required to prepare GPFS, including AFS licensees.

In early June 2022, ASIC released media release [22-128MR](#) *ASIC announces financial reporting changes for AFS licensees*, which set out the revised financial reporting framework to be applied in light of the changes in the Australian financial reporting framework for for-profit entities. The media release sets out the changes ASIC intended to make to FS70, which in summary:

- Requires all AFS licensees to prepare GPFS
- Puts forward ASIC's view that all AFS licensees holding client monies have public accountability and so must prepare Tier 1 GPFS (this is stated in the ASIC press release but not explicitly stated in FS70 as this operates through the existing definition of 'public accountability' in Australian Accounting Standards)
- Requires a number of specified categories of 'large or sophisticated' licensees to prepare Tier 1 GPFS
- Confirms that AFS licensees are required to present a statement of cash flows in all cases (which is required in any case in GPFS prepared under Australian Accounting Standards)
- Require all AFS licensees with controlled entities to present both consolidated and parent entity information when submitting financial statements in accordance with FS70 (i.e. "four columns"). This was subsequently clarified to exclude entities that are eligible for consolidation relief under Australian Accounting Standards
- To provide transitional relief to some entities for their first financial year reporting under the new requirements, and in respect of comparative information in their subsequent financial year.

[Form FS70](#) was reissued on 1 July 2022 and was subsequently revised on 19 September 2022 to clarify that intermediate parent entities are not required to prepare consolidated financial statements if they are eligible for consolidation relief under AASB 10 *Consolidated Financial Statements*. The revised requirements apply to financial years commencing on or after 1 July 2021 (i.e. to coincide with the application date of AASB 2020-2 and AASB 1060).

ASIC also published [Financial reporting and audit: Frequently asked questions \(FAQs\)](#) on its website providing responses to a number of frequently asked questions about the changes (among other topics).

B1.4.8 Changes to reporting requirements for ACNC registered charities

On 12 November 2021, amendments were made to the *Australian Charities and Not-for-profits Commissions Regulation 2013* via *Australian Charities and Not for profits Commission Amendment (2021 Measures No. 3) Regulations 2021*. The key amendments include:

- Additional reporting obligations for those preparing special purpose financial statements to require disclosures of key management personnel remuneration (effective from the 2022 AIS reporting period) and related party transactions (effective from the 2023 AIS reporting period)
- An update to financial reporting thresholds.

Effective from the 2022 AIS reporting period (financial years ending 31 December 2022), the thresholds have been amended as follows:

Given the changes in thresholds are now effective, it is imperative for affected charities to take note of these changes and ensure they comply with the new obligations for financial years ending 31 December 2022.

For each pronouncement, the effective date is listed, together with a summary of its applicability to annual reports and half-year reports for periods ending on 31 December 2022.

B2.1 Overall considerations

B2.1.1 Impacts of adopting new and revised pronouncements

Applying new and revised pronouncements for the first time can result in direct changes in recognition, measurement, presentation and disclosure requirements. In addition, there can be consequential impacts on financial reports through the transitional provisions of the pronouncement and the existing requirements of other Australian Accounting Standards.

The table below outlines some of the areas where these consequential impacts should be considered:

Area	Consideration
Updates to accounting policies	The terminology and substance of accounting policies may need to be updated to reflect new recognition, measurement and other requirements.
Impact of transitional provisions	AASB 108 <i>Accounting Policies, Changes in Accounting Estimates and Errors</i> contains a general requirement that changes in accounting policies are retrospectively applied, but this does not apply to the extent an individual pronouncement has specific transitional provisions.
Disclosures about changes in accounting policies	Where an entity changes its accounting policy as a result of the initial application of an Accounting Standard (including Interpretations as a result of AASB 1048 <i>Interpretation of Standards</i>) and it has an effect on the current period or any prior period, AASB 108 (subject to any specific transitional provisions of the Accounting Standard) requires the disclosure of a number of matters, e.g. the title of the Standard, the nature of the change in accounting policy, a description of the transitional provisions, and the amount of the adjustment for each financial statement line item affected.
Third statement of financial position	AASB 101 <i>Presentation of Financial Statements</i> requires (subject to any specific transitional provisions of the relevant Accounting Standard) the presentation of a third statement of financial position as at the beginning of the preceding period in addition to the minimum comparative financial statements in a number of situations. This applies where an entity applies an accounting policy retrospectively and the retrospective application has a material effect on the information in the statement of financial position at the beginning of the preceding period.
Earnings per share (EPS)	Where applicable to the entity, AASB 133 <i>Earnings Per Share</i> requires basic and diluted EPS to be adjusted for the impacts of adjustments resulting from changes in accounting policies accounted for retrospectively and AASB 108 requires the disclosure of the amount of any such adjustments.

B2.1.2 Disclosing information about pronouncements not yet adopted

The disclosure requirements required in relation to new and revised accounting pronouncements need to be carefully considered where they have not yet been adopted.

AASB 108 *Accounting Policies, Changes in Accounting Estimates and Errors* requires an entity to disclose any known or reasonably estimable information about the possible impact that the application of Australian Accounting Standards on issue which have not been applied, including a discussion of the impact that initial application will have on the entity's financial statements.

ASIC, together with other global regulators, has previously strongly emphasised the need for publicly accountable entities to fully comply with these requirements in light of significant changes in accounting pronouncements. See section B1.4.4 for ASIC's view on disclosures in relation to AASB 17 *Insurance Contracts*.

Entities need to ensure that they comply with the requirements of AASB 108 and respond to regulatory expectations.



Australian-specific illustrative examples of the disclosures can be found in Appendix 2 in Note 2 (starting on page 260).

B2.1.3 Early adoption

Where early adoption is being contemplated, it is important to address any necessary procedural requirements, e.g. for entities reporting under the Corporations Act, appropriate directors' resolutions for early adoption must be made under s.334(5).

B2.8 IFRS Interpretations Committee agenda decisions

Along with its activity developing formal interpretations of IFRS and proposing that the IASB make amendments to Standards, the IFRS Interpretations Committee regularly publishes summaries of issues that it has decided not to add to its agenda, often accompanied by a discussion of the accounting issue submitted.

Whilst the commentary included in an agenda decision is not formally part of IFRS, it is an important source of guidance that should be carefully considered when selecting a suitable accounting policy. In many jurisdictions there is an expectation from regulators that agenda decisions will be considered, with the European Securities and Markets Authority (ESMA), for example, publicly stating an expectation to this effect. In Australia, the AASB has indicated that an entity is required to apply the Standards, reflecting the explanatory material in a relevant agenda decision.

The table below outlines the agenda decisions published by the Committee since July 2021, grouped by the standards to which they relate. Where a decision relates to more than one standard, it is listed under each standard. Links in the table are to the IASB website. Using the core model financial statements for Tier 1 entities

Purpose

The Deloitte model IFRS financial statements contained in the core model financial statements section of this document illustrate the presentation and disclosure requirements of IFRS Accounting Standards for the year ended 31 December 2022 by an entity that is not a first-time adopter of IFRS Accounting Standards and are also applicable for the ended 31 December 2022. They comprise consolidated financial statements which illustrate the impact of the application of IFRS Accounting Standards that are mandatorily effective for the annual period beginning on 1 January 2022.

The core model financial statements, however, do not illustrate the presentation and disclosure requirements specific to annual reports prepared in Australia. Therefore, Appendix 2 to the model financial statements has been designed by Deloitte Australia to assist users with the preparation of annual reports in Australia in accordance with:

- Provisions of the *Corporations Act 2001*
- Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board
- Other requirements and guidelines current as at the date of issue, including ASX Listing Rules, ASIC Class Orders/Corporations Instruments, Regulatory Guides and Media Releases.

Commentary:**One statement vs. two statements**

IAS 1 Presentation of Financial Statements permits an entity to present profit or loss and other comprehensive income (OCI) in either a single statement or in two separate but consecutive statements. The alternative above illustrates the presentation of profit or loss and OCI in two separate but consecutive statements with expenses analysed by function. The alternative presented on the following pages illustrates the presentation of profit or loss and OCI in one statement with expenses analysed by nature.

Whichever presentation approach is adopted, the distinction is retained between items recognised in profit or loss and items recognised in OCI. Under both approaches, profit or loss, total OCI, as well as comprehensive income for the period (being the total of profit or loss and OCI) should be presented. Under the two-statement approach, the separate statement of profit or loss ends at 'profit for the year', and this 'profit for the year' is then the starting point for the statement of comprehensive income. In addition, the analysis of 'profit for the year' between the amount attributable to the owners of the Company and the amount attributable to non-controlling interests is presented as part of the separate statement of profit or loss.

Note that where the two-statement approach is adopted (as above), as required by IAS 1:10A, the statement of profit or loss must be displayed immediately before the statement of comprehensive income.

Commentary:**OCI: items that may or may not be reclassified**

Irrespective of whether the one-statement or the two-statement approach is followed, the items of OCI should be classified by nature and grouped into those that, in accordance with other IFRS Accounting Standards: (a) will not be reclassified subsequently to profit or loss; and (b) may be reclassified subsequently to profit or loss when specific conditions are met. An entity should present its share of OCI of associates and joint ventures accounted for using the equity method separately from those arising from the Group.

Presentation options for reclassification adjustments

In addition, in accordance with IAS 1:94, an entity may present reclassification adjustments in the statement of profit or loss and other comprehensive income or in the notes. In these model financial statements the reclassification adjustments have been presented in the notes.

Presentation options for income tax relating to items of OCI

Furthermore, for items of OCI, additional presentation options are available as follows: the individual items of OCI may be presented net of tax in the statement of profit or loss and other comprehensive income, or they may be presented gross with a single line deduction for tax relating to those items by allocating the tax between the items that may be reclassified subsequently to the profit or loss section and those that will not be reclassified subsequently to profit or loss section as presented in these model financial statements. Whichever option is selected, the income tax relating to each item of OCI must be disclosed, either in the statement of profit or loss and other comprehensive income or in the notes (see note 13).

Subtotals

When an entity presents subtotals, IAS 1:85A requires that those subtotals:

- *Comprise of line items made up of amounts recognised and measured in accordance with IFRS Accounting Standards*
- *Be presented and labelled in a manner that makes the line items that constitute the subtotal clear and understandable*
- *Be consistent from period to period*
- *Not be displayed with more prominence than the subtotals and totals required in IFRS Accounting Standards*

Immaterial items

An entity need not provide a specific disclosure required by an IFRS Accounting Standard if the information resulting from that disclosure is not material. This is the case even if the IFRS Accounting Standard contains a list of specific requirements or describes them as minimum requirements.

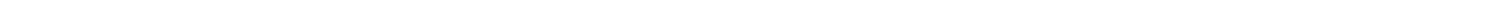

New and amended IFRS Accounting Standards that are effective for the current year

In these Model Financial Statements, it is assumed that International GAAP Holdings Limited early *adopted Covid-19-Related Rent Concessions beyond 30 June 2021 (Amendment to IFRS 16)* in the prior year.

In the current year, the Group has applied a number of amendments to IFRS Accounting Standards issued by the International Accounting Standards Board (IASB) that are mandatorily effective for an accounting period that begins on or after 1 January 2022. Their adoption has not had any material impact on the disclosures or on the amounts reported in these financial statements.

Amendments to IFRS 3 *Reference to the Conceptual Framework*

The Group has adopted the amendments to IFRS 3 *Business Combinations* for the first time in the current year. The amendments update IFRS 3 so that it refers to the 2018 *Conceptual Framework* instead of the 1989 *Framework*. They also add to IFRS 3 a requirement that, for obligations within the scope of IAS 37 *Provisions, Contingent Liabilities and Contingent Assets*, an acquirer applies IAS 37 to determine whether at the acquisition date a present obligation exists as a result of past events. For a levy that would be within the scope of IFRIC 21 *Levies*, the acquirer applies IFRIC 21 to determine whether the obligating event that gives rise to a liability to pay the levy has occurred by the acquisition date.

Amendments to IAS 16 *Property, Plant and Equipment—Proceeds before Intended Use*

The Group has adopted the amendments to IAS 16 *Property, Plant and Equipment* for the first time in the current year. The amendments prohibit deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced before that asset is available for use, i.e. proceeds while bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Consequently, an entity recognises such sales proceeds and related costs in profit or loss. The entity measures the cost of those items in accordance with IAS 2 *Inventories*.

The amendments also clarify the meaning of 'testing whether an asset is functioning properly'. IAS 16 now specifies this as assessing whether the technical and physical performance of the asset is such that it is capable of being used in the production or supply of goods or services, for rental to others, or for administrative purposes.

If not presented separately in the statement of comprehensive income, the financial statements shall disclose the amounts of proceeds and cost included in profit or loss that relate to items produced that are not an output of the entity's ordinary activities, and which line item(s) in the statement of comprehensive income include(s) such proceeds and cost.

Amendments to IAS 37 *Onerous Contracts—Cost of Fulfilling a Contract*

The Group has adopted the amendments to IAS 37 for the first time in the current year. The amendments specify that the cost of fulfilling a contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract consist of both the incremental costs of fulfilling that contract (examples would be direct labour or materials) and an allocation of other costs that relate directly to fulfilling contracts (an example would be the allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract).

In June 2020, the IASB issued *Amendments to IFRS 17* to address concerns and implementation challenges that were identified after IFRS 17 was published. The amendments defer the date of initial application of IFRS 17 (incorporating the amendments) to annual reporting periods beginning on or after 1 January 2023. At the same time, the IASB issued *Extension of the Temporary Exemption from Applying IFRS 9 (Amendments to IFRS 4)* that extends the fixed expiry date of the temporary exemption from applying IFRS 9 in IFRS 4 to annual reporting periods beginning on or after 1 January 2023.

In December 2021, the IASB issued *Initial Application of IFRS 17 and IFRS 9—Comparative Information (Amendment to IFRS 17)* to address implementation challenges that were identified after IFRS 17 was published. The amendment addresses challenges in the presentation of comparative information.

IFRS 17 must be applied retrospectively unless impracticable, in which case the modified retrospective approach or the fair value approach is applied.

For the purpose of the transition requirements, the date of initial application is the start of the annual reporting period in which the entity first applies the Standard, and the transition date is the beginning of the period immediately preceding the date of initial application.

Commentary:

In May 2022, ESMA issued a Public Statement on the implementation of IFRS 17 Insurance Contracts to promote its consistent application and high-quality implementation by issuers. Given the expected impact and importance of IFRS 17 specifically for insurance undertakings and financial conglomerates, ESMA highlights the need for issuers to provide relevant and comparable information in their financial statements that enables users to assess the possible impact that IFRS 17 will have in the period of initial application.

ESMA notes that the annual financial statements for 2022 will be published after IFRS 17 becomes effective. Consequently, ESMA expects that the 2022 annual financial statements provide the quantitative impact of the application of IFRS 17 and explain the changes compared to the amounts reported under IFRS 4, disaggregated as appropriate.

The quantification of the impacts may include (but is not limited to) the expected impact on issuer's equity and the size of the contractual service margin at the transition date of 1 January 2022 and at the initial application date of 1 January 2023 as well as profit or loss for the comparative period 2022.

For the purpose of the 2022 annual financial statements, ESMA recommends that issuers incorporate the considerations in paragraphs 18-22 of the Public Statement.

Amendments to IFRS 10 Consolidated Financial Statements and IAS 28 Investments in Associates and Joint Ventures—Sale or Contribution of Assets between an Investor and its Associate or Joint Venture

The amendments to IFRS 10 and IAS 28 deal with situations where there is a sale or contribution of assets between an investor and its associate or joint venture. Specifically, the amendments state that gains or losses resulting from the loss of control of a subsidiary that does not contain a business in a transaction with an associate or a joint venture that is accounted for using the equity method, are recognised in the parent's profit or loss only to the extent of the unrelated investors' interests in that associate or joint venture. Similarly, gains and losses resulting from the remeasurement of investments retained in any former subsidiary (that has become an associate or a joint venture that is accounted for using the equity method) to fair value are recognised in the former parent's profit or loss only to the extent of the unrelated investors' interests in the new associate or joint venture.

The effective date of the amendments has yet to be set by the IASB; however, earlier application of the amendments is permitted. The directors of the Company anticipate that the application of these amendments may have an impact on the Group's consolidated financial statements in future periods should such transactions arise.

Amendments to IAS 1 Presentation of Financial Statements—Classification of Liabilities as Current or Non-current

The amendments to IAS 1 published in January 2020 affect only the presentation of liabilities as current or non-current in the statement of financial position and not the amount or timing of recognition of any asset, liability, income or expenses, or the information disclosed about those items.

The amendments clarify that the classification of liabilities as current or non-current is based on rights that are in existence at the end of the reporting period, specify that classification is unaffected by expectations about whether an entity will exercise its right to defer settlement of a liability, explain that rights are in existence if covenants are complied with at the end of the reporting period, and introduce a definition of 'settlement' to make clear that settlement refers to the transfer to the counterparty of cash, equity instruments, other assets or services.

The amendments are applied retrospectively for annual periods beginning on or after 1 January 2023, with early application permitted. The IASB is currently considering further amendments to the requirements in IAS 1 on classification of liabilities as current or non-current, including deferring the application of the January 2020 amendments.

The directors of the Company anticipate that the application of these amendments may have an impact on the Group's consolidated financial statements in future periods..

Amendments to IAS 1 Presentation of Financial Statements and IFRS Practice Statement 2 Making Materiality Judgements—Disclosure of Accounting Policies

The amendments change the requirements in IAS 1 with regard to disclosure of accounting policies. The amendments replace all instances of the term 'significant accounting policies' with 'material accounting policy information'. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The supporting paragraphs in IAS 1 are also amended to clarify that accounting policy information that relates to immaterial transactions, other events or conditions is immaterial and need not be disclosed. Accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material.

The IASB has also developed guidance and examples to explain and demonstrate the application of the 'four-step materiality process' described in IFRS Practice Statement 2.

The amendments to IAS 1 are effective for annual periods beginning on or after 1 January 2023, with earlier application permitted and are applied prospectively. The amendments to IFRS Practice Statement 2 do not contain an effective date or transition requirements.

Amendments to IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors—Definition of Accounting Estimates

The amendments replace the definition of a change in accounting estimates with a definition of accounting estimates. Under the new definition, accounting estimates are "monetary amounts in financial statements that are subject to measurement uncertainty".

The definition of a change in accounting estimates was deleted. However, the IASB retained the concept of changes in accounting estimates in the Standard with the following clarifications:

- A change in accounting estimate that results from new information or new developments is not the correction of an error
- The effects of a change in an input or a measurement technique used to develop an accounting estimate are changes in accounting estimates if they do not result from the correction of prior period errors

The IASB added two examples (Examples 4-5) to the Guidance on implementing IAS 8, which accompanies the Standard. The IASB has deleted one example (Example 3) as it could cause confusion in light of the amendments.

The amendments are effective for annual periods beginning on or after 1 January 2023 to changes in accounting policies and changes in accounting estimates that occur on or after the beginning of that period, with earlier application permitted.

Amendments to IAS 12 Income Taxes—Deferred Tax related to Assets and Liabilities arising from a Single Transaction

The amendments introduce a further exception from the initial recognition exemption. Under the amendments, an entity does not apply the initial recognition exemption for transactions that give rise to equal taxable and deductible temporary differences.

Depending on the applicable tax law, equal taxable and deductible temporary differences may arise on initial recognition of an asset and liability in a transaction that is not a business combination and affects neither accounting nor taxable profit. For example, this may arise upon recognition of a lease liability and the corresponding right-of-use asset applying IFRS 16 at the commencement date of a lease.

Following the amendments to IAS 12, an entity is required to recognise the related deferred tax asset and liability, with the recognition of any deferred tax asset being subject to the recoverability criteria in IAS 12.

The IASB also adds an illustrative example to IAS 12 that explains how the amendments are applied.

The amendments apply to transactions that occur on or after the beginning of the earliest comparative period presented. In addition, at the beginning of the earliest comparative period an entity recognises:

- A deferred tax asset (to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised) and a deferred tax liability for all deductible and taxable temporary differences associated with:
 - Right-of-use assets and lease liabilities
 - Decommissioning, restoration and similar liabilities and the corresponding amounts recognised as part of the cost of the related asset
- The cumulative effect of initially applying the amendments as an adjustment to the opening balance of retained earnings (or other component of equity, as appropriate) at that date


The amendments are effective for annual reporting periods beginning on or after 1 January 2023, with earlier application permitted.

The directors of the Company anticipate that the application of these amendments may have an impact on the Group's consolidated financial statements in future periods should such transactions arise.

Commentary:

IAS 8:30 requires entities to give known or reasonably estimable information relevant to assessing the possible impact that the application of any new or revised IFRS Accounting Standard will have on the entity's financial statements in the period of initial application. The regulatory requirements in the various jurisdictions may differ as to how detailed the disclosures need to be; some regulators may require both qualitative and quantitative information to be disclosed whereas others may consider that qualitative information (e.g. key areas that may be affected by the new or revised IFRS Accounting Standard) suffices in many circumstances. For this reason, relevant regulatory guidance should also be taken into account in preparing the disclosure.

This applies to all new or revised IFRS Accounting Standards that have been issued but are not yet effective.

The financial statements have been prepared on the historical cost basis, except for the revaluation of certain properties and financial instruments that are measured at revalued amounts or fair values at the end of each reporting period, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of IFRS 2 *Share-based Payment*, leasing transactions that are within the scope of IFRS 16 *Leases*, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in IAS 2 *Inventories* or value in use in IAS 36 *Impairment of Assets*.

The principal accounting policies adopted are set out below.

Going concern

The directors have, at the time of approving the financial statements, a reasonable expectation that the Group have adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (its subsidiaries) made up to 31 December each year. Control is achieved when the Company:

- Has the power over the investee
- Is exposed, or has rights, to variable returns from its involvement with the investee
- Has the ability to use its power to affect its returns

The Company reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Company has less than a majority of the voting rights of an investee, it considers that it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Company considers all relevant facts and circumstances in assessing whether or not the Company's voting rights in an investee are sufficient to give it power, including:

- The size of the Company's holding of voting rights relative to the size and dispersion of holdings of the other vote holders
- Potential voting rights held by the Company, other vote holders or other parties
- Rights arising from other contractual arrangements
- Any additional facts and circumstances that indicate that the Company has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with corresponding adjustments against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the 'measurement period' (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Other contingent consideration is remeasured to fair value at subsequent reporting dates with changes in fair value recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held interests (including joint operations) in the acquired entity are remeasured to its acquisition-date fair value and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss, where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period (see above), or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed as of the acquisition date that, if known, would have affected the amounts recognised as of that date.



Goodwill

Goodwill is initially recognised and measured as set out above.

Goodwill is not amortised but is reviewed for impairment at least annually. For the purpose of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) expected to benefit from the synergies of the combination. Cash-generating units to which goodwill has been allocated are tested for impairment annually, or more frequently when there is an indication that the unit may be impaired. If the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit pro-rata on the basis of the carrying amount of each asset in the unit. An impairment loss recognised for goodwill is not reversed in a subsequent period.

On disposal of a cash-generating unit, the attributable amount of goodwill is included in the determination of the profit or loss on disposal.

The Group's policy for goodwill arising on the acquisition of an associate is described below.

Investments in associates and joint ventures

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor an interest in a joint venture. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of associates or joint ventures are incorporated in these financial statements using the equity method of accounting, except when the investment is classified as held for sale, in which case it is accounted for in accordance with IFRS 5.

Under the equity method, an investment in an associate or a joint venture is recognised initially in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture. When the Group's share of losses of an associate or a joint venture exceeds the Group's interest in that associate or joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate or joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture.

An investment in an associate or a joint venture is accounted for using the equity method from the date on which the investee becomes an associate or a joint venture. On acquisition of the investment in an associate or a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

If there is objective evidence that the Group's net investment in an associate or joint venture is impaired, the requirements of IAS 36 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with IAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with IAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate or a joint venture. When the Group retains an interest in the former associate or a joint venture and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with IFRS 9. The difference between the carrying amount of the associate or a joint venture at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing of a part interest in the associate or a joint venture is included in the determination of the gain or loss on disposal of the associate or joint venture. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate or joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the associate or joint venture is disposed of.

When the Group reduces its ownership interest in an associate or a joint venture but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a Group entity transacts with an associate or a joint venture of the Group, profits and losses resulting from the transactions with the associate or joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the associate or joint venture that are not related to the Group.

The Group applies IFRS 9, including the impairment requirements, to long-term interests in an associate or joint venture to which the equity method is not applied and which form part of the net investment in the investee. Furthermore, in applying IFRS 9 to long-term interests, the Group does not take into account adjustments to their carrying amount required by IAS 28 *Investments in Associates and Joint Ventures* (i.e. adjustments to the carrying amount of long-term interests arising from the allocation of losses of the investee or assessment of impairment in accordance with IAS 28).

Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

When a Group entity undertakes its activities under joint operations, the Group as a joint operator recognises in relation to its interest in a joint operation:

- Its assets, including its share of any assets held jointly
- Its liabilities, including its share of any liabilities incurred jointly
- Its revenue from the sale of its share of the output arising from the joint operation
- Its share of the revenue from the sale of the output by the joint operation
- Its expenses, including its share of any expenses incurred jointly

The Group accounts for the assets, liabilities, revenue and expenses relating to its interest in a joint operation in accordance with the IFRS Accounting Standards applicable to the particular assets, liabilities, revenue and expenses.

When a Group entity transacts with a joint operation in which a Group entity is a joint operator (such as a sale or contribution of assets), the Group is considered to be conducting the transaction with the other parties to the joint operation, and gains and losses resulting from the transactions are recognised in the Group's consolidated financial statements only to the extent of other parties' interests in the joint operation.

When a Group entity transacts with a joint operation in which a Group entity is a joint operator (such as a purchase of assets), the Group does not recognise its share of the gains and losses until it resells those assets to a third party.

Non-current assets held for sale

Non-current assets (and disposal groups) classified as held for sale are measured at the lower of carrying amount and fair value less costs to sell.

Non-current assets and disposal groups are classified as held for sale if their carrying amount will be recovered through a sale transaction rather than through continuing use. This condition is regarded as met only when the sale is highly probable and the asset (or disposal group) is available for immediate sale in its present condition. Management must be committed to the sale which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving loss of control of a subsidiary, all of the assets and liabilities of that subsidiary are classified as held for sale when the criteria described above are met, regardless of whether the Group will retain a non-controlling interest in its former subsidiary after the sale.

When the Group is committed to a sale plan involving disposal of an investment in an associate or, a portion of an investment in an associate, the investment, or the portion of the investment in the associate, that will be disposed of is classified as held for sale when the criteria described above are met. The Group then ceases to apply the equity method in relation to the portion that is classified as held for sale. To the extent that variable rate borrowings are used to finance a qualifying asset and are hedged in an effective cash flow hedge of interest rate risk, the effective portion of the derivative is recognised in other comprehensive income and reclassified to profit or loss when the qualifying asset affects profit or loss. To the extent that fixed rate borrowings are used to finance a qualifying asset and are hedged in an effective fair value hedge of interest rate risk, the capitalised borrowing costs reflect the hedged interest rate.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets (including property, plant and equipment) are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

The benefit of a government loan at a below-market rate of interest is treated as a government grant, measured as the difference between proceeds received and the fair value of the loan based on prevailing market interest rates.

Retirement and termination benefit costs

Payments to defined contribution retirement benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions. Payments made to state-managed retirement benefit plans are accounted for as payments to defined contribution plans where the Group's obligations under the plans are equivalent to those arising in a defined contribution retirement benefit plan.

For defined benefit retirement plans, the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Remeasurements comprising actuarial gains and losses, the effect of the asset ceiling (if applicable) and the return on plan assets (excluding interest) are recognised immediately in the statement of financial position with a charge or credit to other comprehensive income in the period in which they occur. Remeasurements recognised in other comprehensive income are not reclassified. Past service cost is recognised in profit or loss when the plan amendment or curtailment occurs, or when the Group recognises related restructuring costs or termination benefits, if earlier. Gains or losses on settlement of a defined benefit plan are recognised when the settlement occurs. Net interest is calculated by applying a discount rate to the net defined benefit liability or asset. Defined benefit costs are split into three categories:

- Service costs, which includes current service cost, past service cost and gains and losses on curtailments and settlements
- Net interest expense or income
- Remeasurements

The Group recognises service costs within profit or loss as cost of sales and administrative expenses (see note 58).

Net interest expense or income is recognised within finance costs (see note 11).

The retirement benefit obligation recognised in the consolidated statement of financial position represents the deficit or surplus in the Group's defined benefit plans. Any surplus resulting from this calculation is limited to the present value of any economic benefits available in the form of refunds from the plans or reductions in future contributions to the plans.

A liability for a termination benefit is recognised at the earlier of when the entity can no longer withdraw the offer of the termination benefit and when the entity recognises any related restructuring costs.

Discretionary contributions made by employees or third parties reduce service cost upon payment of these contributions to the plan.

When the formal terms of the plans specify that there will be contributions from employees or third parties, the accounting treatment depends on whether the contributions are linked to service, as follows:

- If the contributions are not linked to services (e.g. contributions are required to reduce a deficit arising from losses on plan assets or from actuarial losses), they are reflected in the remeasurement of the net defined benefit liability (asset)
- If contributions are linked to services, they reduce service costs. Taxation

The income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from net profit as reported in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

A provision is recognised for those matters for which the tax determination is uncertain but it is considered probable that there will be a future outflow of funds to a tax authority. The provisions are measured at the best estimate of the amount expected to become payable. The assessment is based on the judgement of tax professionals within the Company supported by previous experience in respect of such activities and in certain cases based on specialist independent tax advice.

*Deferred tax*

Deferred tax is the tax expected to be payable or recoverable on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit, and is accounted for using the liability method. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, a deferred tax liability is not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised based on tax laws and rates that have been enacted or substantively enacted at the reporting date.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax liabilities and deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. The directors reviewed the Group's investment property portfolios and concluded that none of the Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, the directors have determined that the 'sale' presumption set out in the amendments to IAS 12 is not rebutted. As a result, the Group has not recognised any deferred taxes on changes in fair value of the investment properties as the Group is not subject to any income taxes on the fair value changes of the investment properties on disposal.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

Current tax and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the amortised cost of a financial liability.

Financial guarantee contract liabilities

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payments when due in accordance with the terms of a debt instrument.

Financial guarantee contract liabilities are measured initially at their fair values and, if not designated as at FVTPL and do not arise from a transfer of an asset, are measured subsequently at the higher of:

- The amount of the loss allowance determined in accordance with IFRS 9 (see financial assets above)
- The amount recognised initially less, where appropriate, cumulative amortisation recognised in accordance with the revenue recognition policies set out above

Foreign exchange gains and losses

For financial liabilities that are denominated in a foreign currency and are measured at amortised cost at the end of each reporting period, the foreign exchange gains and losses are determined based on the amortised cost of the instruments. These foreign exchange gains and losses are recognised in the 'Other gains and losses' line item in profit or loss (note 10) for financial liabilities that are not part of a designated hedging relationship. For those which are designated as a hedging instrument for a hedge of foreign currency risk foreign exchange gains and losses are recognised in other comprehensive income and accumulated in a separate component of equity.

The fair value of financial liabilities denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of the reporting period. For financial liabilities that are measured as at FVTPL, the foreign exchange component forms part of the fair value gains or losses and is recognised in profit or loss for financial liabilities that are not part of a designated hedging relationship.

Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

When the Group exchanges with the existing lender one debt instrument into another one with substantially different terms, such exchange is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. Similarly, the Group accounts for substantial modification of terms of an existing liability or part of it as an extinguishment of the original financial liability and the recognition of a new liability. It is assumed that the terms are substantially different if the discounted present value of the cash flows under the new terms, including any fees paid net of any fees received and discounted using the original effective interest rate is at least 10 per cent different from the discounted present value of the remaining cash flows of the original financial liability. If the modification is not substantial, the difference between: (1) the carrying amount of the liability before the modification; and (2) the present value of the cash flows after modification is recognised in profit or loss as the modification gain or loss within other gains and losses.

Derivative financial instruments

The Group enters into a variety of derivative financial instruments to manage its exposure to interest rate and foreign exchange rate risks, including foreign exchange forward contracts, options and interest rate swaps. Derivatives are recognised initially at fair value at the date a derivative contract is entered into and are subsequently remeasured to their fair value at each reporting date. A derivative with a positive fair value is recognised as a financial asset whereas a derivative with a negative fair value is recognised as a financial liability. Derivatives are not offset in the financial statements unless the Group has both a legally enforceable right and intention to offset. A derivative is presented as a non-current asset or a non-current liability if the remaining maturity of the instrument is more than 12 months and it is not due to be realised or settled within 12 months. Embedded derivatives

An embedded derivative is a component of a hybrid contract that also includes a non-derivative host – with the effect that some of the cash flows of the combined instrument vary in a way similar to a stand-alone derivative.

Derivatives embedded in hybrid contracts with a financial asset host within the scope of IFRS 9 are not separated. The entire hybrid contract is classified and subsequently measured as either amortised cost or fair value as appropriate.

Derivatives embedded in hybrid contracts with hosts that are not financial assets within the scope of IFRS 9 (e.g. financial liabilities) are treated as separate derivatives when they meet the definition of a derivative, their risks and characteristics are not closely related to those of the host contracts and the host contracts are not measured at FVTPL.

If the hybrid contract is a quoted financial liability, instead of separating the embedded derivative, the Group generally designates the whole hybrid contract at FVTPL.

An embedded derivative is presented as a non-current asset or non-current liability if the remaining maturity of the hybrid instrument to which the embedded derivative relates is more than 12 months and is not expected to be realised or settled within 12 months.

Hedge accounting

The Group designates certain derivatives as hedging instruments in respect of foreign currency risk and interest rate risk in fair value hedges, cash flow hedges, or hedges of net investments in foreign operations. Hedges of foreign exchange risk on firm commitments are accounted for as cash flow hedges.

At the inception of the hedge relationship, the Group documents the relationship between the hedging instrument and the hedged item, along with its risk management objectives and its strategy for undertaking various hedge transactions. Furthermore, at the inception of the hedge and on an ongoing basis, the Group documents whether the hedging instrument is effective in offsetting changes in fair values or cash flows of the hedged item attributable to the hedged risk, which is when the hedging relationships meet all of the following hedge effectiveness requirements:

- There is an economic relationship between the hedged item and the hedging instrument
- The effect of credit risk does not dominate the value changes that result from that economic relationship
- The hedge ratio of the hedging relationship is the same as that resulting from the quantity of the hedged item that the Group actually hedges and the quantity of the hedging instrument that the Group actually uses to hedge that quantity of hedged item

If a hedging relationship ceases to meet the hedge effectiveness requirement relating to the hedge ratio but the risk management objective for that designated hedging relationship remains the same, the Group adjusts the hedge ratio of the hedging relationship (i.e. rebalances the hedge) so that it meets the qualifying criteria again.

The Group designates the full change in the fair value of a forward contract (i.e. including the forward elements) as the hedging instrument for all of its hedging relationships involving forward contracts.

The Group designates only the intrinsic value of option contracts as a hedged item, i.e. excluding the time value of the option. The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the reporting date, taking into account the risks and uncertainties surrounding the obligation. Where a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Restructurings

A restructuring provision is recognised when the Group has developed a detailed formal plan for the restructuring and has raised a valid expectation in those affected that it will carry out the restructuring by starting to implement the plan or announcing its main features to those affected by it. The measurement of a restructuring provision includes only the direct expenditures arising from the restructuring, which are those amounts that are both necessarily entailed by the restructuring and not associated with the ongoing activities of the entity.

Warranties

Provisions for the expected cost of warranty obligations under local sale of goods legislation are recognised at the date of sale of the relevant products, at the directors' best estimate of the expenditure required to settle the Group's obligation.

Onerous contracts

Present obligations arising under onerous contracts are recognised and measured as provisions. An onerous contract is considered to exist where the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received under it.

Restoration provisions

Provisions for the costs to restore leased plant assets to their original condition, as required by the terms and conditions of the lease, are recognised when the obligation is incurred, either at the commencement date or as a consequence of having used the underlying asset during a particular period of the lease, at the directors' best estimate of the expenditure that would be required to restore the assets. Estimates are regularly reviewed and adjusted as appropriate for new circumstances.

Contingent liabilities acquired in a business combination

Contingent liabilities acquired in a business combination are initially measured at fair value at the acquisition date. At the end of subsequent reporting periods, such contingent liabilities are measured at the higher of the amount that would be recognised in accordance with IAS 37 and the amount recognised initially less cumulative amount of income recognised in accordance with the principles of IFRS 15.

Own shares

Own shares represent the shares of the parent company International GAAP Holdings Limited that are held in treasury or by the employee benefit trust. Own shares are recorded at cost and deducted from equity.

Note 7 describes the expenditure required in the year for rectification work carried out on goods supplied to one of the Group's major customers. These goods were delivered to the customer in the months of __ to __ 2022, and shortly thereafter the defects were identified by the customer. Following negotiations, a schedule of works was agreed, which will involve expenditure by the Group until 2023. In the light of the problems identified, management was required to consider whether it was appropriate to recognise the revenue from these transactions of CU__ million in the current year, in line with the Group's general policy of recognising revenue when goods are delivered, or whether it was more appropriate to defer recognition until the rectification work was complete.

In making their judgement, the directors considered the detailed criteria for the recognition of revenue set out in IFRS 15 and, in particular, whether the Group had transferred control of the goods to the customer. Following the detailed quantification of the Group's liability in respect of rectification work, and the agreed limitation on the customer's ability to require further work or to require replacement of the goods, the directors are satisfied that control has been transferred and that recognition of the revenue in the current year is appropriate, in conjunction with the recognition of an appropriate warranty provision for the rectification costs.

Capitalisation of borrowing costs

As described in note 3, the Group capitalises borrowing costs directly attributable to the acquisition, construction or production of qualifying assets. Capitalisation of the borrowing costs relating to construction of the Group's premises in [A Land] was suspended in 2021, while the development was delayed as management reconsidered its detailed plans. Capitalisation of borrowing costs recommenced in 2022 – following the finalisation of revised plans, and the resumption of the activities necessary to prepare the asset for its intended use. Although construction of the premises was not restarted until May 2022, borrowing costs have been capitalised from February 2022, at which time the technical and administrative work associated with the project recommenced.

Judgement in identifying whether a contract includes a lease – Contract for the supply of sports shoes

The Group has entered into a contract with [Manufacturer A] for the supply of sports shoes for a three-year period. Each month the type of sports shoes and the production volume, up to a limit of [X] pairs, are determined by the Group and are not specified in the contract.

[Manufacturer A] has only one factory that can meet the needs of the Group and is unable to supply the sports shoes from another factory or source the sports shoes from a third party supplier. [Manufacturer A] makes all decisions about the operations of the factory, including the production level at which to run the factory and which customer contracts to fulfil with the output of the factory that is not used to fulfil the Group's contract for that month.

The directors of the Company assessed whether or not the Group has contracted for the rights to substantially all of the capacity of the factory and whether the contract with [Manufacturer A] contains a lease for the factory. After making inquiries based on forecast production volumes over the contract term the directors have established that [Manufacturer A] can regularly use the factory for other purposes during the course of the contract to supply other customers and therefore the Group does not have the right to obtain substantially all of the economic benefits from the use of the factory. As a result the directors concluded that the Group has not contracted for substantially all of the capacity of the factory, including the plant therein, and therefore the contract does not contain a lease.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

Taxation provisions

The Group's current tax provision of CU__ relates to management's assessment of the amount of tax payable on open tax positions where the liabilities remain to be agreed with [insert name of relevant Tax Authority]. Uncertain tax items for which a provision of CU__ is made, relate principally to the interpretation of tax legislation regarding arrangements entered into by the Group. Due to the uncertainty associated with such tax items, there is a possibility that, on conclusion of open tax matters at a future date, the final outcome may differ significantly. Whilst a range of outcomes is reasonably possible, the extent of the reasonably possible range is from additional liabilities of up to CU__ to a reduction in liabilities of up to CU__.

***Impairment testing***

Following the assessment of the recoverable amount of goodwill allocated to 'Leisure goods – retail outlets', to which goodwill of CU__ is allocated, the directors consider the recoverable amount of goodwill allocated to 'Leisure goods – retail outlets' to be most sensitive to the achievement of the 2023 budget. Budgets comprise forecasts of revenue, staff costs and overheads based on current and anticipated market conditions that have been considered and approved by the board. Whilst the Group is able to manage most of 'Leisure goods – retail outlets' costs, the revenue projections are inherently uncertain due to the short-term nature of the business and unstable market conditions. Revenue of the CGU is most sensitive to changes in the sectors demand for sales in retail outlets, reflecting the increased use of internet sales by rivals, a service which the Group does not currently offer.

The market for 'Leisure goods – retail outlets' products has seen a significant slowdown over the past 18 months due to a decline in the customer appetite for retail sales and increases in internet sales of rivals in the sector. It is possible that further underperformance may occur in 2023 if prevailing trends continue.

The sensitivity analysis in respect of the recoverable amount of 'Leisure goods – retail outlets' goodwill is presented in note 16.

***Calculation of loss allowance***

When measuring ECL the Group uses reasonable and supportable forward-looking information, which is based on assumptions for the future movement of different economic drivers and how these drivers will affect each other.

The determination of the Group's defined benefit obligation depends on certain assumptions, which include selection of the discount rate. The discount rate is set by reference to market yields at the end of the reporting period on high quality corporate bonds. Significant assumptions are required to be made when setting the criteria for bonds to be included in the population from which the yield curve is derived. The most significant criteria considered for the selection of bonds include the issue size of the corporate bonds, quality of the bonds and the identification of outliers which are excluded. These assumptions are considered to be a key source of estimation uncertainty as relatively small changes in the assumptions used may have a significant effect on the Group's financial statements within the next year. Further information on the carrying amounts of the Group's defined benefit obligation and the sensitivity of those amounts to changes in discount rate are provided in note 58.

Fair value measurements and valuation processes

Some of the Group's assets and liabilities are measured at fair value for financial reporting purposes. The board of directors of the Company has set up a valuation committee, which is headed up by the Chief Financial Officer of the Company, to determine the appropriate valuation techniques and inputs for fair value measurements.

In estimating the fair value of an asset or a liability, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Group engages third party qualified valuers to perform the valuation. The valuation committee works closely with the qualified external valuers to establish the appropriate valuation techniques and inputs to the model. The Chief Financial Officer reports the valuation committee's findings to the board of directors of the Company every quarter to explain the cause of fluctuations in the fair value of the assets and liabilities.

The valuations of private equity investments, contingent consideration in business combinations and non-derivative financial assets held for trading are particularly sensitive to changes in one or more unobservable inputs which are considered reasonably possible within the next financial year. Further information on the carrying amounts of these assets and the sensitivity of those amounts to changes in unobservable inputs are provided in note 62(a)(i).

Provision for restoration of contaminated land

On 15 December 2022, new legislation in [A Land] was enacted which resulted in the requirement for the Company to clean up historically contaminated waste sites in [A Land] and bear the costs thereof. Consequently, a provision of CU__ million has been recognised. In estimating the provision, the directors have made assumptions regarding the interpretation of the legislation and have estimated costs based on currently available information about the likely extent of contamination and potential clean-up techniques. Due to the associated uncertainty, it is possible that estimates may need to be revised during the next year as interpretations of the legislation evolve and the extent of contamination and potential approaches to clean-up are assessed in more detail. Whilst a range of outcomes is possible, the directors believe that the reasonably possible range is an increase in provisions of up to CU__ million to a reduction in provisions of up to CU__ million. Assessment as to whether the right-of-use assets are impaired

In January 2016, [Subsidiary D Limited], a subsidiary of the Group, entered into a 10-year lease for an office building located in [location]. Following the acquisition of [Acquisition A Limited] on [date] 2022 and the subsequent restructuring programme, the Group identified that the office space occupied by [Subsidiary E Limited], which is also located in [location], could accommodate all of the staff of [Subsidiary D Limited], and took the decision to relocate staff to a single office. The leased property previously occupied by [Subsidiary D Limited], has been marketed with a local estate agent and is expected to be sub-leased by the firm for the remainder of the lease term.

The directors have estimated that the entirety of the lease payment will be recoverable through the sub-lease of the property. This reflects the current achievable market rates for similar properties with similar lease terms and therefore no impairment has been recognised. The carrying amount of right-of-use asset in respect of the property is CU__ at 31 December 2022 (2021: CU__).

In estimating the recoverable amount of the right-of-use asset, the directors have made assumptions about the achievable market rates for similar properties with similar lease terms. Due to the associated uncertainty, it is possible that the estimates of the amount of lease payment that will be recovered through the sub-lease of the property may need to be revised during the next year. Achieving a sub-lease for only 95 per cent of the lease payment is considered reasonably possible based on recent experience in the market and would lead to an impairment charge of CU__ against the right-of-use asset in respect of the property.

The Group operates defined contribution retirement benefit plans for all qualifying employees of its construction and leasing divisions in [A Land]. The assets of the plans are held separately from those of the Group in funds under the control of trustees.

(c)(ii) Interest rate risk management

The Group is exposed to interest rate risk because entities in the Group borrow funds at both fixed and floating interest rates. The risk is managed by the Group by maintaining an appropriate mix between fixed and floating rate borrowings, and by the use of interest rate swap contracts. Hedging activities are evaluated regularly to align with interest rate views and defined risk appetite; ensuring the most cost-effective hedging strategies are applied.

The Group's exposures to interest rates on financial assets and financial liabilities are detailed in the liquidity risk management section of this note.

The Group is exposed to the following risk-free rates: [SOFR, EURIBOR, SONIA]. The exposures arise on derivatives and non-derivative financial assets and liabilities (e.g. bills of exchange, debt and leases).

Some of the Group cash flow and fair value hedge relationships were affected by the interest rate benchmark reform. All the affected hedged items and hedging instruments were either transitioned to risk-free rates or the contracts were amended to introduce fallback clauses which will change the basis for determining the interest cash flows from LIBOR to relevant RFR at an agreed point in time. Interest rate benchmark transition for non-derivative financial instruments

As discussed in note 32, the Group transitioned CU__ million of the 3-months USD LIBOR bank borrowings to SOFR.

For the Group's CU__ million lease liabilities linked to CU LIBOR maturing in 2025, the fallback clauses were incorporated in H1 2022.

During 2022, the Group has also transitioned its CU__ million of CU LIBOR investments in bills of exchange maturing between __ and __ to RFR. The Group accounted for the change to RFR using the practical expedient in IFRS 9 which allows the Group to change the basis for determining the contractual cash flows prospectively by revising the effective interest rate.

Interest rate benchmark transition for derivatives and hedge relationships

As it was discussed earlier, the Group has transitioned CU__ million of its bank borrowings to SOFR. These bank borrowings are hedged in a cash flow hedge using a 3-month USD LIBOR to fixed interest rate swap contract. During the first quarter of 2022 the Group entered into an equal but offsetting derivative against the original derivative and a new off-market derivative based on SOFR plus fixed spread on the same terms as the original derivative (i.e. the fair value on day one of the new SOFR derivative was the same as the original LIBOR derivative). This change was done as a direct consequence of the reform and on an economically equivalent basis. The Group changed the hedge documentation to include the new derivatives and amended the designated hedged risk to "variability in the cash flows of the bank borrowings resulting from changes in SOFR". The hedge relationship was not discontinued and the accumulated gain in the cash flow hedge reserve is deemed to be based on SOFR.

For Group's derivatives with nominal amount CU__ million that reference to 6-month LIBOR maturing in 2025 but were not designated in hedge relationships, the International Swaps and Derivatives Association's (ISDA) fallback clauses were made available in the first quarter of 2022 and the Group has signed up to the protocol, along with each of the Group's counterparties. This ensures all legacy trades will, on cessation of IBOR, follow the fallback clause provided in the protocol.

Business strategies and prospects for future financial years

Information on business strategies and prospects for future financial years should focus on what may affect the future financial performance and position of the entity. RG 247 outlines that the OFR should describe:

- The overall business strategies relevant to the entity's future financial position and performance
- The entity's prospects in terms of future financial performance and financial outcomes
- The material business risks that could adversely affect the achievement of the financial performance or financial outcomes described.

If an entity intends to rely on the unreasonable prejudice exemption in s.299A(3) to omit information, the basis for relying on the exemption needs to be carefully evaluated and established.

- Balanced and unambiguous
- Clear, concise and effective.

- An overview of the consolidated entity and its strategy
- A review of operations, considering both short and longer-term value creation in the context of the consolidated entity's strategy
- Information on investments made to enhance future value creating potential
- A review of the consolidated entity's financial condition
- An overview of risk management and governance practices.

This is aimed at anchoring the review in a strategic context of how the consolidated entity is aiming to enhance shareholder value, both in the short and long-term. This includes discussion of both financial and non-financial elements of performance, including analysis using relevant financial and non-financial key performance indicators. The latter may include sustainability related indicators. The recommended contents of the review include:

- Consolidated entity overview and strategy:
 - Explaining the objectives of the consolidated entity and how they are to be achieved
 - Including a discussion and analysis of key financial and non-financial performance indicators used by management in their assessment of the consolidated entity and its performance (including relevant sustainability performance indicators)
 - Discussing the main factors and influences that may have a major effect on future results (including potential longer-term effects), whether or not they were significant in the period under review. This may include discussion of market opportunities and risks; competitive advantage; changes in market share or position; economic factors; key customer and other relationships; employee skills and training; environmental, occupational health and safety aspects; significant legal issues; and innovation and technological developments

Source

- Review of operations:
 - Discussing the main activities of the consolidated entity, including significant features of operating performance for the period under review. It should cover all aspects of operations, focusing on the consolidated entity as a whole 'through the eyes of the directors'. It should not be boilerplate, and should cover significant aspects of the consolidated entity's performance in the period, financial and non-financial. Consideration should be given to unusual or infrequent events or transactions, including material acquisitions or disposals, major sources of revenues and expenses, and changes in factors which affect the results to enable users to assess the significance of the ongoing and core activities of the consolidated entity to identify the sustainability of performance over the longer-term
 - Providing the overall return attributable to shareholders in terms of dividends and increases in shareholders' funds, including a commentary on the comparison between the results of the financial year and dividends, both in total and in per share terms, and indicating the directors' overall distribution policy
- Providing information on investments made for future performance, including capital expenditure and other expenditure enhancing future performance potential. This may include marketing and advertising spend to enhance brand loyalty and reputation; staff training and development programmes; quality improvement and health and safety programs; customer relationship management; and expansion of production capacity
- Review of financial conditions:
 - Capital structure of the consolidated entity including capital funding and treasury policies and objectives
 - Cash from operations and other sources of capital
 - Discussion of the liquidity and funding at the end of the period under review, including restrictions on funds transfer, covenants entered into and the maturity profile of borrowings
 - Discussing the resources available to the consolidated entity not reflected in the statement of financial position, for example mineral reserves, key intellectual property (e.g. databases or specific entity competences); market-position; employee competences or resources/skills and their role in creating longer-term value

The payment holiday reduces payments in the period to [date] by \$__, and increases payments in the period to [date] by \$__. - Not-for-profit private sector lessees – The AASB has decided to retain the accounting policy choice in AASB 16 for the right-of-use assets of concessionary leases to initially be measured at cost or fair value on an ongoing basis, where this will be a permanent option with no plans to reconsider in future.
- Not-for-profit public sector lessees – The AASB has decided to defer consideration of the accounting policy choice until the Board decides on any additional guidance for measuring the fair value of right-of-use assets under concessionary leases.

The Group has conducted a high-level analysis of upfront fees received and note that upfront fees are accounted for appropriately in accordance with AASB 15. The Group currently measures the right-of-use assets arising from concessionary leases at cost on initial recognition and will continue to do so in the future given the accounting policy choice has been made permanent by the AASB. Accordingly, the directors of the Company do not anticipate that the application of the Standard in the future will have an impact on the Group's consolidated financial statements.

The Standard outlines a general model, which is modified for insurance contracts with direct participation features, described as the variable fee approach. The general model is simplified if certain criteria are met by measuring the liability for remaining coverage using the premium allocation approach.

The general model uses current assumptions to estimate the amount, timing and uncertainty of future cash flows and it explicitly measures the cost of that uncertainty. It takes into account market interest rates and the impact of policyholders' options and guarantees.

During 2020, the AASB issued amendments to AASB 17 to address concerns and implementation challenges that were identified after AASB 17 was published. The amendments defer the date of initial application of AASB 17 (incorporating the amendments) to annual reporting periods beginning on or after 1 January 2023. The amendments also extend the fixed expiry date of the temporary exemption from applying AASB 9 Financial Instruments in AASB 4 Insurance Contracts to annual reporting periods beginning on or after 1 January 2023.

In March 2022, the AASB issued AASB 2022-1 Amendments to Australian Accounting Standards – Initial Application of AASB 17 and AASB 9 – Comparative Information to address implementation challenges that were identified after AASB 17 was published. The amendment addresses challenges in the presentation of comparative information.

AASB 17 must be applied retrospectively unless impracticable, in which case the modified retrospective approach or the fair value approach is applied.

For the purpose of the transition requirements, the date of initial application is the start of the annual reporting period in which the entity first applies the Standard, and the transition date is the beginning of the period immediately preceding the date of initial application.

The Group does not issue insurance contracts. Therefore AASB 17 is not applicable to the Group and will not impact the Group's consolidated financial statements.

Similarly, gains and losses resulting from the remeasurement of investments retained in any former subsidiary (that has become an associate or a joint venture that is accounted for using the equity method) to fair value are recognised in the former parent's profit or loss only to the extent of the unrelated investors' interests in the new associate or joint venture.

The effective date of the amendments was amended by AASB 2015-10, AASB 2017-5 and AASB 2021-7 and now applies for annual reporting periods beginning on or after 1 January 2025 (however the editorial corrections in AASB 2017-5 applied for annual reporting periods beginning on or after 1 January 2018. Further, the editorial corrections in AASB 2021-7 are effective for either annual periods beginning on or after 1 January 2023 (those in respect of AASB 17 *Insurance Contracts*) or 1 January 2022.

Except for the editorial corrections, the directors of the Company anticipate that the application of these amendments may have an impact on the Group's consolidated financial statements in future periods should such transactions arise.

Amends AASB 112 *Income Taxes* to specify how companies should account for deferred tax on transactions such as leases and decommissioning obligations.

In specified circumstances, companies are exempt from recognising deferred tax when they recognise assets or liabilities for the first time (the 'initial recognition exception'). The amendments clarify that the initial recognition exception does not apply to transactions where both an asset and a liability are recognised in a single transaction. Accordingly, deferred tax is required to be recognised on such transactions.

The Group currently accounts for deferred taxes arising from leases, decommissioning liabilities and similar items in respect of the transaction as a whole. For example, in respect of leases, the entity seeks to reflect the linkage between the right-of-use asset and the lease liability and recognise deferred tax on an aggregate temporary difference basis. On application of the amendments, deferred tax amounts will instead be recognised in respect of each separate part of the overall transaction, e.g. in respect of each of the right-of-use asset and lease liability. The directors have not finalised the assessment of the impact of this change in accounting policy, but expect that the total impact on net assets will not be material.

The amendments apply to annual reporting periods beginning on or after 1 January 2023.

Lease Liability in a Sale and Leaseback (Amendments to IFRS 16)

AASB 1054:17

Amends IFRS 16 *Leases* by adding subsequent measurement requirements for sale and leaseback transactions that satisfy the requirements in IFRS 15 *Revenue from Contracts with Customers* to be accounted for as a sale. The amendments require the seller-lessee to determine 'lease payments' or 'revised lease payments' such that the seller-lessee does not recognise a gain or loss that relates to the right of use retained by the seller-lessee, after the commencement date. The amendments do not affect the gain or loss recognised by the seller-lessee relating to the partial or full termination of a lease.

Without these new requirements, a seller-lessee may have recognised a gain on the right of use it retains solely because of a remeasurement of the lease liability (for example, following a lease modification or change in the lease term) applying the general requirements in IFRS 16. This could have been particularly the case in a leaseback that includes variable lease payments that do not depend on an index or rate.

The Group currently does not have sale-and-leaseback arrangements. The directors of the Company do not anticipate that the application of the amendments in the future will have a material impact on the Group's consolidated financial statements.

The amendments apply to annual reporting periods beginning on or after 1 January 2024.

2.3 Other changes in accounting policies

Change in accounting policy – Net realisable value of inventories⁴⁶

AASB 108:28

The IFRS Interpretations Committee (IFRIC) has issued an agenda decision related to the costs an entity includes as the 'estimated costs necessary to make the sale' when determining the net realisable value of inventories.

When determining the net realisable value of inventories, AASB 102 *Inventories* requires an entity to estimate the costs necessary to make the sale. The IFRIC agenda decision states that this requirement does not allow an entity to limit such costs to only those that are incremental, thereby potentially excluding costs the entity must incur to sell its inventories but which are not incremental to a particular sale. Including only incremental costs could fail to achieve the objective set out AASB 102:28.

Therefore, when determining the net realisable value of inventories, an entity estimates the costs necessary to make the sale in the ordinary course of business. An entity uses its judgement to determine which costs are necessary to make the sale considering its specific facts and circumstances, including the nature of the inventories.

The Group has implemented this guidance retrospectively as a change in accounting policy. Previously, the Group [*limited the costs* necessary to make the sale when determining the net realisable value of inventories to only those that are incremental / *explain previous accounting policy*].

Historical financial information has been restated to account for the impact of the change in accounting policy, as below. The impact of the change in accounting policy on both basic and diluted earnings per share is presented in note 15.

During the year, the Company revised its accounting policy in relation to the costs an entity includes as the 'estimated costs necessary to make the sale' when determining the net realisable value of inventories. This is in response to the IFRIC agenda decision which clarifies that such costs are not limited to only those that are incremental. The new accounting policy is presented below. Historical financial information has been restated to account for the impact of the change (refer Note 2.3).

AASB 2:36(a)

Inventories are stated at the lower of cost and net realisable value. Cost comprises direct materials and, where applicable, direct labour costs and those overheads that have been incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted average cost method. Net realisable value represents the estimated selling price less all estimated costs of completion and all costs to be incurred in marketing, selling and distribution.

Example accounting policies for mining entities

The following example accounting policies may be relevant for entities operating in the resources industry. Entities will need to edit and adapt the accounting policies below to reflect their entity's policies and circumstances:

Provision for restoration and rehabilitation

A provision for restoration and rehabilitation is recognised when there is a present obligation as a result of *[exploration, development, production, transportation or storage]* activities undertaken, it is probable that an outflow of economic benefits will be required to settle the obligation, and the amount of the provision can be measured reliably. The estimated future obligations include the costs of *[removing facilities, abandoning sites/wells and restoring the affected areas]*.

The provision for future restoration costs is the best estimate of the present value of the expenditure required to settle the restoration obligation at the reporting date, *[based on current legal and other requirements and technology]*. Future restoration costs are reviewed annually and any changes in the estimate are reflected in the present value of the restoration provision at each reporting date.

The initial estimate of the restoration and rehabilitation provision relating to *[exploration, development and milling/production facilities]* is capitalised into the cost of the related asset and *[depreciated/amortised]* on the same basis as the related asset, unless the present obligation arises from the production of inventory in the period, in which case the amount is included in the cost of production for the period. Changes in the estimate of the provision for restoration and rehabilitation are treated in the same manner, except that the unwinding of the effect of discounting on the provision is recognised as a finance cost rather than being capitalised into the cost of the related asset.

Exploration and evaluation

The following example accounting policy assumes that an entity has adopted an 'area of interest' approach towards the capitalisation of exploration and evaluation, as is suggested by paragraph Aus7.2 of AASB 6 *Exploration for and Evaluation of Mineral Resources*. Where other approaches are adopted, the following wording will need to be edited as appropriate:

Exploration and evaluation expenditures in relation to each separate area of interest are recognised as an exploration and evaluation asset in the year in which they are incurred where the following conditions are satisfied:

- The rights to tenure of the area of interest are current
- At least one of the following conditions is also met:
 - The exploration and evaluation expenditures are expected to be recouped through successful development and exploration of the area of interest, or alternatively, by its sale, or
 - Exploration and evaluation activities in the area of interest have not, at the reporting date, reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves, and active and significant operations in, or in relation to, the area of interest are continuing.

Exploration and evaluation assets are initially measured at cost and include acquisition of rights to explore, studies, exploratory drilling, trenching and sampling and associated activities and an allocation of depreciation and amortisation of assets used in exploration and evaluation activities. General and administrative costs are only included in the measurement of exploration and evaluation costs where they are related directly to operational activities in a particular area of interest.

Exploration and evaluation assets are assessed for impairment when facts and circumstances suggest that the carrying amount of an exploration and evaluation asset may exceed its recoverable amount. The recoverable amount of the exploration and evaluation asset (or the cash-generating unit(s) to which it has been allocated, being no larger than the relevant area of interest) is estimated to determine the extent of the impairment loss (if any). Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in previous years.

Where a decision is made to proceed with development in respect of a particular area of interest, the relevant exploration and evaluation asset is tested for impairment and the balance is then reclassified to [development].

Development

Development expenditure is recognised at cost less accumulated [amortisation/depletion] and any impairment losses. Where commercial production in an area of interest has commenced, the associated costs [together with any forecast future capital expenditure necessary to develop proved and probable reserves] are amortised over the estimated economic life of the [mine/field] on a units-of-production basis.

Changes in factors such as estimates of proved and probable reserves that affect unit-of-production calculations are dealt with on a prospective basis.

The following are examples of the types of disclosures that might be required in this area. The matters disclosed will be dictated by the circumstances of the individual entity, and by the significance of judgements and estimates made to the performance and financial position of the entity.

Instead of disclosing this information in a separate note, it may be more appropriate to include such disclosures in the relevant asset and liability notes, or as part of the relevant accounting policy disclosures.

The Group recognises income from its main revenue/income streams, as listed below:

- Government grants
- Donations and bequests
- Capital grants.

Government grants, donations and bequests

When the Group receives government grants, donations and bequests that are in the scope of AASB 1058 *Income of Not-for-Profit Entities* (being a transaction where the consideration paid to acquire an asset is significantly less than fair value principally to enable the Group to further its objectives), it performs an assessment to determine if the contract is 'enforceable' and contains 'sufficiently specific' performance obligations.

Where the consideration to acquire an asset is significantly less than fair value principally to enable the Group to further its objectives, the transaction is accounted for under AASB 1058 where the Group:

- Recognises the asset in accordance with the requirements of other relevant applicable Australian Accounting Standards (e.g. AASB 9 *Financial Instruments*, AASB 16 *Leases*, AASB 116 *Property, Plant and Equipment* and AASB 138 *Intangible Assets*)
- Considers whether any other financial statement elements should be recognised ('related amounts') in accordance with the relevant applicable Australian Accounting Standard including:
 - Contributions by owners (AASB 1004 *Contributions*)
 - A lease liability (AASB 16)
 - Revenue, or a contract liability arising from a contract with a customer (AASB 15 *Revenue from Contracts from Customers*)
 - A financial instrument (AASB 9)
 - A provision (AASB 137 *Provisions, Contingent Liabilities and Contingent Assets*)
- Recognises income immediately in profit or loss for the excess of the initial carrying amount of the asset over any related amounts recognised.

In cases where the consideration is solely performance obligations under an enforceable contract and sufficiently specific to enable determination as to when the obligations are satisfied, the transaction is accounted for under AASB 15.

Capital grants – Buildings

For capital grants received under an enforceable agreement where it includes a transfer to enable the Group to acquire or construct a recognisable non-financial asset to identified specifications which will be controlled by the Group when completed, the Group recognises a liability for the excess of the fair value of the transfer over any related amounts recognised and recognises income as it satisfies its obligations under the transfer.

As the capital grants received by the Group are primarily for the construction of buildings, the Group recognises income as the buildings are constructed (when it satisfies its obligations).

Unrecognised revenue**Volunteer services (*not-for-profit private sector entities only*)**

The Group regularly receives volunteer services as part of its operations. Under AASB 1058, private sector not-for-profit entities have a policy option to account for donated services at fair value if the fair value can be reliably measured.

While the Group has assessed that the fair value of its volunteer services can be reliably measured, it has decided to adopt the policy option not to recognise volunteer services. Accordingly, no amounts are recognised in the financial statements for volunteer services.

Donated inventories

As part of its operations, the Group receives donations of goods which may then be used in its activities. AASB 102 *Inventories* requires the donated inventories to be measured at current replacement cost and any related amounts to be accounted for under AASB 1058.

The Group has decided to make use of the practical expedient under AASB 102 *Inventories* and apply the materiality assessment at the individual item level (instead of the portfolio level) when recognising donated inventories. Based on an assessment, the Group has noted that it only receives individually immaterial donations of inventory and accordingly will not be required to recognise such donated inventories. Accordingly, no amounts are recognised in the financial statements for donated inventories.

Note regarding recent changes

In October 2021, the ASX published [Consultation Response Proposed changes to the oil and gas reporting requirements in the ASX Listing Rules](#), which outlines final rule changes in respect of reporting by oil and gas entities.

Chapter 5 of the ASX Listing Rules was previously drafted based on the 2007 edition of the Petroleum Resources Management System sponsored by the Society of Petroleum Engineers, the American Association of Petroleum Geologists, the World Petroleum Council and the Society of Petroleum Evaluation Engineers (commonly referred to as the 'SPE-PRMS'). The SPE-PRMS was revised in July 2018 and the final listing rule changes made by the ASX give effect to the revisions.

The revised Chapter 5 of the ASX Listing Rules came into effect on 1 July 2022.

Note: The information below reflects these changes to Chapter 5 of the ASX Listing Rules.

Annual reporting

ASX-LR 5.37

An oil and gas exploration entity must include in its annual report:

- The petroleum tenements held by the oil and gas exploration entity and its child entities and their locations
- The percentage interest it or they held in each petroleum tenement.

ASX-LR 5.38

An oil and gas entity that reports to the Securities and Exchange Commission of the United States of America (SEC) and files an SEC Form 10-K or 20-F Report with a US oil and gas reserves statement is not required to comply with the annual reserves statement requirements under ASX Listing Rule 5.39. In such a case, immediately after filing any such form or report with the SEC, the oil and gas entity must give a copy of the form or report to ASX for release to the market.

ASX-LR 5.39

Except where the above exception applies, an oil and gas entity must include a reserves statement in its annual report including the following information:

- As at the oil and gas entity's end of financial year balance date, the oil and gas entity's petroleum reserves holdings in tabular form reporting on the basis of total '1P' petroleum reserves and '2P' petroleum reserves (split between developed and undeveloped reserves by product) and by total aggregated '1P' and '2P' reserves by product and geographical area (split between developed and undeveloped petroleum reserves by geographical area)
- If the oil and gas entity has material unconventional petroleum resources, separate identification of the proportion of total '1P' and '2P' reserves that are based on unconventional petroleum resources
- A reconciliation of the oil and gas entity's petroleum reserves holdings against that from the previous year, including an explanation of any material changes from the previous year
- Specific information about any material concentrations of undeveloped petroleum reserves in material oil and gas projects which have remained undeveloped after 5 years from the date they were initially reported (including any work the entity is proposing to undertake towards development of the undeveloped petroleum reserves)
- A summary of the governance arrangements and internal control that the oil and gas entity has put in place, including the frequency and scope of any reviews or audits undertaken with respect to its estimates of petroleum reserves and the estimation process.

Estimates of petroleum reserves in the reserves statement in the annual report must be reported in appropriate units for each individual product type reported. If estimates are also reported in units of equivalency, either of oil or gas, the entity must disclose in the report the conversion factor used.

ASX-LR 5.40

An oil and gas entity:

- That reports on oil and gas entity level or other aggregated estimates of contingent resources in its reserve statement in its annual report, must include in its reserves statement, or
- That is exempt from the requirement to include a reserves statement in its annual report but wishes to report on oil and gas entity level or other aggregated estimates of contingent resources, must include in its annual report or in a statement to be provided to the ASX for release to the market with its annual report, a statement that includes,

the following information:

- Total '2C' contingent resources by product
- Aggregated '2C' contingent resources by product and geographical area
- Estimates of contingent resources must be made in the appropriate resources must be made for each individual product type reported. If estimates are also reported in units of equivalency either of oil or gas, the entity must disclose in the report the conversion factor used
- A reconciliation of the oil and gas entity's total 2C contingent resources holdings against that from the previous year, including an explanation of any material changes in those holdings from the previous year
- If the oil and gas entity has material unconventional petroleum resources, it must separately identify the portion of the total 2C contingent resources that are based on unconventional petroleum resources.

For recently listed entities

In the first two annual financial reports after admission to the ASX, where an entity is admitted under ASX Listing Rule 1.3.2(b) or is required to comply with ASX Listing Rule 1.3.2(b) because of the application of ASX Listing Rule 11.1.3, the entity must state whether the entity used the cash and assets in a form readily convertible to cash that it had at the time of admission in a way consistent with its business objectives. If the use was not consistent, an explanation of how the cash and assets were used must be disclosed.

ASX Corporate Governance Principles and Recommendations

Corporate governance is a system of rules, practices, policies and processes by which a company is directed and controlled. It aims at balancing the interests of a company's stakeholders and furthermore, good corporate governance promotes investor confidence. The ASX Corporate Governance Principles and Recommendations ('Principles and Recommendations') set out recommended corporate governance practices for entities listed on the ASX.

The Principles and Recommendations are not mandatory. As a result if a listed entity considers that a recommended principles/recommendation is not appropriate for the entity to adopt, it is entitled not to adopt it. However, the entity must explain why it has not adopted the principle/recommendation – seen as the "if not, why not" approach.

Unlisted entities are not required to report against the Principles and Recommendations however, may choose to adopt the Principles and Recommendations.

The principles set out below are those outlined in the fourth edition of the [Corporate Governance Principles and Recommendations](#) which was issued in February 2019.

It is important that listed entities refer to the complete document when preparing their reports as they provide comprehensive and invaluable guidance in relation to implementation of the Principles and Recommendations. The recommendations of the ASX Corporate Governance Council, including corporate governance practices and suggested disclosures, are set out below. The recommendations are differentiated between the eight core principles that the ASX Corporate Governance Council believes underlie good corporate governance. Entities must disclose any instances of non-compliance with these recommendations.

Principle 1 – Lay solid foundations for management and oversight

- 1.1 A listed entity should have and disclose a board charter setting out:
- (a) The respective roles and responsibilities of its board and management
 - (b) Those matters expressly reserved to the board and those delegated to management.
- 1.2 A listed entity should:
- (a) Undertake appropriate checks before appointing a director or senior executive or putting someone forward for election as a director
 - (b) Provide security holders with all material information in its possession relevant to a decision on whether or not to elect or re-elect a director.
- 1.3 A listed entity should have a written agreement with each director and senior executive setting out the terms of their appointment.
- 1.4 The company secretary of a listed entity should be accountable directly to the board, through the chair, on all matters to do with the proper functioning of the board.
- 1.5 A listed entity should:
- (a) Have and disclose a diversity policy
 - (b) Through its board or committee of the board set measurable objectives for achieving gender diversity in the composition of its board, senior executives and workforce generally
 - (c) Disclose in relation to each reporting period:
 1. The measurable objectives set for that period to achieve gender diversity
 2. The entity's progress towards achieving those objectives
 3. Either:
 - a. The respective proportions of men and women on the board, in senior executive positions and across the whole workforce (including how the entity has defined 'senior executive' for these purposes), or
 - b. If the entity is a 'relevant employer' under the Workforce Gender Equality Act, the entity's most recent 'Gender Equality Indicators', as defined and published under that Act.
- If the entity was in the S&P/ASX 300 Index at the commencement of the reporting period, the measurable objective for achieving gender diversity in the composition of its board should be to have not less than 30% of its directors of each gender within a specified period.
- 1.6 A listed entity should:
- (a) Have and disclose a process for periodically evaluating the performance of the board, its committees and individual directors
 - (b) Disclose, for each reporting period, whether a performance evaluation has been undertaken in accordance with that process during or in respect of that period
- 1.7 A listed entity should:
- (a) Have and disclose a process for periodically evaluating the performance of its senior executives at least once each reporting period
 - (b) Disclose for each reporting period, whether a performance evaluation has been undertaken in accordance with that process during or in respect of that period.

Principle 2 - Structure the board to be effective and add value

- 2.1 The board of a listed entity should:
- (a) Have a nomination committee which:
 1. Has at least three members, a majority of whom are independent directors, and
 2. Is chaired by an independent director
 and disclose
 3. The charter or the committee
 4. The members of the committee
 5. As at the end of each reporting period, the number of times the committee met throughout the period and the individual attendances of the members at those meetings, or
 - (b) If it does not have a nomination committee, disclose that fact and the processes it employs to address board succession issues and to ensure that the board has the appropriate balance of skills, knowledge, experience, independence and diversity to enable it to discharge its duties and responsibilities effectively.
- 2.2 A listed entity should have and disclose a board skills matrix setting out the mix of skills and diversity that the board currently has or is looking to achieve in its membership.
- 2.3 A listed entity should disclose:
- (a) The names of the directors considered by the board to be independent directors
 - (b) If a director has an interest, position, association or relationship of the type described below but the board is of the opinion that it does not compromise the independence of the directors, the nature of the interest, position or relationship in question and an explanation of why the board is of that opinion:
 - The director is, or has been, employed in the executive capacity by the entity or any of its child entities and there has not been a period of at least three years between ceasing such employment and serving on the board
 - The director receives performance-based remuneration (including options or performance rights) from, or participates in an employee incentive scheme of the entity
 - The director is, or has been within the last three years, in a material business relationship (e.g. as a supplier, professional adviser, consultant or customer) with the entity or any of its child entities, or is an officer of, or otherwise associated with, someone with such a relationship
 - The director is, represents, or is or has been within the last three year an officer or employee of, or professional adviser to, a substantial holder
 - The director has close personal ties with any person who falls within any of the categories described above
 - The director has been a director of the entity for such a period that their independence from management and substantial holds may have been compromised.
 - (c) The length of service of each director.
- 2.4 A majority of the board of a listed entity should be independent directors.
- 2.5 The chair of the board of a listed entity should be an independent director and, in particular, should not be the same person as the CEO of the entity.
- 2.6 A listed entity should have a program for inducting new directors and for periodically reviewing whether there is a need for existing directors to undertake professional development to maintain the skills and knowledge needed to perform their role as directors effectively.

Principle 3 – Instil a culture of acting lawfully, ethically and responsibly

- 3.1 A listed entity should articulate and disclose its values
- 3.2 A listed entity should:
 - (a) Have and disclose a code of conduct for its directors, senior executives and employees
 - (b) Ensure that the board or a committee of the board is informed of any material breaches of that code.
- 3.3 A listed entity should:
 - (a) Have and disclose a whistleblower policy
 - (b) Ensure that the board or a committee of the board is informed of any material incidents reported under that policy
- 3.4 A listed entity should:
 - (a) Have and disclose an anti-bribery and corruption policy
 - (b) Ensure that the board or a committee of the board is informed of any material breaches of that policy.

Principle 4 - Safeguard the integrity of corporate reports

- 4.1 The board of a listed entity should:
 - (a) Have an audit committee which:
 - 1. Has at least three members, all of whom are non-executive directors and a majority of whom are independent directors, and
 - 2. Is chaired by an independent director, who is not the chair of the board
 and disclose:
 - 3. The charter of the committee
 - 4. The relevant qualifications and experience of the members of the committee
 - 5. In relation to each reporting period, the number of times the committee met throughout the period and the individual attendances of the members at those meetings, or
 - (b) If it does not have an audit committee, disclose that fact and the processes it employs that independently verify and safeguard the integrity of its corporate reporting, including the processes for the appointment and removal of the external auditor and the rotation of the audit engagement partner.
- 4.2 The board of a listed entity should, before it approves the entity's financial statements for a financial period, receive from its CEO and CFO a declaration that, in their opinion, the financial records of the entity have been properly maintained and that the financial statements comply with the appropriate accounting standards and give a true and fair view of the financial position and performance of the entity and that the opinion has been formed on the basis of a sound system of risk management and internal control which is operating effectively
- 4.3 A listed entity should disclose its process to verify the integrity of any periodic corporate report it releases to the market that is not audited or reviewed by an external auditor.

Principle 5 - Make timely and balanced disclosures

- 5.1 A listed entity should have and disclose a written policy for complying with its continuous disclosure obligations under listing rule 3.1
- 5.2 A listed entity should ensure that its board receives copies of all material market announcements promptly after they have been made.
- 5.3 A listed entity that gives a new and substantive investor or analyst presentation should release a copy of the presentation materials on the ASX Market Announcements Platform ahead of the presentation.

Principle 6 - Respect the rights of security holders

- 6.1 A listed entity should provide information about itself and its governance to investors via its website
- 6.2 A listed entity should have an investor relations program that facilitates effective two-way communication with investors.
- 6.3 A listed entity should disclose how it facilitates and encourages participation at meetings of security holders
- 6.4 A listed entity should ensure that all substantive resolutions at a meeting of security holders are decided by a poll rather than by a show of hands.
- 6.5 A listed entity should give security holders the option to receive communications from, and send communications to, the entity and its security registry electronically.

Principle 7 - Recognise and manage risk

- 7.1 The board of a listed entity should:
 - (a) Have a committee or committees to oversee risk, each of which:
 - 1. Has at least three members, a majority of whom are independent directors
 - 2. Is chaired by an independent director
 and disclose:
 - 3. The charter of the committee
 - 4. The members of the committee
 - 5. As at the end of each reporting period, the number of times the committee met throughout the period and the individual attendances of the members at those meetings, or
 - (b) If it does not have a risk committee or committees that satisfy (a) above, disclose that fact and the processes it employs for overseeing the entity's risk management framework.
- 7.2 The board or a committee of the board should:
 - (a) Review the entity's risk management framework at least annually to satisfy itself that it continues to be sound and that the entity is operating with the due regard to the risk appetite set by the board
 - (b) Disclose, in relation to each reporting period, whether such a review has taken place.
- 7.3 A listed entity should disclose:
 - (a) If it has an internal audit function, how the function is structured and what role it performs, or
 - (b) If it does not have an internal audit function, that fact and the processes it employs for evaluating and continually improving the effectiveness of its risk management and internal control processes
- 7.4 A listed entity should disclose whether it has any material exposure to environmental or social risks and, if it does, how it manages or intends to manage those risks.

Principle 8 - Remunerate fairly and responsibly

- 8.1 The board of a listed entity should:
 - (a) Have a remuneration committee which:
 - 1. Has at least three members, a majority of whom are independent directors, and
 - 2. Is chaired by an independent director
 and disclose:
 - 3. The charter of the committee
 - 4. The members of the committee
 - 5. As at the end of each reporting period, the number of times the committee met throughout the period and the individual attendances of the members at those meetings, or
 - (b) If it does not have a remuneration committee, disclose that fact and the processes it employs for setting the level and composition of remuneration for directors and senior executives and ensuring that such remuneration is appropriate and not excessive
- 8.2 A listed entity should separately disclose its policies and practices regarding the remuneration of non-executive directors and the remuneration of executive directors and other senior executives.
- 8.3 A listed entity which has an equity-based remuneration scheme should:

- Have a policy on whether participants are permitted to enter into transactions (whether through the use of derivatives or otherwise) which limit the economic risk of participating in the scheme
- Disclose that policy or a summary of it.

Additional recommendations that apply only in certain cases

- 9.1 A listed entity with a director who does not speak the language in which board or security holder meetings are held or key corporate documents are written should disclose the processes it has in place to ensure the director understands and can contribute to the discussions at those meetings and understands and can discharge their obligations in relation to those documents.
- 9.2 A listed entity established outside Australia should ensure that meetings of security holders are held at a reasonable place and time.
- 9.3 A listed entity established outside Australia, and an externally managed listed entity that has an AGM, should ensure that its external auditor attends its AGM and is available to answer questions from security holders relevant to the audit.

Externally managed listed entities

The current version of the Corporate Governance Principles and Recommendations includes additional guidance on the application of the recommendations to externally managed entities.

The following recommendations are those which do not apply:

1.1, 1.2, 1.3, 1.4, 1.5, 1.6, 1.7, 2.1, 2.2, 2.4, 2.5, 2.6, 8.1, 8.2, 8.3, 9.1 and 9.2.

The entity may simply state that these recommendations are “not applicable” in its corporate governance statement.

For the following recommendations the normal requirements do not apply, but in lieu of these requirements alternative recommendations apply:

1.1, 8.1, 8.2 and 8.3.

The recommendations and alternative recommendations listed below, apply to externally managed listed entities with specific guidance on application:

- Alternative recommendation 1.1 – The responsible entity of an externally managed listed entity should disclose (1) the arrangements between the responsible entity and the listed entity for managing the affairs of the listed entity and (2) the role and responsibility of the board of the responsible entity for overseeing those arrangements
- Alternative recommendation 8.1, 8.2 and 8.3 – An externally managed listed entity should clearly disclose the terms governing the remuneration of the manager.

Tax transparency report

Federal government proposals for mandatory tax transparency reporting

In August 2022, the Federal Government published a [consultation paper](#), *Multinational Tax Integrity and Tax Transparency*. Comments on the consultation paper closed on 2 September 2022. As part of the consultation, feedback was sought on whether legislating the Tax Transparency Code to include country-by-country reporting would provide a suitable basis for a mandatory transparency reporting framework.

Furthermore, feedback was requested that if the Tax Transparency Code was used as a basis for mandating country-by-country reporting in Australia, whether there are additional tax disclosures that multinational enterprises should be required to report, such as related party expenses, intangible assets, deferred tax and effective tax rate per jurisdiction.

As part of the October 2022 Federal Budget, the Federal Government announced:

- Large multinationals (defined as significant global entities) would be required to prepare for public release of certain tax information on a country by country (CbC) basis and a statement on their approach to taxation, for disclosure by the ATO
- Australian public companies (listed and unlisted) would be required to disclose information on the number of subsidiaries and their country of tax domicile.

The proposals have not advanced as at the date of finalisation of this publication.

The information below illustrates the requirements of the existing Tax Transparency Code.

Basis of preparation

This tax transparency report of GAAP Holdings Limited has been prepared considering the requirements of the Tax Transparency Tax Code (TTC) released by the Federal Government Board of Taxation in February 2016.

This report does not consider the consultation paper issued by the Board of Taxation in February 2019 arising from the post implementation review of the Tax Transparency Code or the Draft Appendix to the Code issued by the Australian Accounting Standards Board as these have not been finalised.

The report is prepared for the income year ended 31 December 2022 and the comparative period 31 December 2021. All amounts in this report are presented in Australian Dollars (\$).

Australian accounting effective tax rate (ETR) and a global ETR

As a minimum requirement, large and medium business should provide disclose an Australian accounting effective tax rate (ETR) and a global ETR for the worldwide accounting consolidated group calculated based on company tax expense.

In addition, where relevant, large and medium businesses should provide an additional ETR based on total tax expense, including taxes other than income tax (particularly in some industries).

'Accounting profit' is not defined in the TTC, but is defined by the Australian Accounting Standards as profit or loss per the statement of comprehensive income (i.e. before income tax expense) or its equivalent.

Subsequent to the finalisation of the TTC, the Board of Tax has indicated to the AASB that for the purposes of the TTC, the use of the term 'accounting profit' was not intended to restrict the denominator in calculating TTC ETRs to accounting profit as defined by Australian Accounting Standards. Accordingly, this guidance allows entities to use either accounting profit in accordance with accounting standards or other measures of profits, such as underlying earnings, where this is considered more relevant to users.

- Denominator – accounting profit: For TTC ETR it is the accounting profit per the accounting standards, or alternative measures such as underlying earnings for. However for accounting ETR it is the accounting profit per accounting standards.

Where the TTC and accounting ETRs differ, to avoid misleading users of either the financial statements or a separate taxes paid report, the TTC ETRs are considered non-IFRS numbers.
