OPENING OF MEETING

Vaughan Strawbridge, a Joint and Several Liquidator of ACN 000 237 678 Pty Ltd (Formerly Custom Coaches (Sales) Pty Ltd) (In Liquidation) ("the Company") declared the meeting open at 10:08am and that he would act as the Chairperson of the meeting in accordance with Regulation 5.6.17(1) of the Corporations Regulations.

The Chairperson noted the other Joint and Several Liquidator, Tim Norman was not present at the meeting and passed on his apologies.

The Chairperson noted the attendance at the meeting of Paul Bennett and Matt Carter who assist with the day to day management of the Liquidation and the meeting.

The Chairperson noted that everyone present in person had signed the attendance register and he would sign on behalf of those present on the telephone. There were no objections.

PURPOSE OF MEETING

The Chairperson advised that the meeting was convened for the following purposes:

1. To receive the account of the Liquidators' acts and dealings and the conduct of the winding up;
2. To consider the actions required to be carried out to completion of the winding up and an estimate of the time required;
3. To consider the appointment of members to a Committee of Inspection ("Committee"); and
4. To consider any other matters creditors may have wished to table.

TABLING OF DOCUMENTS

The Chairman tabled the following documents:

1. The Notice of Annual Meeting of Creditors dated 24 November 2015 ("Notice");
2. The Statement in Writing of Posting of Notice of Meeting (Form 530) dated 25 November 2015 and executed by Muhammad Satti of my office; and
3. The Report to Creditors dated 24 November 2015 ("Report").

The Chairman noted that if there are no objections he would take the tabled documents as being read. There were no objections.

NOTICE OF MEETING

The Chairperson advised that the meeting had been called in accordance with the Notice which has been advertised on 25 November 2015 on the Australian Securities and Investments Commission Insolvency Notices website (<https://insolvencynotices.asic.gov.au>).

DECLARATION OF CONVENIENCE

The Chairperson advised that in accordance with Regulation 5.6.14, the meeting was being held at a date, time and place convenient to the majority of persons entitled to receive notice of the meeting.

QUORUM

The Chairperson advised that a quorum was present in accordance with Regulation 5.6.16(2).

VOTING

The Chairperson advised the meeting that pursuant to Regulation 5.6.19, any resolutions put to the meeting would be declared on the vote of the voices, unless a poll was demanded before or on the declaration of the results of the voices.

REVIEW OF UPDATE TO THE REPORT

The Chairperson noted the Update to the Report ("Update") had been distributed to those present at the meeting. The primary purpose of the Update was to correct an error in the Report relating to the allocation of bank fees between circulating and non-circulating assets. The Update decreased the estimated return to the secured creditor and increased the estimated return to priority creditors. It did not change the estimated nil return to unsecured creditors. The Chairperson explained the changes.

The Chairperson noted he would provide the Update to the secured creditor as it affected its estimated return but did not intend on providing the Update to unsecured creditors as it did not affect their estimated return.

The Chairperson asked if there were any objections. There were no objections.

REVIEW OF REPORT

The Chairperson noted the actions detailed in the Report, namely:

- Original equipment manufacturer ("OEM") bonds: The Liquidators were attempting to resolve the matter to avoid remaining in office until 2021 when the last OEM bond expired. The Chairperson noted this was beneficial to the secured and priority creditors as it saved on the Liquidators' ongoing costs being incurred should a resolution be reached soon; and
- Supplier claim against the Company: The Liquidators noted developments regarding a supplier claim since issuing the Report. The Chairperson noted it was the Liquidators' position the claim was not valid and that the supplier had threatened court action.

QUESTIONS FROM ATTENDEES

The Chairperson asked whether there were any questions.

Peter Krizmanits of the Department of Employment ("Department") referred to a telephone call the previous day between the Chairperson and representatives of the Department where queries were made of the Liquidators' reports to creditors and statutory reports. Mr Krizmanits noted there were no questions at present but the Department's review of the information was ongoing and he may have queries at a later date.

Sean Morgan of the Australian Manufacturing Workers Union ("AMWU") noted that the AMWU was pleased with the outcome for former employees of the Company and had received positive feedback about the conduct of the Voluntary Administration and Liquidation. The Chairperson thanked Mr Morgan for his comments.

RESOLUTION

The Chairperson outlined the purpose of a Committee and the benefits of the formation of such a Committee in a liquidation.

The Chairperson noted he had received nominations from Mr Morgan and Mr Krizmanits or in his place Caitlin Griffiths to be elected to the Committee.

The Chairperson proposed the following resolution:

The creditors of the Company resolve that the following nominations for membership of the Committee of Inspection be accepted:

- *Sean Morgan representing George Glyntzos, Luis Pedreira, Simon Shedden and Robert Villamil; and*
- *Peter Krizmanits, or in his absence Caitlin Griffiths representing the Department of Employment.*

The Chairperson asked that all in favour of the resolution say yes and all those against say no.

The Chairperson declared the resolution carried unanimously on the voices.

The Chairperson noted that documentation to finalise the appointment of the Committee members would be sent to each member separately.

OTHER BUSINESS

The Chairperson asked if there was any further business.


There was no further business.


