Please be advised that Jason Tracy and Gary Doran, partners of Deloitte, were appointed Voluntary Administrators of the Group on 7 May 2015 pursuant to Section 436A of the *Corporations Act 2001*.

You are receiving this circular because the books and records of the Group indicate that you have entered into a building contract with one of the companies in the Group which is currently in progress.

### **Impact of appointment on homebuyers**

The Voluntary Administrators are now in control of the Group’s business and are undertaking an urgent review of the Group’s financial position. At this juncture, the Group is not trading and as a consequence is unable to continue the construction of your home.

Our immediate focus is on trying to secure an alternative party to take over the building contracts so that we can achieve the best outcome for homebuyers and other stakeholders. Shortly, we will seek expressions of interest from parties who may be interested in buying the Group’s assets. A sale may result in the incoming buyer being willing to complete construction of your home.

This matter is being dealt with as a matter of urgency and a number of parties have already approached us to discuss a potential sale.

We appreciate this is a difficult and uncertain time for you, however, we ask for your patience whilst we undertake this process.
