I refer to the reconvened second meeting of creditors of the Company held on 17 December 2014 (**Second Meeting**).

Outcome of the Second Meeting

At the Second Meeting, a resolution was passed by the creditors that the Company be wound up and Jason Tracy and I be appointed Joint and Several Liquidators.

The Company's creditors also resolved that a Committee of Inspection (**Committee**) be formed for the liquidation of the Company. The Committee enables a more effective and responsive liquidation by allowing the Liquidators to seek prompt consultation with the Committee members, the creditors' representatives, on matters relating to the liquidation.

Other matters

As advised in my letter dated 28 November 2014 and my supplementary 439A report dated 10 December 2014, a sale of the majority of the Company's assets was completed on 25 November 2014. I have since received notice of an action Robit Nominees Pty Ltd and Ocean Energy Construction Pty Ltd intend to bring against the Company and others to have this sale set aside and the Joint Administrators (now Joint Liquidators) removed.

Robit Nominees Pty Ltd and Ocean Energy Construction Pty Ltd are associated with the consortium who were unsuccessful in purchasing the assets of the Company and are both creditors of the Company. Tibor Vertes is a director of both Robit Nominees Pty Ltd and the Company.

This matter is listed for a first directions hearing in the Federal Court of Australia on 4 February 2015. I will keep the Company's creditors informed if this matter progresses.
