### General

#### How did you get appointed as Provisional Liquidators?

- We were approached by the Australian Taxation Office to act as Provisional Liquidators.
- We were appointed by the Supreme Court of New South Wales to act as Provisional Liquidators on 9 June 2017.

### General

#### **What is the role of Provisional Liquidators?**

- Our role as Provisional Liquidators in relation to each of the Companies will be to:
  - Identify and take control of any assets;
  - Determine the nature and value of their respective liabilities;
  - Conduct investigations regarding their affairs;
  - Determine whether it appears that they are insolvent;
  - Liaise with the Australian Taxation Office and Australian Federal Police as necessary for their own separate regulatory and / or enforcement investigations; and
  - Determine the most appropriate manner of realising any assets.

#### **What will happen to the companies?**

- It is up to the court to decide what happens to the companies.
- The winding up application has been listed to be heard on 3 July 2017.

#### Will I be paid?

- The Provisional Liquidation process is to enable investigations to be conducted. As such, the Provisional Liquidators' are unable to make any payments to creditors during this time. You are, however, able to lodge a notice of your claim with the Provisional Liquidators.
