

IG DOCA Excluded Contracts Designation Notice

This is the Excluded Contracts Designation Notice for the purposes of, and as defined in, the Deed of Company Arrangement dated 25 September 2020 in relation to Virgin Australia International Holdings Ltd and certain of its subsidiaries (**IG DOCA**).

The Deed Proponent delivers this notice to the Deed Administrators pursuant to clause 10.1 of the IG DOCA.

Capitalised terms used in this notice and not otherwise defined have the meaning given to them in the IG DOCA.

A reference to a contract in this notice is a reference to that contract as amended, supplemented, novated or restated prior to or on the date of Completion of the IG DOCA, including any amendment or supplement entered into after the Commencement Date.

This notice is divided into the following parts:

Part 1:

Part 1 of this notice sets out the contracts that were listed in Part 1 of Schedule 6 (Excluded Contracts) to the IG DOCA (**Excluded Contracts Schedule**). These contracts are Excluded Contracts under the IG DOCA.

Part 2:

Part 2 of this notice sets out the contracts that were listed in Part 2 of the Excluded Contracts Schedule and in respect of which either:

- (a) the counterparty has waived or will waive, prior to or with effect from Completion, any event of default or breach by the relevant Deed Company which occurred on or prior to the Commencement Date or which may occur during the Deed Period or on Completion insofar as the Creditor would be entitled to terminate the contract or (where applicable) take possession of or otherwise recover from a Deed Company property leased under that contract; or
- (b) the Deed Proponent designates the contract as an Excluded Contract notwithstanding that the counterparty has not satisfied the requirements of paragraph (a).

These contracts are Excluded Contracts under the IG DOCA.

Part 3:

Part 3 of this notice sets out the contracts that were listed in Part 3 of the Excluded Contracts Schedule and in respect of which either:

- (a) the conditions to the inclusion of that contract as an Excluded Contract for the purposes of the IG DOCA identified in Part 3 of the Excluded Contracts Schedule for that contract have been satisfied (or are to be satisfied on the date of Completion of the IG DOCA); or
- (b) the Deed Proponent designates the contract as an Excluded Contract notwithstanding that the counterparty has not satisfied the requirements of paragraph (a).

These contracts are Excluded Contracts under the IG DOCA provided that any conditions to the designation of that contract as an Excluded Contract identified in Part 3 of this notice for that contract are satisfied by no later than the date of Completion of the IG DOCA.



Part 4:

Part 4 of this notice sets out the contracts (including any lease) relating to an aircraft leasing or financing transaction that were listed in Part 4 of the Excluded Contracts Schedule and in respect of which the relevant Deed Company has entered into an amendment agreement with the relevant counterparties, and any conditions to the effectiveness of the amendments contemplated by the amendment agreement have been satisfied (or are to be satisfied on the date of Completion of the IG DOCA).

Contracts listed in Part 4 of this notice are Aircraft Excluded Contracts under the IG DOCA, provided that any conditions to the designation of that contract as an Aircraft Excluded Contract identified in Part 4 of this notice for that contract are satisfied by no later than the date of Completion of the IG DOCA.

Part 5:

Part 5 of this notice sets out certain contracts that were not listed in the Excluded Contracts Schedule but that are designated by the Deed Proponent as an Excluded Contract under the IG DOCA. These contracts are Excluded Contracts under the IG DOCA.
