



Mutual Funds (Amendment) Law, 2020

On 7 February 2020, the Cayman Islands Government enacted the **Mutual Funds (Amendment) Law, 2020**. Open-end funds formed in the Cayman Islands that have 15 or fewer investors (who have the ability to appoint or remove the operator of the fund) are now required to register with the Cayman Islands Monetary Authority ("CIMA").

These open-end funds were previously exempted from CIMA registration under section 4(4) of the Mutual Funds Law ("Limited Investor Funds").

Under the transitional period arrangement, Limited Investor Funds must be registered by 7 August 2020, accompanied by an initial application fee of US \$366. Mutual funds registering during the six-month transitional period shall not pay an annual registration fee for 2020 and the first annual registration fee of US \$4,268 shall fall due in January 2021.

Any fund registering on or after 8 August 2020 will be required to pay an annual registration fee of US \$4,268 for 2020.

Ongoing Operating Obligations

Directors: Mutual funds must have a minimum of 2 directors for companies. In the case of general partners or corporate directors of a mutual fund, a minimum of 2 natural persons must be named in respect of the general partner or corporate director. Directors must be registered under the Directors Registration and Licensing Law.

Audit: Audited financial statements, issued by a Cayman Islands auditor approved by CIMA, must be submitted to CIMA annually within six months of the fiscal year-end. The accounts must be prepared and audited in accordance with International Financial Reporting Standards or US, Japanese or Lux GAAP or GAAP of a non-high risk jurisdiction.
