

# A single platform of Internet providers will be created in Azerbaijan

A single information center on their coverage will be established in Azerbaijan.

It is reported that for this purpose, it is planned to create an information system "ASANnet" and a single service portal.

At present, at the initial stage, the development of such a service for customers of state providers Baktelecom and Aztelekom has begun. At the next stage, it is planned to create an "ASANnet" service for customers of all providers.

This service involves the creation of a personal account for each customer on a single portal and the management of services provided by the provider to which it is connected.

#### MTCHT warns: Citizens are sent fake e-mails

The Electronic Security Service under the Ministry of Transport, Communications and High Technologies has registered another "phishing" campaign via e-mail. Thus, fake letters sent to citizens by e-mail state that various military exercises were allegedly held with the participation of Azerbaijani, Turkish and Georgian servicemen. It is noted that the State Civil Aviation Agency together with the Ministry of Defense has developed the "Unshakable Brotherhood - 2021" program to watch these exercises live. The fake letter states that the program was approved by the Ministry of Transport, Communications and High Technologies.

According to Xeberler.az, the user is then asked to enter the link attached to the fake letter and download the program. Malware is placed in that link, and the device of the user who enters the link and downloads the program is infected.

### The subject of cryptocurrency has been included in the curriculum for the first time in Azerbaijan

For the first time in Azerbaijan, the subject of cryptocurrency has been included in the curriculum of the Azerbaijan State University of Economics (UNEC). The subject "Cryptocurrencies and Cyber Risks" will be taught by the UNEC School of Business, Department of Economics and Business Administration in the 2021 academic year under the MBA (Master of Business Administration) program. Thus, UNEC became the first university in the national education system to teach the subject of cryptocurrencies.

MBA students in the subject "Cryptocurrencies and cyber risks" e-money, digital assets, cryptography, blockchain technology, e-wallets, features and applications of cryptocurrencies, cryptocurrency mining, smart contracts, DeFi finance, international information security and regulation of cyber risks, digital assets they will gain knowledge on the field.

### Central Russia's nuclear facilities have been targeted by cyberattacks

The statement came from the Secretary of the Security Council of the Russian Federation on Wednesday, October 27. The number of attacks increased by 15% in 2021, and in the last three years, 11,500 cyberattacks were recorded in the central part of the country.

"Among the targets are information resources of government and local self-government bodies, military-industrial complex enterprises, energy, including nuclear energy, as well as educational and scientific institutions," the Central Federal District (CEC) said at a security meeting on Wednesday.

## A service to identify unlicensed drivers has been launched in Almaty

The new technology for searching for drivers behind the wheel of cars that do not have the right to drive works on the basis of the Police Department's Operational Control Center and is connected to the city's video surveillance systems. In this regard, the actions of the personnel of the combat units of the Almaty police are aimed at identifying biased violators who pose a real threat to road users. The new service, introduced by the police, allows the information to be transmitted to patrol teams for operative storage and stopping after the vehicle is detected by a video recording system.

### Kazakhstan's Internet is accelerating, surpassing that of Central Asia

In September of this year, Kazakhstan ranked 80th in the ranking of countries for the speed of mobile Internet, rising three places in a month. At the same time, the country improved its position by 21 lines during the year. Since the beginning of the year, the speed of the Internet in Kazakhstan has increased from 19.52 to 31.74 Mbit / s, an increase of 62.6%.

It should be noted that Kazakhstan is the leader among Central Asian countries in terms of mobile internet speed. Thus, Kyrgyzstan ranks 103rd, Uzbekistan 120th and Tajikistan 129th. Kazakhstan bypassed the EEU partners - Russia (90th place) and Belarus (119th place).

In an interview with Sputnik Kyrgyzstan, Aybek Sultanaliyev, head of the digital and financial technology department of the National Bank of Kyrgyzstan's payment systems department, said that the country's financial sector is trying to keep up with the times.

"The National Bank pays great attention to this sector, our efforts are aimed at providing timely and quality services to businesses and people. The problem is also that banks and other organizations compete with each other and reduce costs with the help of new technologies. The National Bank has adopted a concept for the development of digital payment technologies for 2020-2022. Under the influence of new technologies are the fastest changing industrial payments. People and businesses are gradually getting used to electronic payments and non-cash payments. You can't force anyone to change the system in one day, everything should be gradual, "Sultanaliyev said.
