

## Azerbaijan

#### National information resources have been seized

Many Azerbaijani YouTube channels have been subjected to cyberattacks. The Azerbaijan Internet Forum reports that, looking at the statistics, recently these types of cyberattacks against our national resources have increased significantly.

The State Service of Special Communication and Information Security has discovered new fraud methods

The institution notes that based on the latest research, it is observed that fraudsters are seizing the funds of card users based on a new scheme.

In the revealed method, card users are first asked to register on the relevant website to provide them with a job or to form an additional source of income from virtual sales through SMS notification and accounts on social networks. Registered card users are offered various service packages that provide interest income on the amount. However, card users cannot get any services later in exchange for the funds they paid as participants.

## The Ministry of Internal Affairs appealed to citizens about cyber fraud

The Ministry of Internal Affairs reports that there are many cases of fake electronic lottery games, contests on social network pages with a prize fund using the names and logos of well-known persons and companies of the country that ask the participants to transfer a certain part of the winnings to the provided bank account to formalize the corresponding prize. Some people who believe in the said promises then become victims of cyber fraudsters.

## Accounting of internet providers in Azerbaijan has started

The Information Communication Technologies Agency (ICTA) under the Ministry of Digital Development and Transport is starting to register operators and providers of internet telecommunication services, including host providers.

It is reported that, considering the requirements of the Law "On Telecommunications" and the "Regulation of keeping records of operators and providers providing Internet telecommunications services", operators and providers offering services in the field of Internet telecommunications in Azerbaijan, including host providers, must be registered.

## The State Tax Service will limit the use of code-passwords

From January 1 next year, taxpayers in Azerbaijan will be limited in their access to the electronic cabinet with the code-password provided by the tax authority. The information is provided by the State Tax Service under the Ministry of Economy.

It will be necessary for taxpayers to use an enhanced electronic signature ("ASAN Signature") to enter the electronic cabinet, register the notification of employment contract electronically, send electronic invoices related to goods, works and services to persons registered as taxpayers, and benefit from other electronic services. Taxpayers with a strengthened electronic signature can use all electronic services freely and securely, whether through a mobile phone, computer or other mobile devices.

## Uzbekistan is introducing 5G technology

The first stage of the project provides for full coverage of the city of Tashkent with a 5G network, as well as partial coverage of regional centres.

As part of the project, more than 3,000 existing base stations across Uzbekistan will be modernized using the latest technologies, and more than 2,000 new base stations will be built and put into operation.

## Kazakhstan

#### The volume of IT-services in Kazakhstan has increased sharply

The volume of services provided in the field of computer programming, as well as consulting and other related services in January-December 2022 amounted to 772.5 billion tenge - this is 40.3% more in monetary terms compared to the same period in 2021. According to the Ministry of Digital Development, IT exports have doubled over the past two years.

## Kazakhstani people can apply for a passport and ID card by themselves

The innovative project "Documenting Terminal" is unique in that customers will be able to order the service, bypassing the queue, and choose a successful photo for the document on their own. Passport and ID card service is one of the most popular in Kazakhstan. Thus, last year more than 2.3 million citizens applied to Public Service Centers for the service. To optimize the service for citizens, reducing the time of reception, the state corporation installed a terminal, which allows you to independently apply for documents.

## Several digital services for citizens and businesses are planned to launch in Kazakhstan

A list of 66 digital initiatives to be implemented this year has been developed. Among the proposals voiced by the Minister of Digital Development, Innovation and Aerospace Industry are the digitization of medical and social expertise, the launch of a digital product for preschools, the development of a "Vet Mobile" application that can be used for registration of farm animals, exemption from military conscription or registration of equipment according to certain formats.
