1. Introduction

The Game is organized by Deloitte Accountancy, with registered office at Berkenlaan 8B, 1831 Diegem, Belgium, subscribed in the Register of Legal Entities of Brussels under business registration number 418.466.314 (hereinafter "Deloitte", "we", "us," or "our") and this Privacy Statement explains how we protect the participating students (hereafter also referred to as "you") information gathered via the Application.

By taking part in the Game, you are agreeing to the use of your information as described in this Privacy Statement.

All terms used in this Privacy Statement will have the same meaning as assigned to it in the "General Terms of the Deloitte Facebook Game."

2. Information collection

As a participating student, you will be asked to submit additional personal information in order to take part in the Game. We do not seek sensitive information (e.g., data relating to race or ethnic origin, religious beliefs, criminal record, physical or mental health, or sexual orientation) from the participating students. We will, where necessary, obtain your explicit consent to collect and use such information.

3. Information use

We may use your personal information for marketing purposes, or to send you promotional materials or communications regarding services provided by entities within the Deloitte Network that we feel may be of interest to you. We may also contact you to seek feedback on services provided by entities within the Deloitte Network or for market or other research purposes.

Your personal information may also be used to protect our rights or property and that of other participating students and, where appropriate, to comply with legal process.

You may at any time request that we discontinue sending you emails or other communications generated in response to your provision of personal information via the unsubscribe button in the emails and/or by contacting us through beentrepreneurship@deloitte.com.

4. Disclosure of information to third parties

We may provide your personal information to other entities within the Deloitte Network in order to provide you with information that could be of interest to you and conduct market or other research.
