The Belgian tax authorities announced on their BizTax website the due date for filing the resident and non-resident corporate income tax returns of tax year 2016.

The due date has been set at **Wednesday 28 September 2016** with respect to companies closing their financial year between 31 December 2015 and 31 March 2016, and holding their shareholders general meeting before August 2016.

As with last year, the tax authorities also issued an overview of the due dates for companies closing their financial year as of 30 April 2016.
