Mileage allowance for professional travel: index 2014

The administrative circular letter with regard to the mileage allowance (*kilometervergoeding/indeminté kilométrique*) for civil servants was published in the Belgian Official Gazette of 4 July 2014.

The mileage allowance is increased to € 0.3468/km (currently € 0.3461/km) and is applicable during the period between 1 July 2014 and June 30 2015.

The lump-sum mileage allowance is accepted as a cost proper to the employer in the private sector when it is paid to employees using their own car in the framework of their employment.
