#### Private use of company car – 2014 Modified CO2 emission reference

After the Council of Ministers approved the draft bill containing miscellaneous tax provisions on 6 December 2013, a Royal Decree of 24 January 2014 (*M.B.* 29 January 2014) modified the CO2 emission reference applicable in determining the taxable benefit in kind for the private use of a company car by company directors and employees.

The following reference CO2 emission reference will be applicable as of 1 January 2014 for the taxable benefit in kind for the private use of a company car :

- Petrol, LPG or natural gas cars: 112 g CO2/km (instead of 116 g CO2/km for income year 2013)
- Diesel cars: 93 g CO2/km (instead of 95 g CO2/km for income year 2013 )

For income year 2014, the minimum amounts to consider as taxable benefit for the private use of company car amounts to EUR 1,250.00 (instead of EUR 1,230.00 – amounts applicable for income year 2013).

This CO2 emission reference change will affect the processed January pay slip.
