### **Resident income tax return form for IY 2016 published**

On 29 March 2017, the new form for the 2016 resident income tax return (assessment year 2017) has been published in the Belgian Official Journal ([Dutch](#) | [French](#)).

Compared to last year, there are 75 additional codes that have been adopted, bringing the total number of codes to 885.

The new codes relate to tax reductions for mortgage loans, the separate taxation of movable income, tax incentives for hotel and catering staff (special overtime in the hospitality sector) and for people benefitting from unemployment with company allowance.

Tax authorities have announced that they will communicate further information on the new resident tax reform on 25 April 2017.

Deloitte will provide an update as soon as the filing deadlines have been announced.
