### Selection criteria

Public or private companies who develop a technology-related product or service and who have experienced substantial revenue growth over the last five years can enter the competition for their chance to be nominated as one of the 50 fastest-growing technology companies in Belgium.

Companies that have been active in the technology sector for less than five years can participate in the special Rising Star category of the competition.

### Awards

This year, the Deloitte Technology Fast50 competition is held solely for Belgian technology companies. This Belgian edition will see the number of award categories expand and include the:

**Fast 50 award:** given to the country's fastest-growing technology company based on its percentage of growth in turnover during the last five years.

**Rising Star:** an award for a promising technology company operating for less than five years. The winner is selected based on the short "Pitch-presentation" made by each company just prior to the Fast 50 award ceremony.

**Most Disruptive Innovator:** an award for the company that creates a revolution within a specific technology segment. The winner is selected from among the Rising Star Nominees.

**Most Sustainable Growth:** an award for a (mature) company with the most increasing ROI and profitability. The winner is selected from among the 2015 Fast 50 contestants and Fast 50 Alumni.

- Biotech & Medical Technology
- Internet, Media & Telecom

### Jury

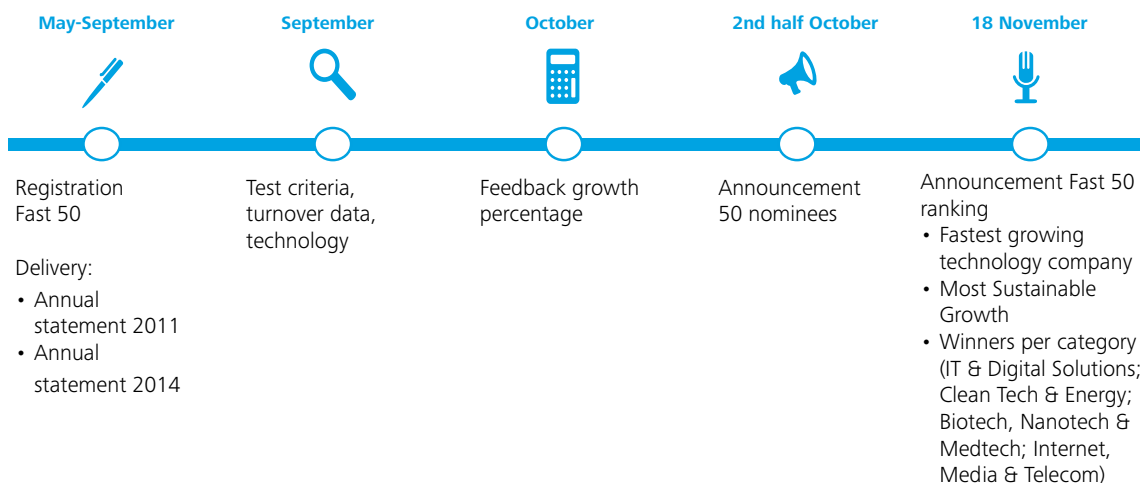
This year, it is our pleasure to announce that the Rising Star jury will be presided by **Duco Sickinghe**, CEO Fortino and Former CEO Telenet.
