### EU funding instrument for infrastructure investments

**Total budget of the program:** EUR 3,33 billion, divided into the following major topics:

- **Alternative Fuels Infrastructure Facility:** EUR 780 million
  - Electricity charging infrastructure
  - Hydrogen refuelling infrastructure
  - LNG refuelling infrastructure
- **Develop Transport Infrastructure Projects on the Core and Comprehensive Networks of the TEN-T:** EUR 1,23 billion
  - Maritime Ports
  - Roads, Rail-road Terminals, and Multimodal Logistics Platforms
- **Modernize Transport Infrastructure on the Core and Comprehensive Networks of the TEN-T:** EUR 805 million
  - Smart Applications for Transport and Transport Interoperability
