Athens city tour & Acropolis Museum

This tour includes an overview of the modern city and striking contrasts to the remains of its glorious past. You will see the Tomb of the Unknown Soldier in front of the Parliament House and the Panathinaikon Stadium the first Olympic Games took



place in 1896. See vistas of the Presidential Palace, the Catholic Cathedral, the Academy, University, National Library and the Temple of the Olympian Zeus. Continue the guided Athens sightseeing tour with a pleasant short walk in order to visit the Acropolis Museum.

Wine tasting - Fragou Winery

Fragou Winery is one of the oldest buildings in Spata with a history of over 230 years. The visitor is captured by the atmosphere of old times. The recently restored old cellar, being a remarkable combination of utility and aesthetics, contributes greatly to this superb sensation.



Guests will enjoy a fun-filled day at the winery, immersing themselves in the culinary and cultural richness of Greece. Split into two teams, they will tour the facilities of the winery and the enchanting stone house, and enjoy wine tasting and a presentation on Greek wine making.

Meanwhile, the second team will take part in a hands-on cooking class, preparing Greek specialties such as spinach pie. The two teams will then meet to exchange experiences over a coffee break in the enchanting courtyard and then swap activities. A souvenir accompanies the event (homemade marmalade, olive oil, mix of Greek herbs).
