ISO Certificate 14001

We successfully obtained the ISO Certificate 14001 for the Environmental Management System back in May 2008.

Since then, we publicly present our compliance by maintaining and continually improving our environmental management system, and undergo internal and external audits annually.

Currently all staff, management and subcontractors have been informed of and have joined the effort to protect the environment. The following commitments illustrate what are our standpoints on environmental responsibility and climate action in the Czech Republic and Slovakia, in accordance with these environmental management systems.

Embed sustainability

Deloitte recognizes we must align our climate policies, practices, and actions across our organization, ensuring that it is an important element of everything we do.

Concrete steps in the Czech & Slovak Cluster:

- We have a designated position of the WorldImpact leader, dedicated to conveying the significance of the topic, and uniting the region and local offices in these shared goals.
- With implemented sustainability governance, Climate stakeholders meet monthly to discuss climate change and execute actions to continuously move closer to reaching our 2030 goals.
- We embed climate-smart considerations into every aspect of our operation, from introducing circular economy principles to client projects.
- Along with fulfilling all applicable environmental legislation and reporting data on our emissions and actions taken, we communicate our steps both internally and externally, to ensure maximum transparency and accountability.
- Due to the nature of Deloitte's services, our operations do not create direct emissions from activities such as material extraction or manufacturing. Scope 1, 2 and 3 emissions are addressed in the following commitments to Net-zero.

Net-zero with 2030 goals

Deloitte's near-term (2030) greenhouse gas (GHG) reduction goals have been validated by the Science Based Targets initiative (SBTi) as 1.5°C-aligned, science-based targets. Deloitte has also committed to set long-term emissions reduction targets using the SBTi's Net Zero Standard.

Concrete steps in the Czech & Slovak Cluster:

- We continue measuring our emissions and reducing our consumption. Our focus is conserving water, maintaining energy consumption at a reasonable minimum, keeping clean air, and limiting our waste production.
- We participate in projects focused on renewable energy sources.
- We encourage our employees in choosing sustainable modes of travel for work and personal reasons.
- We support eco-friendly business travel decisions, while promoting the use of online platforms whenever possible.
- We encourage our suppliers to make sustainable decarbonization choices, and select new suppliers based on their environmental practices.

Empower individuals

By engaging and educating Deloitte professionals on climate change impacts decisions about what they consume, use, and buy—we foster a sustainable mindset. This enables our people to make positive climate choices at home and at work and amplify these through their personal networks.

Engage ecosystems
