




Number of new corporate bond issues in 2017-2021




In 2021, the volume of corporate CZK bonds issued was CZK 52.9 billion, an increase of 70% compared to 2020. The average issue amount was CZK 229 million.



Number of above-threshold issues in 2021. This is 30% more than the previous highest number.


Below-threshold issue volumes in 2017-2021 (CZK billion)



Number of below-threshold issues in 2021. The average issue amount increased by 2.1% to CZK 12.9 million year-on-year.

The total volume of new issuance was particularly affected by a record high volume of above-threshold issues in 2021. Compared to 2020, the volume of below-threshold issues decreased by around 8% while the volume of above-threshold issues increased by around 72%. The number of above-threshold issues increased by around 37% compared to the previous year. The average above-threshold issue amount in 2021 was CZK 331 million, almost 26x the average below-threshold issue amount.

Development of coupon yields for above-threshold and below-threshold issues (% p. a.)





Structure by years of issuers' existence




In 2021, bonds on the Czech market were predominantly issued by new companies (up to 1 year old).


Issues above CZK 1 billion (CZK million)
