

INFORMATION ON PROCESSING OF PERSONAL DATA

Information provided by

The Author acknowledges that his/her personal data is processed by Deloitte as the Controller in the manner and to the extent set out below. Scope of processing:

Purpose of processing:

The purpose of the processing of the Author’s Personal Data is the exercise of Deloitte’s rights and obligations under the Agreement and applicable law, in particular the administration of the Contractual Relationship, acts related to the performance of the Parties’ obligations under the Agreement.

Author's personal data may also be disclosed to competent authorities authorised under applicable law.

Personal data processing period:

The Author's Personal Data will be processed until the purposes of processing such Personal Data under the Agreement are fulfilled, or for the period required by applicable law. After this period, the Author's Personal Data will be anonymised or permanently deleted. If the Author's Work is not published according to the Terms of Use, the Author's Personal Data will be deleted no later than 4 months after it is provided.

Author's obligations:

The Author is responsible for the accuracy and up-to-date nature of the Personal Data provided to Deloitte. The Author undertakes to inform Deloitte forthwith of any changes to the Personal Data provided by the Author.

Author's rights:

The Author, as the subject of the Personal Data, has the right to request access to his/her Personal Data, their rectification or erasure or restriction of processing, or may object to processing, and also has the right to data portability. The Author also has the right to file a complaint with the local supervisory authority for the processing of personal data, i.e. the Office for Personal Data Protection.
