## What is TISAX and why do you need it?

Companies in the automotive industry are required to demonstrate regularly **every three years** that they meet the Information Security criteria.

VDA-ISA catalogue of Information Security requirements published by the Association of the Automotive Industry (Verband der Automobilindustrie, VDA). The VDA-ISA catalogue includes **key aspects and criteria of the internationally recognized ISO 27001 standard** and additional lists of criteria that are directly relevant to the automotive sector, such as third party involvement and prototype protection. In addition, there is a fully developed and comprehensive **audit and exchange mechanism**.

The audit and reporting processes provide a high degree of comparability and transparency and thus **build confidence** for the relevant customers, who therefore increasingly require a TISAX label.

The TISAX online platform allows participants to share assessment data, while at the same time allows participants and audit providers to communicate with each other.
