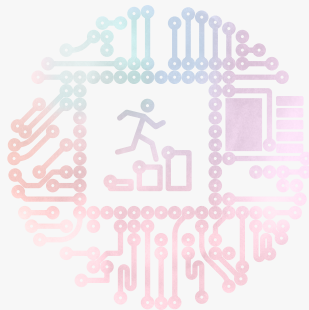
CISO Programme launch event
