# Friday, 23 June and Monday, 26 June are non-business days for the Superintendency of Tax Administration

On 23 June 2023, Resolution No. SAT-DSI-894-2023 of the Superintendency of Tax Administration was published in the official gazette, which grants paid leave on Friday, 23 June and Monday, 26 June, 2023 to the personnel of the Tax Administration, due to the institution's anniversary and the general elections that will be held in the Republic of Guatemala, with the exception of personnel that work special schedules in such entity.

Due to the above, the 23 and 26 June 2023 will be considered as non-business days for purposes of calculating the terms established in the tax and customs legislation.
