

### Tax Alert SAT declares 9, 10, 11, 12 and 13 October 2023 as non-business days

In light of the current situation in the country, the Superintendency of Tax Administration -SAT-, according to resolution number SAT-DSI-1688-2023 published today in the official gazette, announced that it is declaring

9, 10, 11, 12 and 13 October 2023 as non-business days for purposes of disregarding them in the calculation of the administrative terms established in the tax, customs or administrative legislation, both for taxpayers and for SAT in the exercise of their duties and responsibilities.

Likewise, SAT is declaring 12 and 13 October 2023 as non-business days for purposes of calculating the

terms for filing tax returns and for the payment of the corresponding taxes.

It is recommended that taxpayers take this into consideration when filing their tax returns, as well as when filing appeals on these dates.

In addition, it is important to stay alert to the information provided through the official channels of the Tax Administration in the coming days, since it has also stated that the declaration of non-business days may be extended if the exceptional circumstances that led to this resolution persist.
