

The Tax Administration has made available to Small Taxpayers the Suggested Pre-prepared Tax Return


The Superintendency of Tax Administration -SAT- has made available the Suggested Pre-prepared Tax Return for Small Taxpayers to taxpayers that are registered under the following regimes:

- Small Taxpayer Regime
- Electronic Regime for Small Taxpayers
- Special Agricultural Taxpayer Regime
- Special Electronic Regime for Agricultural Taxpayers

This pre-prepared tax return is generated automatically through the FEL App; that is, the taxpayer's information, the period to be declared, and the amount of income are obtained from the information that SAT already has in its system, based on online electronic invoicing, with the purpose of simplifying tax compliance and reducing mistakes in the filling out of tax return forms.

If there is no resulting tax payable, the Suggested Pre-prepared Tax Return can be submitted to SAT directly from the FEL App.

The above confirms that the Tax Administration continues innovating in the areas of compliance and oversight through the use of electronic tools.
