SAT declares 24 June and 01 July 2024 as non-business days

The Superintendency of Tax Administration -SAT-, according to Resolution No. SAT-DSI-1192-2024 published today in the official gazette, announced that it is declaring 24 June 2024, in commemoration of the creation of SAT, and 01 July 2024, Guatemala's National Army Day, as non-business days for purposes of disregarding them in the calculation of the terms established in the tax and customs legislation.

It is recommended that taxpayers take this into consideration for the filing of their tax obligations, as well as for the calculation of days for filing appeals in administrative proceedings.
