EU Gateway Programme: entering the Japanese and Korean markets

We would like to raise your attention to the European Commission funded and financed initiative, the EU Gateway Programme. The main objective of EU Gateway is to support innovative European companies – primarily SMEs – operating in different business sectors in entering the Japanese and Korean markets, expand their businesses and make new contacts through a 1 week long business week. The Commission provides a funding covering much of the expenses for each participant and also provides assistance in the application process.

14 February 2014 (Japan)
- **Interior Design** / application deadline:
25 October 2013 (Japan)
