### Summary of the New Energy & Resources Regulations

The following is a list of the new energy & resources regulations. All regulations are available in Indonesian.

### New Energy & Resources Regulations

1. Regulation: Minister of Energy and Mineral Resources (ESDM) Regulation 27/2018 ([click here Permen ESDM 27/2018](#))

Date : 4 May 2018

Subject : Kompensasi atas Tanah, Bangunan, dan/atau Tanaman yang Berada di Bawah Ruang Bebas Jaringan Transmisi Tenaga Listrik  
(Compensation for Land, Buildings, and/or Plants Located under Electric Power Transmission Network Right of Way)

### **Summary**

Minister of Energy and Mineral Resources Regulation Number 27 of 2018 confirms that holders of electric power provision business licenses are obliged to provide compensation to holders of title to land, buildings and/or the plants associated with land, buildings and/or plants that suffer a reduction of economic value due to being crossed by an electric power transmission network, whether in activities of construction of a new electric power transmission network, activities of replacement or addition of new towers/poles, or expansion of the area/width of the right of way and minimum horizontal and vertical axis safe distance corridors of existing networks. The formula for calculation of the compensation is stipulated in this regulation. In

addition, the steps that must be taken and actions that must be performed in connection with provision of compensation, and the requirement for holders of electric power provision business licenses to pay compensation for damage to buildings and plants that occurs during the construction of an electric power transmission network, are all stipulated in this regulation.

Subject : Pelaksanaan Kaidah Pertambangan yang Baik dan Pengawasan Pertambangan Mineral dan Batubara  
(Implementation of Good Mining Practices and Oversight of Mineral and Coal Mining)

### **Summary**

Minister of Energy and Mineral Resources Regulation Number 26 of 2018 is established based on the consideration to provide implementation guidance on good mining engineering standards as mentioned in Law Number 4 of 2009 and Government Regulation Number 55 of 2010. Further, the scope of this regulation as specified in Article 2 covers implementation of good mining practices, oversight of mining business management operations, and oversight of implementation of mining business activities.

3. Regulation: Minister of Energy and Mineral Resources (ESDM) Regulation 25/2018 ([click here Permen ESDM 25/2018](#))

Subject : Perusahaan Pertambangan Mineral dan Batubara  
(Mineral and Coal Mining Business Operations)

### **Summary**

Minister of Energy and Mineral Resources Regulation Number 25 of 2018 is established based on considerations to ensure legal certainty and certainty in doing business, as well as to boost effectiveness, efficiency and accountability in the implementation of mining business activities and to promote development of mineral and coal businesses.

4. Regulation: Minister of Energy and Mineral Resources (ESDM) Regulation 22/2018 ([click here Permen ESDM 22/2018](#))

Subject : Perubahan atas Permen ESDM Nomor 11 Tahun 2018 tentang Tata Cara Pemberian Wilayah, Perizinan, dan Pelaporan Pada Kegiatan Usaha Pertambangan Mineral dan Batubara  
(Amendment of Permen ESDM Number 11 of 2018 concerning Procedures for Granting of Areas, Licensing, and Reporting in Mineral and Coal Mining Business Activities)

## **Summary**

Minister of Energy and Mineral Resources Regulation Number 22 of 2018 stipulates changes concerning the calculation of the compensation price of data and information on Mining Business License Region (WIUP) and Special Mining Business License Regions (WIUPK) based on the availability of data and information; as well as to ensure financial and technical capability of tender winners; and to provide certainty in doing business for holders of Mining Business Licenses (IUP) for Production Operation, specifically for transportation and sales.

Subject : Harga Mineral Logam Acuan dan Harga Batubara Acuan untuk Bulan Mei Tahun 2018

(Reference Prices of Metallic Minerals and Reference Price of Coal for May 2018)

## **Summary**

Minister of Energy and Mineral Resources Decision Number 1812 K/30/MEM/2018 sets the reference prices of metallic minerals for 20 metallic mineral commodities and the reference price of coal which prevail during May 2018. The Reference Prices of Metallic Minerals (including reference prices for metallic minerals in the form of Nickel, Cobalt, Lead, Aluminium, Copper, Gold, Silver, and others) and the Reference Price of Coal will be used as the basis for calculation of the Benchmark Prices of Metallic Minerals and the Benchmark Price of Coal for May 2018.

Subject : Harga Kompensasi Data Informasi dan Informasi Penggunaan Lahan Wilayah Izin Usaha Pertambangan dan Wilayah Izin Usaha Pertambangan Khusus Periode Tahun 2018

(Compensation Price for Information Data and Information on Land Use for Mining Business License Areas and Special Mining Business License Areas for the Period 2018)

## **Summary**

Minister of Energy and Mineral Resources Decision Number 1805 K/30/MEM/2018 stipulates the compensation prices for information data and information on land use in Mining Business License Areas and Special Mining Business License Areas which is needed for implementation of tenders for Mining Business License Areas and Special Mining Business License Areas in 2018. The compensation for the information data is calculated based on the availability of data and information covering size of the area, type of deposits, status of the area, and loading/transshipment distance. Payment of the compensation price of information data for a mining area that is tendered must be made in advance. The payment, which is similar to the concept of a signing bonus for an oil and gas work area, applies for 16 mining areas that are tendered.

### **Summary**

Minister of Energy and Mineral Resources Decision Number 1802 K/30/MEM/2018 designates 10 Exploration Mining Business License Areas and 6 Special Exploration Mining Business License Areas. The Exploration Mining Business License Areas may be granted to a business entity, cooperative or individual through tender, while the Special Exploration Mining Business License Areas may be granted to a State-Owned Enterprise or Regional Government-Owner Enterprise on priority basis or to a private business entity through tender.

Minister of Energy and Mineral Resources Decision Number 1801 K/30/MEM/2018 stipulates that the formula for calculation of the compensation price for information data on Mining Business License Areas and Special Mining Business License Areas shall be calculated as the sum total of all types of scope of data as stipulated in Minister of Energy and Mineral Resources Decision Number 1805 K/30/MEM/2018.

Minister of Energy and Mineral Resources Decision Number 1796 K/30/MEM/2018 is established based on the consideration to provide implementation Guidelines for requests, evaluation and issuance of licenses in the field of mineral and coal mining, and to implement the provisions of Minister of ESDM Regulation Number 11 of 2018 as amended by Minister of ESDM Regulation Number 22 of 2018.
