



## Energy and Resources Regulations Update

The following is a list of the new Energy and Resources regulations.

All regulations are available in Indonesian.

- Title (Indonesian) : Perubahan atas Peraturan Menteri Keuangan Nomor 194/PMK.02/2021 tentang Tata Cara Perhitungan Persentase Tertentu atas Peningkatan Belanja Subsidi Bahan Bakar Minyak dan Liquefied Petroleum Gas terhadap Kenaikan Penerimaan Negara Bukan Pajak Minyak Bumi dan Gas Bumi yang Dibagihasilkan
- Title (English) : Amendment to Regulation of the Minister of Finance Number 194/PMK.02/2021 concerning Procedures for Calculation of a Certain Percentage of Increase in Subsidy Expenditures for Oil Fuel and Liquefied Petroleum Gas on the Increase of Non-Tax State Revenues for Shared Petroleum and Natural Gas

### **Summary**

This Regulation of the Minister of Finance concerning the Amendment to the Regulation of the Minister of Finance Number 194/PMK.02/2021 amends the provisions of paragraph (3), paragraph (4), and paragraph (5) of Article 5 into the following points: The government may calculate a certain percentage of an increase in subsidy spending on certain types of fuel and 3 Kg LPG cylinders in the event that the realization of PNPB Migas that is shared exceeds the revenue target in the State Budget; The increase and realization of Non-Tax State Revenues for Petroleum and Natural Gas (PNPB Migas) that is shared is caused by an increase in the price of Indonesian crude oil of at least 10% of the price target in the State Budget or changes in the State Budget for the current year; A certain percentage of the increase in subsidy spending on certain types of fuel and 3 kg LPG cylinders that can be charged to the increase in non-tax revenues from shared oil and gas; The formula for calculating the burden of increasing subsidy spending on certain types of fuel and 3 kg LPG cylinders for the increase in PNPB Migas that is shared; If the value of the subsidy expenditure calculated by the formula is greater than or equal to the value of the increase in PNPB Migas, the imposition of the increase in Subsidy expenditure for Certain Types of Fuel and 3 Kg LPG Cylinders uses a portion of the increase in PNPB Migas that is shared. Calculation of the charge for the increase: Increase in PNPB Migas that is shared; Increased Subsidy Expenditure for Certain Types of Fuel and 3 Kg LPG Cylinders; The value of the increase in subsidies for certain types of fuel and 3 kg LPG cylinders that can be charged against the increase in PNPB Migas that is shared. Increase in PNPB Migas that is shared; Increased Subsidy Expenditure for Certain Types of Fuel and 3 Kg LPG Cylinders; The value of the increase in subsidies for certain types of fuel and 3 kg LPG cylinders that can be charged against the increase in PNPB Migas that is shared.

### **Summary**

This ministerial decree regulates the procedures of application for approval of electric power selling prices and electric power grid rentals and procedures of application for determination of electricity tariffs, including procedures for application

for approval of the selling price of electricity and electricity grid rental, which discusses the approval of the selling price of electricity and rental of the electric power grid and the assignment of purchasing electricity. Furthermore, there are regulations regarding the procedure for applying for the determination of electricity tariffs and other costs related to the distribution of electricity, which disclose the determination of electricity tariff, alteration of electricity tariff, other fee concerning electricity distribution, and re-evaluation of electricity tariff and other fees concerning electricity distribution. This decree also discloses the report arrangement, transition provision, and other provisions. This regulation is in effect starting 27 April 2022.

The Regulation of the Minister of Energy and Mineral Resources Number 15 of 2016 concerning the Provision of 3 Hours Fast Licensing Services Related to Infrastructure in the Energy and Mineral Resources Sector (State Gazette of the Republic of Indonesia Year 2016 Number 978) and Regulation of the Minister of Energy and Mineral Resources Number 13 of 2017 concerning Amendments to the Regulation of the Minister of Energy and Mineral Resources Number 15 of 2016 concerning the Provision of 3 Hours Fast Licensing Services Related to Infrastructure in Energy and Mineral Resources Sector (State Gazette of the Republic of Indonesia Year 2017 Number 241) is revoked and declared invalid. This regulation is in effect starting 13 April 2022.

- Title (English) : Reference Price of Metal Minerals and Reference Price of Coal for June 2022

#### **Summary**

The Decree of the Minister of Energy and Resources number 67.K/HK.02/MEM.B/2022 establishes the reference price of metal minerals and reference price of coal for April 2022. The metal mineral commodities mentioned in this decision are nickel, cobalt, lead, zinc, aluminium, copper, forms of gold, forms of silver, forms of tin, manganese, iron ore, chrome ore, ilmenite concentrate, and titanium concentrate. There are different reference prices for each commodity as seen in the appendix of the decision. The reference price for coal is 323,91 USD/ton.

This regulation is in effect starting 6 June 2022.

#### **Summary**

The Decree of the Minister of Energy and Resources number 135.K/MB.01/MEM.B/2022 establishes the reference price of metal minerals and reference price of coal for May 2022. The metal mineral commodities mentioned in this decision are nickel, cobalt, lead, zinc, aluminium, copper, forms of gold, forms of silver, forms of tin, manganese, iron ore, chrome ore, ilmenite concentrate, and titanium concentrate. There are different reference prices for each commodity as seen in the appendix of the decision. The reference price for coal is 275,64 USD/ton.

This regulation is in effect starting 13 May 2022.

- Title (English) : Guidelines for the Determination and Evaluation of Users and Prices of Certain Natural Gas in the Industrial Sector and in the Provision of Electricity for the Public Interest Sector

#### **Summary**

In this Decree of the Minister of Energy and Mineral Resources, it is stipulated regarding the processing of determining users and prices of certain natural gas, reporting and reconciliation of volumes and prices of certain natural gas, as well as evaluating the implementation of certain natural gas prices in the industrial sector and in the field of providing electricity for the public interest.

The flow of processing recommendations for users of certain natural gas prices begins with verification from the Director General of Oil and Gas; The recommendations in question include submission of a list of prospective Certain Natural Gas Users, submission of return letters if necessary, and evaluation results of Certain Natural Gas Users who have obtained Certain Natural Gas Prices; The Director General of Electricity submits recommendations to the Director General of Oil and Gas; and so on as presented in Appendix I. This decree discloses realization report, reconciliation implementation, report of reconciliation implementation, and distribution of volume and prices of certain natural gas.

This regulation is in effect starting 1 April 2022.

- Title : Harga Jual Bahan Bakar Gas Yang Digunakan Untuk Transportasi  
(Indonesian)
- Title (English) : Selling Price of Gas Fuel Used for Transportation

### **Summary**

This Decree of the Minister of Energy and Mineral Resources determines that the selling price of Gas Fuel for transportation at Gas Filling Stations is IDR 4,500.00 for every 1 Liter Equivalent Premium (LSP) including taxes. Gas fuel in question is in the form of Compressed Natural Gas (CNG) for motorized vehicles for road transportation. The Director General of Oil and Gas monitors and supervises the implementation of the selling price of Gas Fuel.

When this Decree of the Minister of Energy and Mineral Resources takes effect, the Decree of the Minister of Energy and Mineral Resources Number 2932 K/12/MEM/2010 concerning the Selling Price of Gas Fuel Used for Transportation in the Jakarta Area is revoked and declared invalid.

This regulation is in effect starting 1 May 2022.
