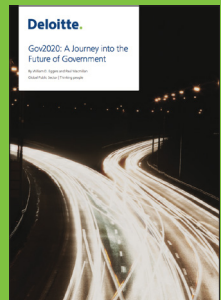

Justice and security organisations must address public concerns over cyber risk, privacy and geopolitical tensions.

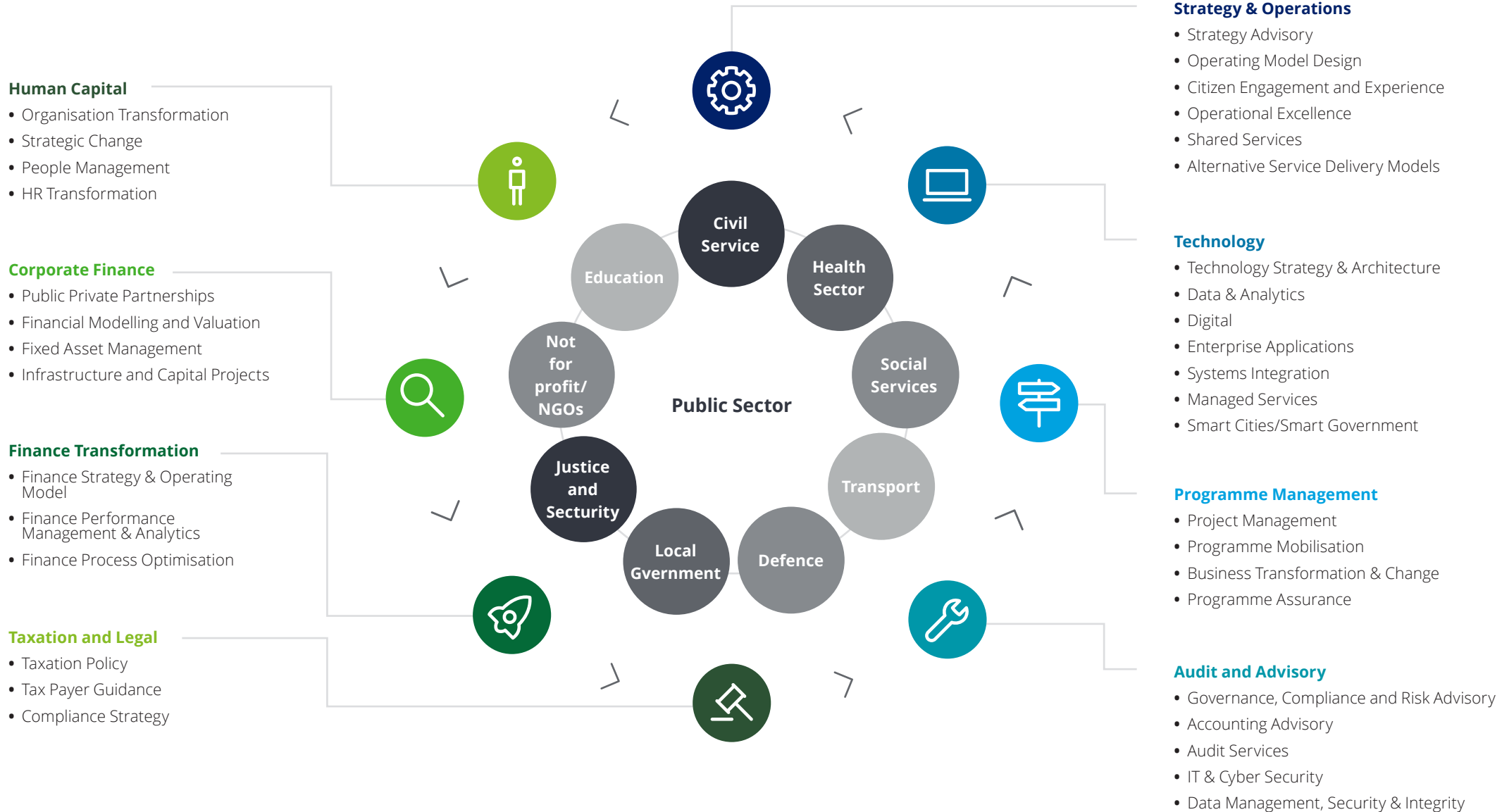
Economic
