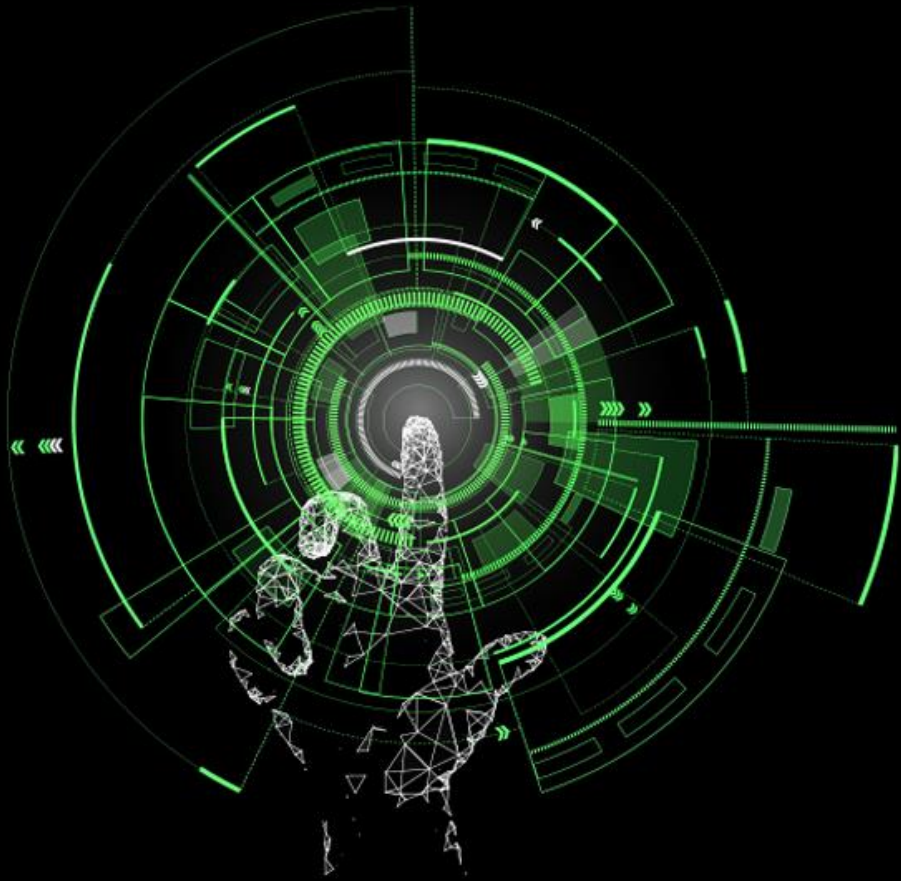

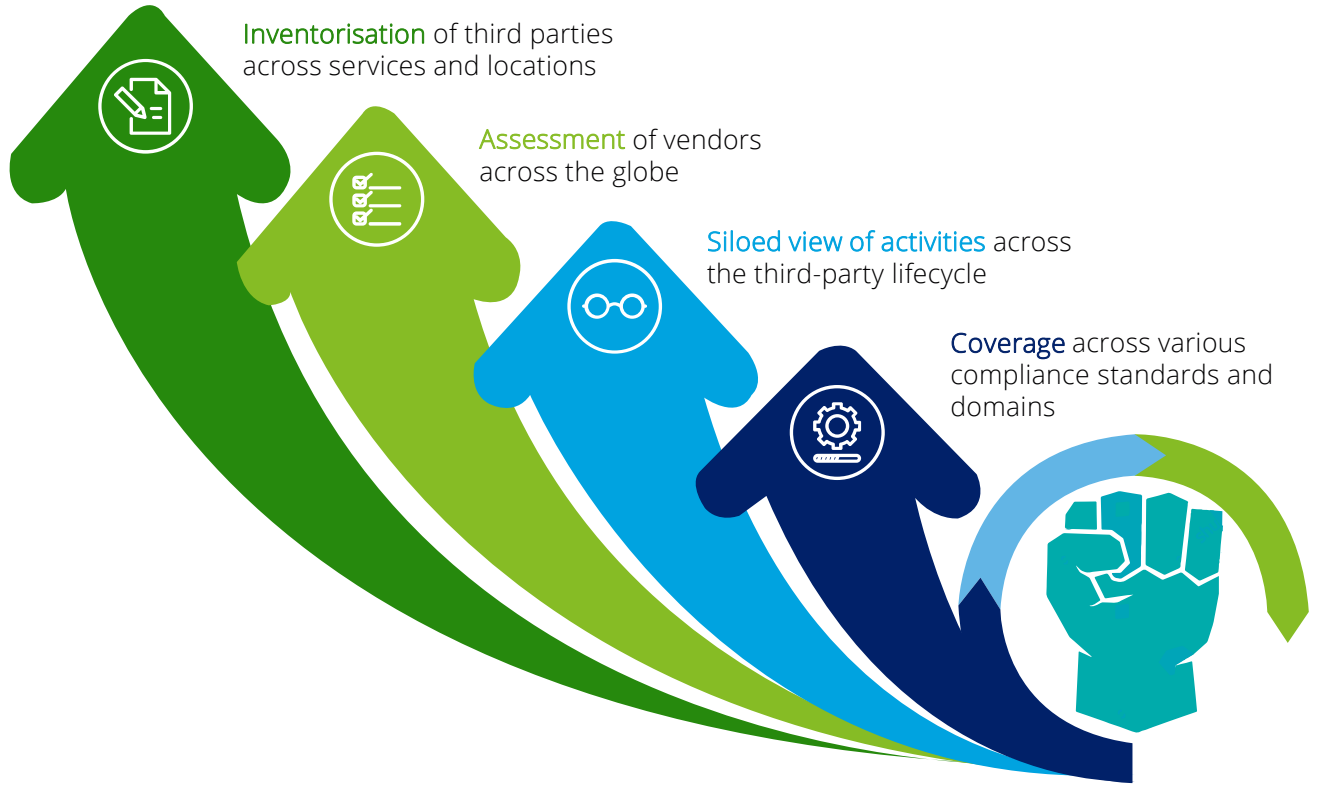



Challenges in third party risk management engagements

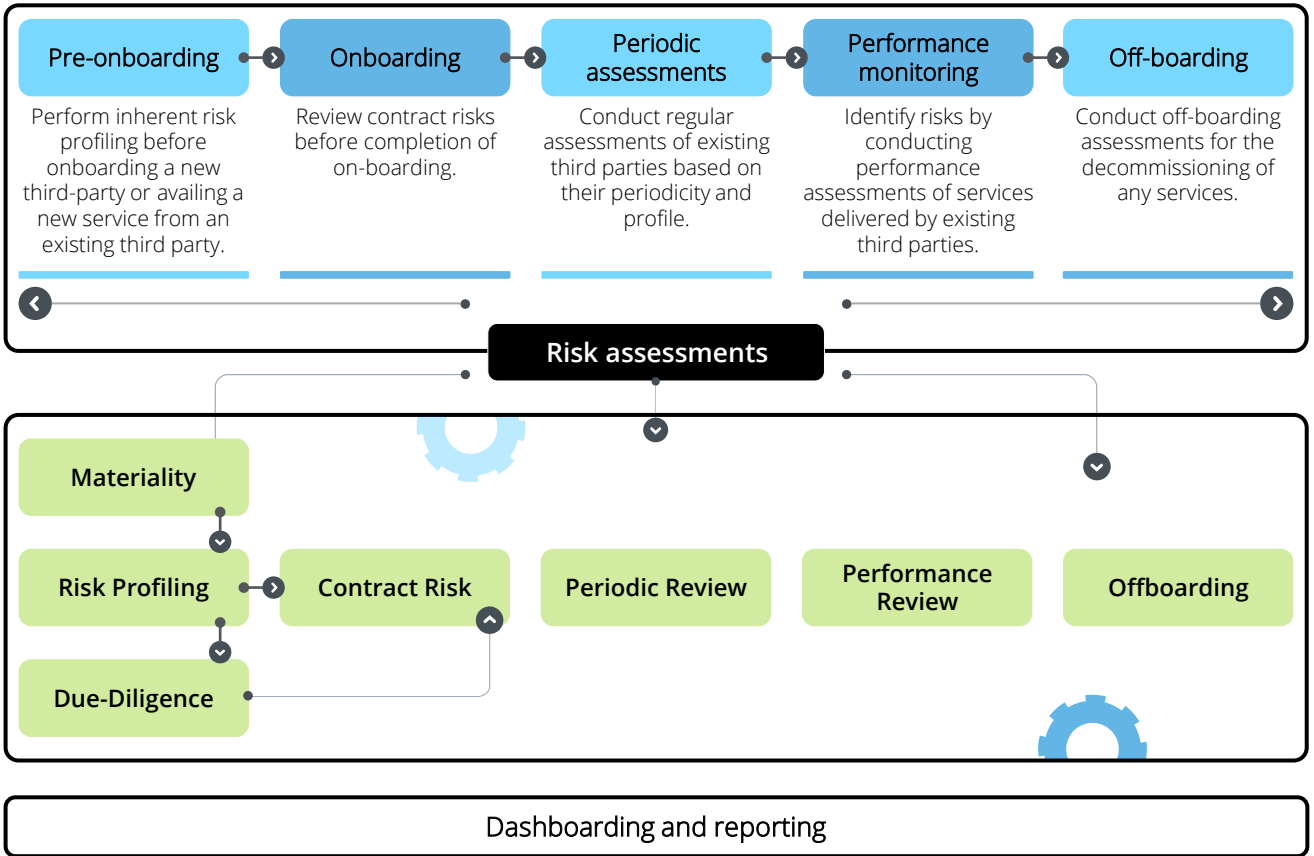
Introducing Trygna
