## Due date for GSTR-1, GSTR-2 and GSTR-3 for July and August 2017, extended.

- GST implementation committee has decided to extend the due dates for filing of GSTR-1, GSTR-2 and GSTR-3 for the months of July 2017 and August 2017.
- Previously prescribed dates for filing vis-à-vis revised dates has been provided as follows:

Month	Type of return	Previously notified due date	Extended due date*
July 2017	GSTR-1	05 September 2017	10 September 2017
July 2017	GSTR-2	10 September 2017	25 September 2017
July 2017	GSTR-3	15 September 2017	30 September 2017
August 2017	GSTR-1	20 September 2017	05 October 2017
August 2017	GSTR-2	25 September 2017	10 October 2017
August 2017	GSTR-3	30 September 2017	15 October 2017
