### **Background**

- The companies are required to apply for various registration under different governing laws and regulations at the time of setting up.
- The Government of India in its attempt to improve ease of doing business, has modified corporate law and Income-tax Rules.
- The Ministry of Corporate Affairs ('MCA') had issued a notification<sup>1</sup> dated 25 January 2017 where the Certificate of Incorporation shall also mention PAN of the company as issued by the Income-tax Department. The said provision is to be effective from 30 January 2017.
- To give effect to the said provision, the Central Board of Direct Taxes ('CBDT') has also amended Income-tax Rules<sup>2</sup> enabling allotment of PAN and TAN via a common application form.
- The classes of persons, prescribed forms and procedure to be undertaken for aforesaid initiative shall be notified soon.

#### **Conclusion**

The government has been committed to improve the conditions of ease of doing business in India. This has been a welcome step in that direction. The said relaxation shall also go a long way by acting as a catalyst for various other registrations for which PAN acts as a supporting document.
