Increase in Madhya Pradesh VAT rate Change w.e.f. 1 April 2015

Effective 1 April 2015, the rate of Value Added Tax leviable under Madhya Pradesh Value Added Tax Act, 2002 has been enhanced, as mentioned below:

Particulars	Rate up to 31 March 2015	Rate effective from 1 April 2015
All goods covered by Part-IV of Schedule II (i.e. all other goods not covered by Schedule I and any other part of Schedule II)	13%	14%

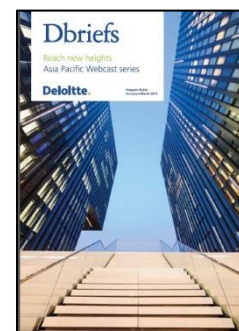
