

We operate as a single point of contact for comprehensive management of all aspects of statutory, tax, and payroll processing compliance, thus:



- Management of customer and supplier master records.
- Issuance of sales orders and purchase orders.
- Issuance of invoices receivable and receipt of invoices payable.

- Maintenance, printing, and keeping of accounting and tax records.
- End-to-end management of the process related to Legislative Decree No. 124/2019 requirements.

- Calculation of direct tax (Ires Corporate Income Tax and Irap Regional Tax on Production Activities), preparation and submission of the relevant payment form.
- Preparation and submission of declaration forms (Modello Unico form for tax returns, VAT return form, 770 form, and Irap form).
- Submission of CU forms.
- Managing chamber of commerce paperwork (filing of financial statements, change of registered office, assignment of powers, registration of leases).
- Support in corporate secretarial duties (management of convening of meetings, proxies, drafting of meeting and board of directors' minutes, assistance in preparing company books).
- Management of requirements related to payroll processing (preparation of contracts, management of communications to relevant authorities, payslip processing, calculation of social security contributions and deferred charges, preparation and submission of payment forms related to social security contributions and withholding tax, ISTAT adjustment calculation, etc.).
