- **Contributing to inform and update** the Deloitte Network in the field of public policies.

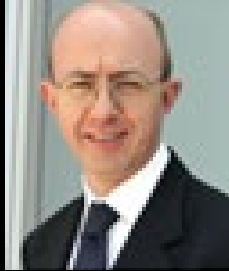
## Policy Topics
