FATCA Update – January 2017

Updated FATCA Circular ECHA n° 3 released

According to a [newsletter](#) issued on 19 January 2017, the Luxembourg Tax Authorities released an updated version of the Circular [ECHA n° 3](#) taking into account the new FATCA XSD 2.0 schema published by the IRS on 31 August 2016. The new circular replaces the previous circular ECHA n°3 dated 18 February 2016.

A marked-up [version](#) has also been published to highlight the latest changes.

The Luxembourg Tax Authorities have announced that the update of the reporting tool will be completed by 1 February 2017. As of this date, only version 2.0 files will be accepted.
