



System error in the issuance of CURPs to temporary residents in Mexico

Impact – Medium

What has changed?

The RENAPO system has incorrectly assigned a percentage of CURPs under the category of “Documento SEGOB” and additionally are issued temporarily. The CURPs issued for temporary residents must have the legend “Documento Migratorio” in order to be a definitive CURP and not a temporary one.

What does this change represent?

Residents who have a CURP with the legend “Documento SEGOB” must request the

reactivation of the CURP before the National Immigration office (INM) so that it is assigned under the correct category: Documento Migratorio.

How can I review it?

You must follow the following steps:

1. Enter the [RENAPO](https://www.gob.mx/curp/) webpage: <https://www.gob.mx/curp/>
2. Enter your CURP where it says “ingresa tu CURP”
3. Upon entering, a pop-flash may appear informing you that the CURP is no longer valid, here is an example:

4. If this is the case, you must choose the option “cerrar” and you must download the PDF with the CURP in order to validate the document; at the bottom of the QR code you can find the following legends as follows:
