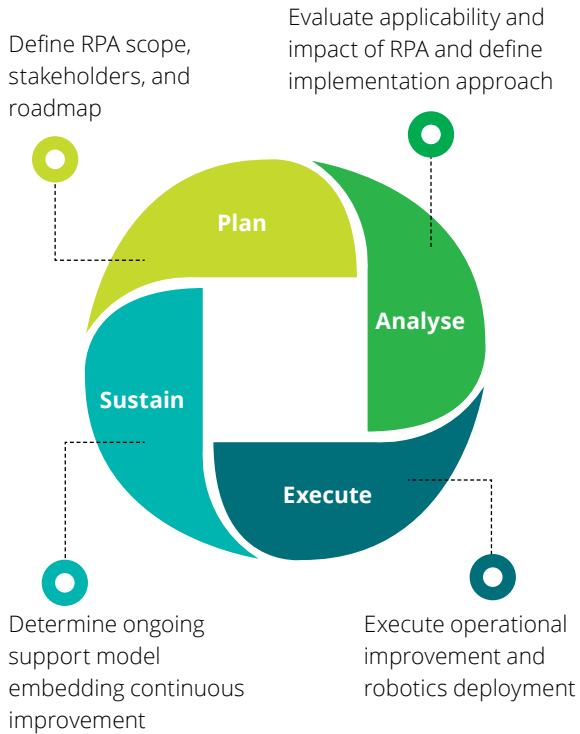

Key benefits of using RPA

Refocus of Capacity

- Automation of routine tasks enables employees to focus on higher order activities
- Creates capacity for resources to develop new competencies and build expertise

Decision-Making

- Process automation enables improved quality and consistency of data
- Enhances an organisation's analytics and decision-making capabilities

Client/Employee Experience

- Enhances the work of employees by reducing repetitive and manual tasks
- Increases employee morale and creates a more productive workforce

Quality

- Robots perform tasks with a high degree of accuracy and improved process quality
- Processing errors are reduced by 20-40%

Security

- Platforms are secure, audited and managed within an IT corridor of governance
- Centralised management and predictable processing enables tighter data controls

Efficiency

- Automation can result in a 40-80% reduction in processing times
- Increase in time availability allows employees to put hours back into the business
