The Ministry of Finance (MoF) published the Budget 2022 Pre-Budget Statement (PBS) on 31 August 2021. This provided a preliminary overview of the direction, approach and expected benefits of Budget 2022.

The MoF has invited the public to give their suggestions on the necessary measures needed to accelerate the recovery of sectors badly affected by the COVID-19 pandemic. Suggestions provided may be included in the upcoming Budget 2022, scheduled to be tabled in parliament on 29 October 2021.

Required

You are required to record a video of not more than 5 minutes to the Government on the measures Malaysia could take to accelerate the recovery of sectors badly affected by the COVID-19 pandemic, including tourism, retail, and the small and medium enterprise (SME). Your suggestions may include both tax and non-tax measure(s).

Note : Subtitles are not required for the video submission. However, kindly ensure the video audio is loud and clear so that judges are able to hear your justification clearly.
