Malaysia – Official launch of Expatriate Satellite Centre (ESC) at Kuala Lumpur International Airport (KLIA), Terminal 2

What is the change?

MYXpats Centre has officially announced the launch of ESC at Terminal 2 of KLIA. The option to obtain selected pass endorsements were initially made available on the Expatriate Services Division (ESD) online portal since June 2024, but without any official announcement and took place directly at the KLIA 2 International Arrivals immigration checkpoint.

ESC is now fully operational on a 24/7 basis. Expatriates may now follow lanes A3 to A5 (typically reserved for APEC/Diplomats/Crew) at the KLIA 2 International Arrivals area to access ESC for completion of the pass endorsement process.
