### Introduction

The introduction of GST has given Royal Malaysian Customs Department (RMCD) greater focus and more resources to regulate indirect taxes in Malaysia. While businesses have spent a significant amount of time to get ready for GST, it is important to not lose sight of RMCD's primary focus being the regulation of the movement of goods into and outside of Malaysia and the collection of customs duties.

Whilst RMCD have allowed a self-assessment regime for the disclosing and payment of duties and taxes, it is always on the basis that such disclosures may be reviewed and audited at a later date. As there is an increased focus on regulation and enforcement due to GST, we have seen increased customs audit activity, and the general experience has been businesses have under-emphasized this indirect tax risk (including historical sales and service tax liabilities). Failure to comply with customs requirements can result in significant penalties, loss of reputation and greater scrutiny in future.

It is important for businesses to not lose sight of this important area.
