Release of the Draft Sales Tax and Service Tax Regulations, Orders and Guides

With the passing of the Sales Tax Bill, Service Tax Bill, Goods and Services Tax (Repeal) Bill, Customs (Amendment) Bill and Free Zones (Amendment) Bill in the Dewan Negara (Senate) on Monday, 20th August 2018, the Royal Malaysian Customs Department ("RMCD") has released the draft Regulations, Orders and Guides for Sales Tax and Service Tax ("SST").
