



## **Indirect Tax Alert** Sales Tax and Service Tax (SST) Framework—Deloitte Analysis and Views

Whilst the proposed framework retains much of the previous version of the SST, there are some critical changes to the scope and the way the tax is administered. It is important to note that the SST Framework is still in a proposal stage and that the final details will only be known once the Bills are released before Parliament.
