



## Immigration GES Alert

Malaysia – Introduction of Electronic Pass (ePASS) for Renewal Application(s) of Foreign Knowledge Worker (FKW)

### What is the change?

In line with the [announcement](#) made by the Expatriate Service Division (ESD) of the Immigration Department, Malaysia Digital Economy Corporation (MDEC) has announced that effective 17 March 2023, ePASS will be issued for RENEWAL APPLICATION of Foreign Knowledge Worker (FKW) including their dependent(s).

Below is a summary of the ePASS features:

Type of pass applicable	Employment Pass (Category EP I, II and III) Dependent Pass to EP I and II categories Long-Term Social Visit Pass (LTSVP) to EP I and II categories
Eligibility	All renewal cases under Employment Pass (EP) and its related passes with a previous active pass that was endorsed in the same passport
Commentary	Company may download and print the ePASS from the system. The Foreign Knowledge Worker (FKW) including their dependent(s) MUST ensure that the ePASS is attached with the passport as identification at all times. The ePASS will be issued for the Foreign Knowledge Worker (FKW) including their dependent(s) that are currently in Malaysia and the latest pass is endorsed in the same passport.

### Deloitte's view

Expatriates with Long-Term Passes may use the Autogate facility whenever they enter and exit the country.

Requirement	The pass holder is required to register their passport and fingerprint at the foreigner e-gate registration kiosk.
