



## Immigration GES Alert

### Malaysia – Updated Fees for Expatriate Processes by Expatriate Services Division (ESD)

#### What is the change?

Starting 1 September 2024, the online application fees on the ESD online portal are revised following recent enhancements, including the onboarding of previously manual applications (e.g.: cancellation, transfer of endorsement, etc.) to the online portal.

The new application rates are as follows:

Application Type	Revised Fee (MYR) <sup>1</sup>
Employment Pass (EP) – New and Renewal	2,160
Dependent’s Pass (DP)/Long Term Social Visit Pass (LTSVP) <sup>2</sup>	540
Professional Visit Pass (PVP)	1,296
Transfer of Endorsement (TOE)	162

<sup>1</sup> Includes 8% Sales and Services Tax (SST)

<sup>2</sup> For dependents of EP applicant that do not qualify for EP

The amount stated above is solely for online application charges, which excludes any other immigration fees.
