On 24 August 2020, David Webb and Colin Owens were appointed Joint and Several Administrators of STA Travel (NZ) Limited by resolution of the directors of the Company pursuant to section 239I of the Companies Act 1993.

To be appointed, the Administrators sought permission of the Court and made an application under section 280 of the Companies Act 1993, which was granted by the Court.

## Conduct of the Administration

STA was an established travel agency that was operating from a number of sites in New Zealand.

Following the collapse of its overseas parent company, all remaining stores were closed on the evening of 20 August 2020. The Directors then placed the Company into Voluntary Administration on 24 August 2020 and appointed Colin Owens and David Webb Joint and Several Administrators.

The Administrators undertook an assessment of the financial position of the Company. The ultimate parent company and other companies within the STA Travel Group were or about to be in some sort of formal administration. Given the current financial position of the Company in New Zealand and without the support of the STA Travel Group, the Company could not continue to trade in New Zealand.

At the watershed meeting of creditors held on 28 September 2020, the creditors voted to place the Company into liquidation with Colin Owens and David Webb being appointed as Liquidators.

## Creditors

### Secured Creditors

There are no secured creditors of the Company.

### Preferential Creditors

Preferential claims are estimated to total \$439,000, which is made of \$413,000 owing to employees and \$26,000 owing to the Inland Revenue in respect of PAYE and GST.

### Unsecured Creditors

The books and records of the Company estimate that unsecured creditors are owed \$11,146,000.

## Administrators' Remuneration

No remuneration was paid to the Administrators during the Administration. The Administrators' remuneration will be paid from funds held/recovered by the Liquidators during the course of the Liquidation.

## Receipts and Payments

A statement of receipts and payments is attached as **Appendix A**. Administrators' remuneration and other costs of the administration are still to be paid, which will be paid by the Liquidators, funds permitting.
