### **Modes of obtaining the Offline eBIRForms Package** *(Revenue Memorandum Circular No. 16-2015)*

Due to the volume of taxpayers accessing the BIR website to download, enroll and submit online their tax returns, the BIR has identified the following links/sites/application to obtain the eBIRForms Package:

Taxpayers using the Offline eBIRForms Version 4.7.07 may submit the 2014 income tax return (ITR) via email, and subsequently enroll after eFiling. Thus, the email submission of the 2014 ITR is allowed whether enrolled or not to eBIRForms System.
